Q1	Please provide a list of all interested parties considering bidding on this solicitation, including contact information, if available?
A1	See Attachment 1
Q2	Who are the incumbents on this contract? Please provide copies of current contracts and associated pricing?

A2	The current incumbent (Contractor) for this scope is Engineering/Remediation Resources Group, Inc. (EERG), DRR19050. See Attachment 2, Cost Breakdown (Rate Sheet).
Q3	Please confirm the statement that we may need to support other contractors relates interchangeably to the prime contractor awardees for So Cal and No Cal regions for this contract only?
A3	The intent of this contract is to allow for the prime contractor of the Northern California region to support the prime contractor in the Southern California region if needed, for the environmental services outlined on pages 15, 16, 57, and 58 of the RFQ. There may still be a possibility that either or both prime contractors may be required to assist with debris removal operations in response to a wildfire.
Q4	Please provide full details of the liquidated damages clause that applies to this contract?
A4	Liquidated damages would only apply to individual work orders in the instance where there was an impacted party from the prosecution of the work. To date CalRecycle has never used this clause on this contract.
Q5	We understand we cannot be awarded both regions as the prime contractor. However, please confirm we can provide services in both regions if we are a subcontractor to both of the awarded prime contractors (one in each region)?
A5	Yes, a subcontractor for the Northern California region environmental services contract can also be a subcontractor for the Southern California region environmental services contract.
Q6	Please advise if there any restrictions on subcontractor markup percentages?
A6	The markup percentage for subcontractors is discussed on page 27 of the RFQ and cannot exceed ten (10) percent.
Q7	Can we pass along a reasonable annual fuel surcharge and cost of living pricing adjustment?
A7	The rates paid for contractor-owned equipment shall be fixed over the term of the contract and shall include the cost of fuel, oil, lubrication, supplies, small tools, necessary attachments, repairs and maintenance of any kind, depreciation, storage, insurance, and all incidentals. An annual fuel surcharge and cost of living adjustment will not be allowed. The fuel purchased by the contractor for rental equipment can be considered as "Materials" and will be reimbursed at cost plus a markup negotiated between the contractor and the Contract Manager.
Q8	Why are the regions defined the way they are? In other words, why are some counties included but not others? Is there a map you could provide to better help us understand the locations where services are required?
A8	For this contract, the Northern and Southern regions of California were defined in accordance with the territorial span covered by the union of

Operating Engineers Local's 3 and 12. Local 3 being Northern California and Local 12 being Southern California. A map showing the counties designated in Northern and Southern California is provided in attachment 3.
What is the expected annual spend on the new contract for each region? What was the spend in 2022 and 2021 for each region?
The annual spend per contract will vary. The annual spend for the Northern California contract was approximately \$107,000 and \$912,000 for 2021 and 2022 respectively. The annual spend for the Southern California contract was approximately \$851,000 and \$700,000 for 2021 and 2022 respectively.
Does the scope of work include homeless encampment cleanups? If yes, what are your expectations for the handling of "personal property" and providing a police presence?
Work performed under the environmental services contracts in the past has included the removal of solid waste debris generated by encampments created by the unhoused. Cleanup of the encampment would not commence until the transient population has been relocated or provided sufficient advance notice to vacate and remove personal property. CalRecycle will work with the local municipalities and counties to ensure that cleanup sites are safe for contractor personnel and police presence can be provided if deemed necessary.
Because questions will not be answered until later this week, would you please consider extending the submission due date by 7-14 days?
The final filing date has been extended to February 10, 2023, at 2:00 pm as noted in Item 1.
Was the proposers conference mandatory to submit a RFQ package?
The Proposer's Conference was optional and not required to submit an RFQ package.
Who currently provides these services? Please provide a copy of the current contracts, including pricing.

I couldn't find the Liquidated Damages information when I clicked on the various links. Please provide details on the LD clause that applies to these contracts.

Q16	Contractor requests confirmation that a company can only be awarded one region (Northern or Southern)?
A16	A contractor can be awarded a contract for either the northern or southern regions of California, but not both regions.
Q17	Can CalRecycle provide a forecast for contract \$ values to be awarded to Northern California vs. Southern California over the next three years?
A17	Over the next three years, the contract budget are tentatively \$3,277,500 for both regions. The contract budget for the Southern California region <u>may</u> be increased to account for an ongoing project that is expected to be completed in 2023 at an approximate cost of \$1.4 to \$1.7 million.
Q18	Is the contract amount of \$3,277,500 for each region, north and south, or is it the total for both regions?
A18	The current contract amount of \$3,277,500 is for each of the northern and southern regions.
Q19	Do the SB/DVBE participation goals apply for each individual project or taken together for all projects performed throughout the 36-month period?
A19	The SB/DVBE participation goals apply to overall 36-month contract period.
Q20	Is there a minimum self-perform amount for the prime contractor when using SB/DVBE subcontractors on any project?
A20	There is currently no self-performance requirement.
Q21	Can you provide a physical address for the hard copy submission instead of a P.O. Box?
A21	CalRecycle Contact Information including Physical Address can be found under Section I Overview.
Q22	Do we need to include three references for each subcontractor in addition to three references for the prime contractor?
A22	A minimum of three references for subcontractors are preferred but not required.
Q23	The RFQ states that "compensation for office support employees shall be actual wages, plus any employer payments to or on behalf of the employees for health and welfare, pension, vacation, and similar purposes, and include overhead and profit." Therefore, can you clarify Mr. Kovacs remarks during the proposers' conference that there is no allowed markup for rates of personnel not working in the field. Does this contradict the RFQ text?
A23	Personnel not working in the field are considered exempt office staff and will be billed at an hourly rate that is negotiated between the Contract Manager and the Contractor prior to execution of the contract. The Contractor can determine an hourly wage for each of the office staff that is inclusive of actual wages, employer payments to or on behalf of the employees for health and welfare, pension, vacation, overhead and profit.

Q24	Will you submit work plans and other project documents to other public agencies; therefore, requiring the signature and stamp of a duly licensed professional?
A24	The work plans or other project documents submitted by a Contractor will not be submitted to other public agencies.
Q25	Are blanket additional insured endorsements acceptable?
A25	Blanket additional insured endorsements are not acceptable.
Q26	Is there a maximum number of project descriptions we can include with our submission?
A26	There is not a set maximum number of project descriptions that can be included with the response to the RFQ.

All other terms, conditions, and requirements of this Request for Qualifications will remain the same.
