		We are a small business and do not have reviewed or audited financial						
		statements. We do have internally prepared financial statements, can we submit those?						
Α	1	No. CalRecycle requires reviewed or audited financial statements dated within the last 12 months.						
Q	2	Are the required forms listed in Attachment 17: Final Proposal Checklist (Section 1-8; Attachments 2-9) also required by subconsultants?						
A	2	The firm submitting their Statement of Qualifications must submit the forms listed in Attachment 17 Final Proposal Checklist. Refer to Section 3.16 Statement of Qualifications, Partners/Subcontractors: The variety of work may require resources beyond the capabilities of some firms. If other firms are proposed as partners or subcontractors, the experience of those firms, in addition to the experience of the prime firm, shall be indicated on the appropriate forms in the SOQ. All experience documented on the forms shall be clearly marked to show which firm was responsible for the specific work.						
Q	3	Do subconsultants need to submit sample work?						
Α	3	No. The RFQ does not require submission of sample work.						
Q	4	Is the Indemnification language in the Sample Standard Agreement negotiable?						
Α	4	No. The indemnification language in Exhibit C, General Terms and Conditions is not negotiable.						

All other terms, conditions, and requirements of this RFQ will remain the same.
