To the Request for Qualifications (RFQ)**

CalRecycle is issuing Addendum No. 1 to provide the following information.

1. No revisions have been made to the RFQ within the electronic bid system.

2. The following questions were received during the Questions and Answers period.

Q 1	May the project experience be provided in an alternate format so long as all of the required information is provided?
A 1	No. The Proposers must follow the format of the documents in the RFQ. Supporting documentation may be included with each submittal upload.
Q 2	If proposing on both Northern California and Southern California, may the same personnel be proposed for Northern California contract as Southern California contract?
A 2	Yes. The same personnel can be proposed for DRR25033 Landfill, Disposal Site, and Waste Tire Site Remediation Northern California and for DRR25034 Landfill, Disposal Site, and Waste Tire Site Remediation Southern California. However, the same Contractor cannot be awarded for both contracts.
Q 3	If a contractor proposes a subcontractor who is going to perform <10% of the work, are we required to provide qualifications for that subcontractor?
A 3	Yes, qualifications need to be provided for Subcontractors, referenced in 2.16 Subcontractors. Additionally, as stated 3.15 Statement of Qualifications,

		Partners/Subcontractors: The variety of work may require resources beyond the capabilities of some firms. If other firms are proposed as partners or subcontractors, the experience of those firms, in addition to the experience of the prime firm, shall be indicated on the appropriate forms in the SOQ. All experience documented on the forms shall be clearly marked to show which firm was responsible for the specific work.
Q 4		Will CalRecycle accept a letter from the bank with the required information without notarization?
A 4		<p>No. As stated in Attachment 1, the Statement of Qualifications Questionnaire, under 3. Financial Information, firms are required to submit a notarized written statement from their financial institution(s) on letterhead stating the following information:</p> <ul style="list-style-type: none"> A. Name of Company; B. Date account(s) were opened; C. Line of credit? Yes or No D. Does the company keep a well-balanced financial position at the bank? Yes or No

All other terms, conditions, and requirements of this RFQ will remain the same.
