Section I Overview

General Information

CalRecycle promotes a zero waste California in partnership with local government, industry, and the public. This means managing the estimated 76 million tons of waste generated each year by reducing waste whenever possible, promoting the management of all materials to their highest and best use, and protecting public health and safety and the environment.

Any documents delivered in person must be received in the Visitor and Environmental Services Center located in the lobby of the CalEPA Headquarters Building at 1001 I Street, Sacramento, CA 95814.

Service Needed

While CalRecycle encourages digital use of the Education and the Environment Initiative (EEI) Curriculum, surveyed teachers throughout California have consistently conveyed the need for the EEI Curriculum in print form. Even though today's classrooms are becoming more technologically equipped, there is still a need for students to use printed materials for effective learning, especially in the early grades. The purpose of this Agreement is to print, store, package, and prepare for shipping EEI materials to educators. Fulfillment and shipments may include as few as one Teacher Kit of a curriculum unit. The Contractor shall provide all services associated with being a printing and fulfillment house for the EEI Curriculum. The Contractor shall NOT be responsible for shipping costs.

Contract Budget

This Agreement is valid and enforceable only if sufficient funds are made available by the Budget Act of the appropriate fiscal year for the purposes of this program. In addition, this Agreement is subject to any additional restrictions, limitations, or conditions enacted by the Legislature, which may affect the provisions, terms, or funding of this Agreement in any manner.

Subject to availability of funds and approval by CalRecycle, there is a current maximum budget of \$847,839.84 for this Agreement. Furthermore, CalRecycle is currently seeking additional funding for these materials and reserves the right to amend the budget for this Contract to add up to an additional \$1,629,000 (for a total budget of \$2,476,839.84) if funding becomes available during the Agreement term.

Contract Term

The term of this Agreement is expected to begin in June 2018 and shall span approximately 16 months. This Agreement may be extended at the sole option of CalRecycle up to an additional 24 months, subject to future fiscal year budget allocations and the granting of a waiver from the Office of State Publishing.

Invitation for Bid (IFB).

Section II Rules and Conditions

Introduction

There are conditions that this IFB, submitting Bidders, bids and resulting Agreements are subject to and/or required to comply with.

Commitment

Upon submittal of a Bid, the Contractor has committed to comply with the following requirements:

- All items noted in IFB documents.
- Special Terms and Conditions are included in the sample Agreement attached.
- General Terms and Conditions (GTCs) and or Certification Clauses (CCCs) are both available for viewing at http://www.dgs.ca.gov/ols/Resources/StandardContractLanguage.aspx

The above terms, conditions, and/or requirements are not subject to negotiation. Any Bidder that reserves a right to negotiate or expresses any exception to the above terms, conditions, and/or requirements shall be disqualified. However, requests to revise any of the above terms, conditions, and/or requirements may be submitted during the formal question and answer period. Any such requests must include the current language, the proposed revised language, and the justification for the proposed revision. Any revisions are at the sole discretion of CalRecycle and shall only be made under very limited circumstances in which the revisions apply to all Bidders and benefit or enhance the Agreement.

If the Bidder fails to meet any of the requirements or comply with CalRecycle requests, CalRecycle can reject, disqualify, or remove the firm from the process. CalRecycle is not committed to award an Agreement resulting from this IFB.

Antitrust Claims

In submitting a Bid Package to a public purchasing body, the Bidder offers and agrees that if the Bid Package is accepted, it shall assign to the purchasing body all rights, title, and interest in and to all causes of action it may have under Section 4 of the Clayton Act (15 U.S.C. Sec. 15) or under the Cartwright Act (Chapter 2 [commencing with Section 16700] of Part 2 of Division 7 of the Business and Professions Code), arising from purchases of goods, materials, or services by the Bidder for sale to the purchasing body pursuant to the Bid Package. Such assignment shall be made and become effective at the time the purchasing body tenders final payment to the Bidder. (See Government Code Section 4552.)

If an awarding body or public purchasing body receives, either through judgment or settlement, a monetary recovery for a cause of action assigned under this chapter, the assignor shall be entitled to receive reimbursement for actual legal costs incurred and may, upon demand, recover from the public body any portion of the recovery, including treble damages, attributable to overcharges that were paid by the assignor but were not

paid by the public body as part of the Bid Package price, less the expenses incurred in obtaining that portion of the recovery. (See Government Code Section 4553.)

Upon demand in writing by the assignor, the assignee shall, within one year from such demand, reassign the cause of action assigned under this part if the assignor has been or may have been injured by the violation of law for which the cause of action arose and (a) the assignee has not been injured thereby, or (b) the assignee declines to file a court action for the cause of action. (See Government Code Section 4554.)

Contractor's Cost

All costs resulting from the Contractor's participation in the IFB process are at the firm's expense. No costs incurred by the Contractor participating in the IFB process shall be reimbursed by CalRecycle.

Information

All information obtained or produced during the course of the Agreement shall be made available to CalRecycle.

Any information that qualifies as confidential or a trade secret(s) under the Public Records Act (PRA) or the Public Contract Code (PCC) and is thus exempt from disclosure under those statutes must so be marked by the Bidder prior to submission to CalRecycle. Any claims of confidentiality or trade secret(s) except as to information that qualifies as such under the PRA or PCC may result in disqualification.

CalRecycle shall hold information deemed confidential or trade secret(s) by the Bidder to the extent allowable by the California Public Records Act and the Public Contract Code.

Written Questions

Bidders needing clarification of the requirements of this solicitation may submit questions to CalRecycle's Contracts Unit. All inquiries must be received no later than 5:00 pm on April 10, 2018 regardless of postmark. If the inquiries are faxed, then the time and dated on the fax must not be later than the due date and time.

Questions, suggestions or objections regarding the content of this solicitation, including but not limited to the purpose, scope of work, etc., not submitted by the deadline for questions shall be deemed waived and may not be raised at a later time.

Oral communications with CalRecycle officers and employees shall be non-binding on the State and shall in no way exclude the Bidder of any obligations as set forth in this package.

All questions or inquiries regarding this solicitation shall be submitted using the contact information provided in Section I.

E-mails and/or faxes shall be clearly marked "Questions Relating to SOLICITATION DRR17111".

The questions and answers shall be published in an Addendum to the IFB (see below, Addenda).

Addenda

CalRecycle reserves the right to amend, alter, or change the rules and conditions of this IFB.

Any ambiguity, conflict, discrepancy, omission, or other error discovered in the IFB shall immediately be reported to CalRecycle prior to the deadline for submission of written questions. CalRecycle shall issue addenda to address such issues. Addenda shall be available on the CalRecycle webpage for this particular solicitation at www.calrecycle.ca.gov/contracts.

Modification of Submittals

A Bid submitted prior to the submittal deadline, can be withdrawn or modified by the submitting Bidder. The Bidder must:

- Provide a written request.
- Identify the requesting individual and their association to the Bidder.

A Bid cannot be withdrawn for modification after the submittal deadline has passed.

Errors in Submittals

An error in a Bid package may be cause for rejection of that Bid.

CalRecycle may make certain corrections, if the Bidder's intent is clearly established based on review of the complete Bid.

Unreliable List

Any Contractor or Subcontractor currently on the CalRecycle Unreliable list is ineligible to apply for or participate in this Agreement.

Electronic Waste Recycling

If the Contractor or any Subcontractors participate in activities that result in the disposition of electronic components, they shall comply with the provisions of PRC Chapter 8.5.

Use Tax

If, during the course of the Agreement, the Contractor shall be involved in the re-sale of goods to the State, they must comply with the requirements of Section 6452.1, 6487, 6487.3, 7101, and 18510 of the Revenue and Taxation Code, in addition to Section 10295.1 of the Public Contract Code.

Small Business (SB) Preference

The following information shall apply to both SBs and MBs.

Any Bidder competing in this process as a California Certified Small Business (SB) or Micro Business (MB), or as a non-SB certifying to subcontract a minimum of 25% of the

total Agreement services to a California Certified SB or MB, shall receive a five percent (5%) preference. Certification must be provided by the Department of General Services (DGS), Procurement Division (PD), Office of Small Business and DVBE Services (OSDS). CalRecycle shall apply the preference per State law and as described on the DGS website at http://www.dgs.ca.gov/pd/Programs/OSDS.aspx

A five percent (5%) bid preference is available to a non-small business claiming twenty-five percent (25%) California certified small business subcontractor participation. If claiming the non-small business subcontractor preference, the bid response must include a list of the small business(es) with which you commit to subcontract in an amount of at least twenty-five percent (25%) of the net bid price with one of more California certified small businesses. Each listed certified small business must perform a "commercially useful function" in the performance of the Agreement as defined in Government Code Section 14837(d)(4).

The required list of California certified small business subcontracts must be attached to the bid response and must include the following: 1) subcontractor name, 2) address, 3) phone number, 4) a description of the work to be performed and/or products supplied, 5) and the dollar amount or percentage of the net bid price (as specified in the solicitation) per subcontractor. Use the Bidder Declaration form (Attachment G) to report this information.

Bidders claiming the five percent (5%) preference must commit to subcontract at least twenty-five percent (25%) of the net bid price with one or more California certified small businesses. Completed certification applications and required support documents must submitted to the office of Small Business and DVBE Certification (OSDC) no later than 5:00 p.m. on the bid due date, and the OSDC must be able to approve the application as- submitted. Questions regarding certification shall be directed to the OSDC at (916) 375-4940. In no event shall the SB preference or non-SB subcontracting preference exceed \$50,000 in any single bid.

The incentive is applied during the evaluation process and is only applied for responsive bids from responsible bidders proposing the percentage of SB participation for the incentive specified above. The SB preference shall be applied when a responsible bidder that is not a CA certified SB or a non-SB claiming 25% CA certified SB subcontractor participation submits the lowest responsive bid.

For award based on low price, the incentive is applied by reducing the bid price by the amount of incentive as computed from the lowest responsive and responsible bid price. The computation is for evaluation purposes only. Application of the incentive shall not displace an award to a small business with a non-small business.

A copy of the Bidder's SB certification shall be included with the Bid Package.

If the Bidder makes a commitment to achieve small business participation, then the Bidder, if awarded this Agreement, must within 60 days of receiving final payment (or

within such other time period as may be specified elsewhere in this Agreement) report to the awarding department the actual percentage of small business participation that was achieved (Govt. Code § 14841). Refer to Attachment H to fulfill this requirement.

Disabled Veterans Business Enterprise (DVBE) Incentive

Any Bidder competing in this process as a California Certified Disabled Veterans Business Enterprise, or as a non-DVBE certifying to subcontract a minimum of 3% of the total Agreement services to a California Certified DVBE, shall receive an incentive as shown below:

- 1. Five (5%) and above participation level = bid shall receive five percent (5%) incentive.
- 2. Four (4%) participation level = bid shall receive two percent (2%) incentive.
- 3. Three (3%) participation level = bid shall receive one percent (1%) incentive.

Certification must be provided by the Department of General Services (DGS), Procurement Division (PD), Office of Small Business and DVBE Services (OSDS).

A three to five percent (3-5%) bid incentive is available to a non-DVBE claiming a minimum of three percent (3%) California certified DVBE subcontractor participation. If claiming the non-DVBE subcontractor incentive, the bid response must include a list of the DVBE(s) with which you commit to subcontract in an amount of at least three percent (3%) of the net bid price with one of more California certified DVBEs. Each listed certified DVBE must perform a "commercially useful function" in the performance of the Agreement as defined in Government Code Section 14837(d)(4).

The required list of California certified DVBE subcontracts must be attached to the bid response and must include the following: 1) subcontractor name, 2) address, 3) phone number, 4) a description of the work to be performed and/or products supplied, 5) and the dollar amount or percentage of the net bid price (as specified in the solicitation) per subcontractor. Use the Bidder Declaration form (Attachment G) to report this information.

Bidders claiming an incentive must commit to subcontract at least three percent (3%) of the net bid price with one or more California certified DVBEs. Completed certification applications and required support documents must submitted to the office of Small Business and DVBE Certification (OSDC) no later than 5:00 p.m. on the bid due date, and the OSDC must be able to approve the application as- submitted. Questions regarding certification shall be directed to the OSDC at (916) 375-4940.

The incentive is applied during the evaluation process and is only applied for responsive bids from responsible bidders proposing the percentage(s) of DVBE participation for the incentive(s) specified above.

For award based on low price, the incentive is applied by reducing the bid price by the amount of incentive as computed from the lowest responsive and responsible bid price.

The computation is for evaluation purposes only. Application of the incentive shall not displace an award to a small business with a non-small business.

A copy of the Bidder's DVBE certification shall be included with the Bid Package. For information on locating DVBE resources please go to the following website http://www.dgs.ca.gov/pd/Programs/OSDS.aspx

A copy of the Bidder's DVBE certification shall be included with the Bid Package.

If awarded, the Bidder who has made a commitment to achieve disabled veteran business enterprise (DVBE) participation, must within 60 days of receiving final payment under this Agreement (or within such other time period as may be specified elsewhere in this Agreement) certify in a report to the awarding department: (1) the total amount the prime contractor received under the Agreement; (2) the name and address of the DVBE(s) that participated in the performance of the Agreement; (3) the amount each DVBE received from the prime contractor; (4) that all payments under the Agreement have been made to the DVBE(s); and (5) the actual percentage of DVBE participation that was achieved. A person or entity that knowingly provides false information shall be subject to a civil penalty for each violation (Military & Veterans Code (M&VC) § 999.5(d)). Refer to Attachment H to fulfill this requirement.

Target Area Contract Preference Act (TACPA)

If the budget for services outlined in this announcement, exceeds \$100,000, CalRecycle shall grant a preference for TACPA qualified Bidders. The Bidder must provide reasonable demonstration of Agreement labor hours and certify that they shall comply with the requirements of the TACPA. If the Bidder is qualified for this preference, the TACPA Preference Request Form must be included in the Bid submittal. The form may be downloaded at www.calrecycle.ca.gov/contracts/forms.

Maximum Combined Preferences and Rules for Award

In combination with any other preferences (TACPA, SB or DVBE, participation), the maximum limit of the combined preferences is 15% of the bid amount and, in no case, more than \$100,000.00 per solicitation.

Preference programs for TACPA or the non-SB subcontracting preference cannot displace a direct award to a certified SB. In the event of a tie between a SB/MB and a firm that is SB/MB and DVBE, the award shall be made to the firm that is SB/MB and DVBE.

Subcontractors

All Subcontractors identified in the Bid, must be experts in their respective disciplines and capable of performing the tasks for which they are hired.

If awarded the Agreement, the Contractor **must** use all of the SB/MB and DVBE firms identified on the Bidder Declaration (Attachment G).

Contractor understands and agrees that should award of this Agreement be based in part on their commitment to use the Disabled Veteran Business Enterprise (DVBE) subcontractor(s) identified in their proposal, per Military and Veterans Code 999.5 (e), a DVBE subcontractor may only be replaced by another DVBE subcontractor and must be approved by the Department of General Services (DGS). Changes to the scope of work that impact the DVBE subcontractor(s) identified in the proposal and approved DVBE substitutions shall be documented by Agreement amendment.

Failure of Contractor to seek substitution and adhere to the DVBE participation level identified in the proposal may be cause for Agreement termination, recovery of damages under rights and remedies due to the State, and penalties as outlined in M&VC § 999.9; Public Contract Code (PCC) § 10115.10, or PCC § 4110 (applies to public works only).

CalRecycle reserves the right to approve substitutions of subcontractors, as long as, certified business participation levels remain unchanged.

Section III Bid Submittal Requirements

Introduction

Failure to follow the instructions contained in this document may be grounds for rejection of a Bid.

CalRecycle may reject any Bid if it is conditional, incomplete or contains irregularities.

CalRecycle may waive an immaterial deviation in a Bid, if deemed in the best interest of CalRecycle.

Deadline

The Bid package must be received by CalRecycle, at the address listed in Section I, Overview by 2:00 p.m. on April 17, 2018.

Bids received after the deadline shall be considered late and returned to the Bidder unopened.

Addressing

The Bid package must clearly state that it is in response to this IFB and note the IFB number listed with the direction of "Mailroom – do not open."

Number of Copies

The Bidder is required to submit all required documents in the following format:

- One original, non-bound hard copy marked "Original" (do not include bid sheet in this copy).
- One electronic copy on compact disc or USB flash drive viewable by Adobe Acrobat Reader (do not include bid sheet in this copy).
- One complete, signed bid sheet in a sealed envelope marked "Bid Do Not Open".

It is the submitting Bidder's responsibility to ensure that the electronic copy is formatted in Adobe Acrobat Reader and viewable by CalRecycle.

Document Printing

All documents must be submitted double-sided on paper with a minimum of 100% post-consumer recycled content fiber.

Cover Letter

The cover letter shall be signed by an individual who is authorized to bind the Bidder and shall indicate that person's title or position. The cover letter must be on the Bidder's company letterhead and contain the following information:

- a. Name and address of the Bidder submitting qualifications;
- b. Bidder's Headquarters for purposes of this Agreement, if awarded;
- c. Name, telephone number, and e-mail address of a person who can be contacted if further information is required;

- d. Name, title, address, telephone number, and e-mail address of individual(s) with authority to execute a binding Agreement on behalf of the Bidder;
- e. Statement that the bidder shall have qualified personnel available to meet the service needs;
- f. Statement attesting to the fact of the percentage of post-consumer recycled content fiber paper used in the compilation of the IFB package; and
- g. Statement stating that the Contractor and any Subcontractors to be used during the performance of the Agreement are eligible to contract with the State of California, pursuant to PCC 10286.

Qualifications and Resources

The prospective contractor must have the experience, qualifications, and resources to perform the required tasks of the project.

Each Bid must include a description of the resources to be used on the project while demonstrating an individual or team members' abilities to perform the work. The Bid must include resumes for the Project Manager, Personnel and Subcontractors, that include:

Experience

Knowledge

Educational Background

Appropriate Licensing (if applicable)

Each Bid must include a detailed response, outlining information as to how the prospective contractor meets each of the following minimum qualifications.

- 1. At least five (5) years of experience successfully providing digital and offset printing services.
- 2. At least five (5) years of experience successfully providing fulfillment services that meet all of the

following criteria:

- Fulfillment of small orders and of one hundred (100) or more orders per day from a single client within five business days.
- Assembly of multiple print materials into multiple distinctive, and complex kits on a per order basis.
- Inventory tracking.
- Ordering and inventory analysis.
- Maintenance of sufficient stock to avoid backorders.
- Maintaining an effective Quality Assurance and Quality Control program.
- Implementing contingency plans for immediate repair of any backorder situation.
- Packaging, shipping, and tracking orders.
- 3. Must have the ability to:
 - Receive and interpret Excel spreadsheets with order information sent via email.
 - Access the internet in order to interface with CalRecycle's web-based order management system.

- Provide a minimum of 20,000 sq. ft. of available working/storage space to house inventory and perform fulfillment services.
- Maintain an organized and labeled inventory of 500+ different curriculum components.
- Compile components into 170 distinct kits.
- Distribute kits as ordered.
- Receive hundreds of pallets of curriculum materials without special packaging or delivery requirements.
- Produce relevant, comprehensible inventory reports and detailed invoices.

Organization

Provide a brief description of the organization's services and activities, including:

- Date of establishment
- History
- Location
- Any known conflicts of interest

References

The Bidder's team must provide a minimum of three (3) verifiable references and/or experience that support the above qualifications.

CalRecycle reserves the right to seek references in addition to the client references provided by the Bidder, as it deems necessary.

If a reference or project experience is unable to be verified, it shall be disregarded.

Contractor Eligibility

The Bidder must include a written declaration, stating that the Contractor and any Subcontractors to be used during the performance of the Agreement are eligible to contract with the State of California, pursuant to PCC 10286.1. Statement may be included in the cover letter.

Contractor Licenses and Certifications

The Contractor shall be an individual or firm qualified to do business in California. Bids from business entities whose Business Entity Status with the California Secretary of State is anything other than "Active" shall be rejected. Required documentation includes the following as applicable:

- A copy of the Bidder's registration with the Secretary of State.
- Additionally, pursuant to the California Business and Professions Code, for services
 of a "professional" nature requiring a professional license issued by the CA
 Department of Consumer Affairs, Bidders must submit a copy of the appropriate
 license(s) for each team member who shall provide "professional" services under
 the Agreement.

Disabled Veteran Business Enterprise (DVBE) Participation

The DVBE participation requirement is being waived for this solicitation, however the DVBE incentive is available to those bidders meeting participation goals.

Cost Breakdown

The bid must specify the total cost and include detailed project costs, as required in the Cost Bid Sheet (Attachment A). The costs identified, shall take into consideration the length of the Agreement, rise in salaries and administrative overhead costs.

Failure to include on the Cost Bid Sheet budgeted costs for all tasks included in the Scope of Work shall be grounds for disqualification.

The Cost Bid Sheet is a self-contained document for purposes of calculating cost points and evaluating whether all information required by the IFB has been submitted. Therefore, all information (such as explanations of \$0 instead of itemized costs) must be included on the Cost Bid Sheet. Reference by incorporation to the Bid is not acceptable.

The amount identified on the cost breakdown may not be changed and shall remain in effect for the life of the Agreement.

Section IV Evaluation and Selection

Introduction

CalRecycle shall perform a Pre-Qualification Evaluation process to ensure that the Bidder has included all required documentation in the Bid submittal. The bid sheet must be in a separate sealed envelope marked "Bid – Do Not Open".

If a Bid package does not meet all of the requirements set forth in this IFB, it shall be considered non-responsive and rejected from further competition.

Grounds for Rejection

All bids may be rejected whenever the determination is made that the bids received are not competitive, when the cost is not reasonable, or when the cost exceeds the amount expected.

Additionally, a bid may be rejected if:

- It is received after the due date and time for submittal.
- The bid submittal is unsigned.
- The bid cost is not prepared as required by the IFB.
- The Bidder has been prohibited from contracting with the State by the Department of Fair Employment and Housing.
- The Bidder has received a substantive negative contract performance from the State.
- Any items required by the IFB are not included with the submittal.

No bid may be rejected arbitrarily or without reasonable cause.

Bid Opening

The qualified bids (sealed) shall be opened publicly at the time set in Section I, Process Schedule, in Room 240 of the CalEPA building located at 1001 I Street, Sacramento, CA 95814.

Award of Agreement

Award of this Agreement shall be to the lowest responsive responsible Bidder meeting all of the IFB requirements after preferences are applied as indicated in Section II Rules and Conditions.

In the event of a tie, CalRecycle shall utilize a tiebreaker to determine the winning Bidder. The tiebreaker shall be determined based on which bidder has the most SB and DVBE participation identified in the bid package.

CalRecycle reserves the right to not award an Agreement.

Rejection of Award

If the Bidder fails to enter into a satisfactory Agreement within a reasonable timeframe after the award is made, CalRecycle may deem that the Bidder has rejected the award.

CalRecycle reserves the right to disqualify the awardee and award the Agreement to the next lowest responsive responsible Bidder.

CalRecycle shall notify the rejected lowest responsive Bidder, at least five (5) days prior to the award being made, of the decision not to award the Agreement.

Notice of Intent to Award

CalRecycle shall post a notice of intent to award the Agreement resulting from this IFB, only upon written request of any Bidder.

The request must be submitted to the contact contained in Section I, Overview.

If requested, the notice of intent to award shall be posted on CalRecycle's contract website at www.calrecycle.ca.gov/contracts and at the headquarters address noted in Section I, Overview five days prior to award of the Agreement.

Protest of Award

A Bidder may protest the proposed award by filing an official protest with the Department of General Services. The protest must be filed after the notice of intent to award the Agreement, but before the actual award.

Within five (5) **working** days of the initial protest filing, the Bidder must submit a detailed written statement with information that supports that the Bidder shall have been awarded the Agreement and the grounds for that position.

The Agreement shall not be awarded until a decision has been made on the filed protest.

Section V Description of Work

Background

California is currently leading the nation in environmental literacy as a result of the Education and the Environment Initiative (EEI), a landmark environment-based education effort. Pursuant to California law (Chapter 665, Statutes of 2003 [AB1548; Pavley], and Chapter 581, Statutes of 2005 [AB1721; Pavley]), the California Environmental Protection Agency developed a Kindergarten through 12th grade curriculum that teaches students about their relationship with the environment while simultaneously instructing them on required academic content standards.

The EEI Curriculum is now in use in California schools and CalRecycle and its partners share the vision that successful implementation of EEI materials in our classrooms will increase the environmental literacy of our citizens and promote a sustainable and prosperous future for our State.

CalRecycle oversees distribution of the 85 EEI curriculum units that teach Science and History/Social Science using the environment as a context for learning. The State Board of Education approved all 85 units of the EEI Curriculum in early 2010.

Contractor Responsibilities

The awarded Contractor shall be responsible for the printing, storage, and order fulfillment of the curriculum units. As orders are submitted, the Contractor shall assemble the required components as per the order, and ship them to the order address. The Contractor shall be responsible for tracking inventory of print materials and maintaining a minimum level of inventory in stock.

The EEI Curriculum consists of 85 instructional units (with over 500 components) for Kindergarten through 12th grade (See Table 4). Every curriculum unit includes one Teacher's Edition (TE) book, one Visual Aids (VA) book, and one Teacher's Masters (TM) book. In addition, each unit may have additional components, such as a Student Edition, Student Workbook, Dictionary, Reader(s), Word Wall Cards, etc. The Contractor must compile a total of 170 distinct kits (one Teacher Kit and one Student Kit for each unit). All 85 instructional units can be found online at www.CaliforniaEEI.org. The TE books are password protected. The password to open those documents is: "teacheei".

Control of Work

CalRecycle's Contract Manager (Contract Manager) has the authority to determine the quality and acceptability of the following:

- The work that was performed
- The rate and progress of the work that was performed

The determination of quality and acceptability shall be deemed final and enforceable by the Contract Manager.

The Contractor shall designate a Project Manager who holds the following authority:

- Act as the Contractor's Representative for work to be provided under this Agreement
- Act as the Contractor's Representative regarding contractual matters relating to this Agreement

If during the course of the Agreement, it is deemed necessary to replace the Project Manager, the Contract Manager's approval is required.

Tasks

The Contractor shall perform the following tasks:

Task 1 – Print EEI Curriculum Materials as Directed by CalRecycle

CalRecycle shall provide the Contractor with periodic printing orders of EEI Curriculum units. Printing turnaround times shall be according to the chart below from the time the printing order is submitted to the printer by CalRecycle.

For the purposes of bidding on this IFB, the bidder may download PDF versions directly from the www.CaliforniaEEI.org website. Note: Teacher's Masters books and Visual Aid books will not be printed and therefore do not appear on the above chart.

Task 2– Inventory Control and Storage of Curriculum

- A. Contractor is responsible for receiving and storing an estimated 150-200 pallets of existing inventory that are components of some of the 85 curriculum units, including boxes of National Geographic Society (NGS) wall maps.
- B. Contractor shall properly store and protect from damage (using industry standards) all EEI Curriculum printed materials until fulfillment is requested by CalRecycle as described in Task 3.
- C. Contractor may receive and store large quantities of unit specific Next Generation Science Standards Correlations Guides from CalRecycle on a regular basis for incorporation into select Teacher's Kits for each fulfillment order.
- D. Contractor is responsible for maintaining an accurate balance of all inventory at all times.
- E. Contractor shall maintain accurate inventory information of EEI Curriculum, by unit kits, NGS maps, and Common Core Correlations Guides.
- F. Contractor shall report inventory status to CalRecycle on a weekly basis as specified in Task 3, B.2.
- G. Contractor shall provide ordering trend reports and successfully forecast and report reorder quantities for each curriculum unit upon request by the Contract Manager. See Task 3, B.3. for more details.

- H. At the end of the Agreement, and upon notice by the Contract Manager, the Contractor shall assemble and prepare in an organized fashion all remaining inventory for shipment to the location identified by CalRecycle. Contractor shall not be responsible for shipping costs.
- I. CalRecycle may occasionally ship Teacher Kits to the Contractor. Contractor shall store this material, include it in inventory reports, and use it to fulfill orders.

Task 3 – Fulfillment, Shipping, and Communications

- A. Fulfillment and Shipping
 - 1. Contractor shall regularly receive fulfillment order requests from the Contract Manager, or designee.
 - Fulfillment orders shall be submitted to the Contractor either by an Excel spreadsheet sent via email or by a web-based fulfillment order submittal system if such a system is implemented by CalRecycle during the course of the Agreement.
 - 3. Contractor must be willing to adapt to the possible use of a web-based fulfillment ordering system which would require the Contractor to access the internet daily to retrieve the fulfillment orders. In such a case, any required software license and/or training for the specific purpose of retrieving the fulfillment orders electronically, will be provided to the Contractor by CalRecycle.
 - 4. A fulfillment order may consist of as few as one unit-specific kit to as many as a pallet of materials going to one shipping address.
 - 5. For each fulfillment order, the Contractor shall have access to the recipient's name, unit kit(s) ordered, and mailing address.
 - 6. Upon receipt of fulfillment order requests from the Contract Manager or designee, Contractor shall pull and package fulfillment orders in unit-specific kits and quantities according to the specific fulfillment order requests. Fulfillment of orders shall be done within five business days of when CalRecycle submitted the order, unless given prior written approval from the Contract Manager.
 - 7. Contractor shall create a web-based special orders fulfillment system. This system would be accessed solely by CalRecycle staff and would not be accessed directly by CalRecycle's EEI customers. The Contractor must retrieve special orders daily and ship the order within 2 business days. The special order fulfillment system must:
 - a. Allow CalRecycle to assign multiple users.
 - b. Be password protected.
 - c. Upon shipment of order, send an email notification to the Contract Manager or designee and recipient of special order and include the tracking number/information.
 - 8. A Teacher's Kit shall include components specified in Table 2 and a Student Kit shall include components specified in Table 3. In addition to components noted in the respective tables, each EEI fulfillment order shipped shall include:
 - a. One (1) CalRecycle approved cover letter (which specifies content of shipment).
 - b. Unit specific NGS wall map(s).
 - 9. Any additional letter or materials included in the shipments other than approved cover letter insert must be pre-approved by CalRecycle.

- 10. Contractor shall ship to recipient identified by CalRecycle as indicated on each fulfillment order.
- 11. Contractor is not responsible for direct payment of shipping costs. CalRecycle shall specify the shipping vendor and provide the Contractor with shipping vendor account information and any special instructions.
- 12. Contractor shall input each tracking number and shipping date into CalRecycle's order management/tracking system within 24 hours from the time and date the order is picked up by the shipping vendor.
- 13. Contractor shall provide and use 100% recyclable packaging materials for shipment of EEI Curriculum components.
- 14. Contractor shall consolidate shipping of units to the same address, when feasible, to minimize shipping costs (e.g., box 1 of 5).
- 15. For bulk fulfillment orders going to the same address, the Contractor shall palletize and inform CalRecycle's shipping vendor of shipment size in advance of pick up by vendor.
- 16. Backlogs and Backorder Procedures:
 - a. Contractor shall promptly notify CalRecycle whenever there is a backlog of fulfillment orders and the reason for the backlog and an estimated date of when the backlog shall be processed.
 - b. Contractor shall immediately notify CalRecycle of any out-of-stock inventory and shall begin implementing a backorder process in concert with CalRecycle.
 - c. Contractor shall work with CalRecycle when alternative printing methods are implemented to fulfill backorders.
 - d. Contractor shall perform overtime or hire additional employees as needed to keep up with fulfillment and printing workloads.
- 17. Contractor shall put in place quality assurance and control mechanisms to ensure each fulfillment order shipped is accurate. See Task 3, C. for more details.

B. Communications

- 1. On a weekly basis, the Contractor shall provide a brief written summary of the week's activities. This report shall contain:
 - a. The order numbers received from CalRecycle.
 - b. The order numbers fulfilled by Contractor.
 - c. The order numbers pending for next week's fulfillment.
 - d. The order numbers on backorder, if applicable.
- 2. Contractor must provide the following inventory data as specified below:
 - a. Provide CalRecycle access to real-time inventory data (web-based).
 - b. Issue immediate email alerts when any unit's inventory levels drop below the critical point as determined by the Contract Manager.
- 3. Provide ordering and inventory analytics within 24 hours of request by the Contract Manager, to include:
 - a. Trending reports of most popular units ordered with quantity ordered, for a time frame specified by the Contract Manager.
 - b. Projection of orders for upcoming month by unit, based on past ordering trends.
 - c. Recommendation on quantities of specific unit kits to print and when to print them.

- C. Quality Assurance & Quality Control (QA/QC)
 - Contractor shall respond to any inquiries made by the Contract Manager or support staff regarding orders fulfillment discrepancies and inventory within 24 hours of the inquiry.
 - 2. Contractor shall establish and implement QA/QC strategies to assure the highest level of accuracy with fulfilling curriculum orders. The strategies shall be communicated to CalRecycle for concurrence. CalRecycle reserves the right to recommend additional strategies for implementation by the Contractor.
 - 3. Contractor shall immediately notify CalRecycle of any problems occurring such as with printing of materials, assembly and maintenance of stock, kitting of orders, or shipping deliveries.
 - Contractor shall repair and correct the identified problem(s) within 24 hours of notification by CalRecycle or self-identification by the Contractor, and shall keep CalRecycle apprised of the situation as it evolves.
 - 5. In the event of a problem determined to be the fault of the Contractor, the Contractor shall assume any cost to remedy the issue. For example, the Contractor shall pay to retrieve erroneous shipments from recipients and to re-ship to the proper recipient.
 - 6. Contractor shall absorb any additional print costs that are the result of error on the Contractor's part, such as lost materials, and poor print quality materials. Poor print quality materials include, but are not limited to, those that are too light, off-center, offcolor, have dog-eared corners, smudges, or inconsistent ink coverage.
 - 7. Contractor shall track and document all QA/QC issues and provide explicit information on how the issues are being addressed. The Contractor shall keep CalRecycle apprised of issues as they are identified and provide CalRecycle with periodic updates on the effectiveness of implemented QA/QC processes.

3. Background

California is currently leading the nation in environmental literacy as a result of the Education and the Environment Initiative (EEI), a landmark environment-based education effort. Pursuant to California law (Chapter 665, Statutes of 2003 [AB1548; Pavley], and Chapter 581, Statutes of 2005 [AB1721; Pavley]), the California Environmental Protection Agency developed a Kindergarten through 12th grade curriculum that teaches students about their relationship with the environment while simultaneously instructing them on required academic content standards.

The EEI Curriculum is now in use in California schools and CalRecycle and its partners share the vision that successful implementation of EEI materials in our classrooms will increase the environmental literacy of our citizens and promote a sustainable and prosperous future for our State.

CalRecycle oversees distribution of the 85 EEI curriculum units that teach Science and History/Social Science using the environment as a context for learning. The State Board of Education approved all 85 units of the EEI Curriculum in early 2010.

Contractor Responsibilities

The Contractor shall be responsible for the printing, storage, and order fulfillment of the curriculum units. As orders are submitted, the Contractor shall assemble the required components as per the order, and ship them to the order address. The Contractor shall be responsible for tracking inventory of print materials and maintaining a minimum level of inventory in stock.

The EEI Curriculum consists of 85 instructional units (with over 500 components) for Kindergarten through 12th grade (See Table 4). Every curriculum unit includes one Teacher's Edition (TE) book, one Visual Aids (VA) book, and one Teacher's Masters (TM) book. In addition, each unit may have additional components, such as a Student Edition, Student Workbook, Dictionary, Reader(s), Word Wall Cards, etc. The Contractor must compile a total of 170 distinct kits (one Teacher Kit and one Student Kit for each unit). All 85 instructional units can be found online at www.CaliforniaEEI.org. The TE books are password protected. The password to open those documents is: "teacheei".

5. Tasks

Task 1 – Print EEI Curriculum Materials as Directed by CalRecycle

Task 2- Inventory Control and Storage of Curriculum

- A. Contractor is responsible for receiving and storing an estimated 150-200 pallets of existing inventory that are components of some of the 85 curriculum units, including boxes of National Geographic Society (NGS) wall maps.
- B. Contractor shall properly store and protect from damage (using industry standards) all EEI Curriculum printed materials until fulfillment is requested by CalRecycle, as described in Task 3.
- C. Contractor may receive and store large quantities of unit specific Next Generation Science Standards Correlations Guides from CalRecycle on a regular basis for incorporation into select Teacher's Kits for each fulfillment order.
- D. Contractor is responsible for maintaining an accurate balance of all inventory at all times.
- E. Contractor shall maintain accurate inventory information of EEI Curriculum, by unit kits, NGS maps, and Common Core Correlations Guides.
- F. Contractor shall report inventory status to CalRecycle on a weekly basis as specified in Task 3, B.2.
- G. Contractor shall provide ordering trend reports and successfully forecast and report re-order quantities for each curriculum unit upon request by the CalRecycle Contract Manager (Contract Manager). See Task 3, B.3. for more details.
- H. At the end of the Agreement, and upon notice by the Contract Manager, the Contractor shall assemble and prepare in an organized fashion all remaining inventory for shipment to the location identified by CalRecycle. Contractor shall not be responsible for shipping costs.
- I. CalRecycle may occasionally ship Teacher Kits to the Contractor. Contractor shall store this material, include it in inventory reports, and use it to fulfill orders.

Task 3 – Fulfillment, Shipping, and Communications

- A. Fulfillment and Shipping
- 1. Contractor shall regularly receive fulfillment order requests from the Contract Manager, or designee.

- 2. Fulfillment orders shall be submitted to the Contractor either by an Excel spreadsheet sent via email or by a web-based fulfillment order submittal system if such a system is implemented by CalRecycle during the course of the Agreement.
- 3. Contractor must be willing to adapt to the possible use of a web-based fulfillment ordering system which would require the Contractor to access the internet daily to retrieve the fulfillment orders. In such a case, any required software license and/or training for the specific purpose of retrieving the fulfillment orders electronically, will be provided to the Contractor by CalRecycle.
- 4. A fulfillment order may consist of as few as one unit-specific kit to as many as a pallet of materials going to one shipping address.
- 5. For each fulfillment order, the Contractor shall have access to the recipient's name, unit kit(s) ordered, and mailing address.
- 6. Upon receipt of fulfillment order requests from the Contract Manager or designee, Contractor shall pull and package fulfillment orders in unit-specific kits and quantities according to the specific fulfillment order requests. Fulfillment of orders shall be done within five business days of order submission by CalRecycle, unless given prior written approval from the Contract Manager.
- 7. Contractor shall create a web-based special orders fulfillment system. This system would be accessed solely by CalRecycle staff and would not be accessed directly by CalRecycle's EEI customers. The Contractor must retrieve special orders daily and ship the order within 2 business days. The special order fulfillment system must:
 - a. Allow CalRecycle to assign multiple users
 - b. Be password protected
 - c. Upon shipment of order, send email notification to the Contract Manager or designee and recipient of special order and include tracking number/information.
- 8. A Teacher's Kit shall include components specified in Table 2 and a Student Kit shall include components specified in Table 3. In addition to components noted in the respective tables, each EEI fulfillment order shipped shall include:
 - a. One (1) CalRecycle approved cover letter (which specifies content of shipment)
 - b. Unit specific NGS wall map(s)
- 9. Any additional letter or materials included in the shipments other than approved cover letter insert must be pre-approved by CalRecycle.
- 10. Contractor shall ship to recipient identified by CalRecycle as indicated on each fulfillment order.
- 11. Contractor is not responsible for direct payment of shipping costs. CalRecycle shall specify the shipping vendor and provide the Contractor with shipping vendor account information and any special instructions.
- 12. Contractor shall input each tracking number and shipping date into CalRecycle's order management/tracking system within 24 hours from the time and date the order is picked up by the shipping vendor.
- 13. Contractor shall provide and use 100% recyclable packaging materials for shipment of EEI Curriculum components.
- 14. Contractor shall consolidate shipping of units to the same address, when feasible, to minimize shipping costs (e.g., box 1 of 5).
- 15. For bulk fulfillment orders going to the same address, the Contractor shall palletize and inform CalRecycle's shipping vendor of shipment size in advance of pick up by vendor.
- 16. Backlogs and Backorder Procedures:
 - a. Contractor shall promptly notify CalRecycle whenever there is a backlog of fulfillment orders and the reason for the backlog and an estimated date of when the backlog shall be processed.
 - b. Contractor shall immediately notify CalRecycle of any out-of-stock inventory and shall begin implementing a backorder process in concert with CalRecycle.

- c. Contractor shall work with CalRecycle when alternative printing methods are implemented to fulfill backorders.
- d. Contractor shall perform overtime or hire additional employees as needed to keep up with fulfillment and printing workloads.
- 17. Contractor shall put in place quality assurance and control mechanisms to ensure each fulfillment order shipped is accurate. See Task 3, C. for more details.
- B. Communications
 - 1. On a weekly basis, the Contractor shall provide a brief written summary of the week's activities. This report shall contain:
 - a. The order numbers received from CalRecycle.
 - b. The order numbers fulfilled by Contractor.
 - c. The order numbers pending for next week's fulfillment.
 - d. The order numbers on backorder, if applicable.
 - 2. Contractor must provide the following inventory data as specified below:
 - a. Provide CalRecycle access to real-time inventory data (web-based).
 - b. Issue immediate email alerts when any unit's inventory levels drop below the critical point as determined by the Contract Manager.
 - 3. Provide ordering and inventory analytics within 24 hours of request by the Contract Manager, to include:
 - a. Trending reports of most popular units ordered with quantity ordered, for a time frame specified by the Contract Manager.
 - b. Projection of orders for upcoming month by unit, based on past ordering trends.
 - c. Recommendation on quantities of specific unit kits to print and when to print them.
- C. Quality Assurance & Quality Control (QA/QC)
 - 1. Contractor shall respond to any inquiries made by the Contract Manager or support staff regarding orders fulfillment discrepancies and inventory within 24 hours of the inquiry.
 - 2. Contractor shall establish and implement QA/QC strategies to assure the highest level of accuracy with fulfilling curriculum orders. The strategies shall be communicated to CalRecycle for concurrence. CalRecycle reserves the right to recommend additional strategies for implementation by the Contractor.
 - 3. Contractor shall immediately notify CalRecycle of any problems occurring such as with printing of materials, assembly and maintenance of stock, kitting of orders, or shipping deliveries.
 - 4. Contractor shall repair and correct the identified problem(s) within 24 hours of notification by CalRecycle or self-identification by the Contractor, and shall keep CalRecycle apprised of the situation as it evolves.
 - 5. In the event of a problem determined to be the fault of the Contractor, the Contractor shall assume any cost to remedy the issue. For example, the Contractor shall pay to retrieve erroneous shipments from recipients and to re-ship to the proper recipient.
 - 6. Contractor shall absorb any additional print costs that are the result of error on the Contractor's part, such as lost materials, and poor print quality materials. Poor print quality materials include, but are not limited to, those that are too light, off-center, off-color, have dog-eared corners, smudges, or inconsistent ink coverage.
 - 7. Contractor shall track and document all QA/QC issues and provide explicit information on how the issues are being addressed. The Contractor shall keep CalRecycle apprised of issues as they are

identified and provide CalRecycle with periodic updates on the effectiveness of implemented QA/QC processes.

- C. Each invoice submitted to CalRecycle shall include the following information:

 - Contract Number
 - Description of Rendered Activities/Services
 - Submitting Contractor's Address
 - Invoice Period

2. BUDGET CONTINGENCY CLAUSE:

- A. It is mutually agreed that if the Budget Act of the current year and/or any subsequent years covered under this Agreement does not appropriate sufficient funds for the program, this Agreement shall be of no further force and effect. In this event, the State shall have no liability to pay any funds whatsoever to the Contractor or to furnish any other considerations under this Agreement and the Contractor shall not be obligated to perform any provisions of this Agreement.
- B. If funding for any fiscal year is reduced or deleted by the Budget Act for purposes of this program, the State shall have the option to either: cancel this Agreement with no liability occurring to the State, or offer an Agreement Amendment to the Contractor to reflect the reduced amount.
- 3. <u>PROMPT PAYMENT CLAUSE</u>: Payment shall be made in accordance with and within the time specified in Government Code, Chapter 4.5 (commencing with Section 927).
- 4. <u>TAXES</u>: The State of California is exempt from Federal Excise Taxes, and no payment shall be made for any taxes levied on employees' wages. The State will pay for any applicable State of California or local sales or use taxes on the services rendered or equipment or parts supplied pursuant to this Agreement. California may pay any applicable sales or use tax imposed by another state.

- 2. <u>AMENDMENT</u>: No amendment or variation of the terms of this Agreement shall be valid unless made in writing, signed by the parties and approved as required. No oral understanding or agreement not incorporated in this Agreement is binding on any of the parties. CalRecycle reserves the right to amend this Agreement through a formal written amendment signed by both parties, for additional time and/or funding.
- 3. <u>CALIFORNIA WASTE TIRES</u>: Unless otherwise provided for in this contract, in the event the Contractor and/or Subcontractor(s) purchases waste tires or waste-tire derived products for the performance of this Agreement, only California waste tires and California waste tire-derived products shall be used. As a condition of payment under this Agreement, the Contractor must provide documentation substantiating the source of the tire materials used during the performance of this Agreement to the Contract Manager.
 - All formal notices required by this Agreement must be given in writing and sent by prepaid certified mail, fax, personal delivery or telex.
- 4. <u>CONTRACT MANAGEMENT</u>: The Contractor and the agents and employees of the Contractor, in the performance of this Agreement, shall act in an independent capacity and not as officers or employees or agents of the State of California. The Contractor may change the designated Project Director, but CalRecycle reserves the right to approve any substitution of the Project Director. Contractor's key personnel may not be substituted without CalRecycle's Contract Manager's prior written approval. CalRecycle may change the Contract Manager by notice given to the Contractor at any time. CalRecycle staff will be permitted to work side by side with the Contractor's staff to the extent and under conditions that may be directed by the Contract Manager. In this connection, CalRecycle's staff will be given access to all required data, working papers, etc. The Contractor will not be permitted to utilize the CalRecycle's staff for the performance of services, which are the responsibility of the Contractor unless the Contract Manager previously agreed to such utilization in writing, and any appropriate adjustment in price is made. No charge will be made to the Contractor for the services of CalRecycle's staff for coordination or monitoring functions.
- 5. CONTRACTOR EVALUATIONS: If this Agreement is for consulting services, CalRecycle will evaluate the Contractor's performance within sixty days of the completion of this Agreement and shall remain on file by CalRecycle for a period of thirty-six months. If the Contractor does not satisfactorily perform the work or service specified in this Agreement, CalRecycle will submit a copy of the negative evaluation to the Department of General Services (DGS), Office of Legal Services, within five (5) working days of the completion of the evaluation. Upon filing an unsatisfactory evaluation with the DGS, CalRecycle shall notify and send a copy of the evaluation to the Contractor within fifteen days. The Contractor shall have thirty days to prepare and send a written response to CalRecycle and the DGS. CalRecycle and the DGS shall file the Contractor's statement with the evaluation. (PCC §10369).

- 6. <u>CONFIDENTIALITY/PUBLIC RECORDS</u>: The Contractor and CalRecycle understand that each party may come into possession of information and/or data, which may be deemed confidential or proprietary by the person or organization furnishing the information or data. Such information or data may be subject to disclosure under the California Public Records Act, commencing with GC § 6250, or the PCC. CalRecycle agrees not to disclose such information or data furnished by Contractor and to maintain such information or data as confidential when so designated by Contractor in writing at the time it is furnished to CalRecycle, only to the extent that such information or data is exempt from disclosure under the California Public Records Act and the PCC.
- 7. <u>CONFLICT-FUTURE BIDDING LIMITATION</u>: Pursuant to Public Contracts Code Section 10365.5:
 - (a) No person, firm, or subsidiary therefore who has been awarded a consulting services contract may submit a bid for, nor be awarded a contract for, the provision of services, procurement of goods or supplies, or any other related action that is required, suggested, or otherwise deemed appropriate in the end product of the consulting services contract.
 - (b) Subdivision (a) does not apply to any person, firm, or subsidiary thereof who is awarded a subcontract of a consulting services contract that amounts to no more than ten (10) percent of the total monetary value of the consulting services contract.
 - (c) Subdivisions (a) and (b) do not apply to consulting services contracts subject to Chapter 10 (commencing with Section 4525) of Division 5 of Title 1 of the Government Code.
- 8. <u>CONSULTING SERVICES</u>: If this Agreement is for consulting services, the Contractor is hereby advised of its duties, obligations and rights under PCC §§10335 through 10381.
- 9. <u>COPYRIGHTS AND TRADEMARKS</u>: The Contractor shall assign to CalRecycle any and all rights, title and interests to any copyrightable material or trademarkable material created or developed in whole or in any part as a result of this Agreement, including the right to register for copyright or trademark of such materials. The Contractor shall require that its subcontractors agree that all such materials shall be the property of CalRecycle. Such title will include exclusive copyrights and trademarks in the name of CalRecycle.
 - For contracts of \$5,000 or more, any document or written report prepared for or under the direction of CalRecycle, shall include a notation on the inside cover as follows:
 - "Prepared as part of CalRecycle contract number DRR17111, Total Contract Amount \$847,839.84, pursuant to Government Code Section 7550."
- 10. <u>DELIVERABLES</u>: All documents and/or reports drafted for publication by or for CalRecycle in accordance with this contract shall adhere to CalRecycle's Contractor Publications Guide at www.calrecycle.ca.gov/Contracts/PubGuide/ and shall be reviewed by CalRecycle's Contract Manager in consultation with CalRecycle editor.
- 11. <u>ENTIRE AGREEMENT</u>: This Agreement supersedes all prior agreements, oral or written, made with respect to the subject hereof and, together with the Attachments and/or Exhibits hereto, contains the entire Agreement of the parties.
- 12. <u>ENVIRONMENTAL JUSTICE</u>: In the performance of this Agreement, the Contractor shall conduct its programs, policies, and activities that substantially affect human health or the environment in a manner that ensures the fair treatment of people of all races, cultures, and income levels, including minority populations and low income populations of the State. (Government Code Section 65040.12(e)).

- 13. <u>FORCE MAJEURE</u>: Neither CalRecycle nor the Contractor, including the Contractor's subcontractor(s), if any, will be responsible hereunder for any delay, default or nonperformance of this Agreement, to the extent that such delay, default or nonperformance is caused by an act of God, weather, accident, labor strike, fire, explosion, riot, war, rebellion, sabotage, or flood, or any other cause beyond the reasonable control of such party.
- 14. <u>GRATUITIES</u>: CalRecycle may terminate this Agreement if gratuities were offered or given by the Contractor, or any agent or representative of the Contractor, to any employee of CalRecycle, with a view toward securing a contract or securing favorable treatment with respect to awarding or amending or making a determination with respect to performance of this Agreement.
- 15. <u>IMPRACTICABILITY OF PERFORMANCE</u>: This Agreement may be suspended or cancelled, without notice at the option of the Contractor, if the Contractor's or CalRecycle premises or equipment is destroyed by fire or other catastrophe, or so substantially damaged that it is impractical to continue service or in the event the Contractor is unable to render service as a result of any action by any governmental authority.
- 16. <u>INSURANCE</u>: When required, the Contractor must provide: 1) a Certificate of Insurance insuring CalRecycle, and/or 2) verification of Worker's Compensation insurance. The Contractor must provide said Certificate of Insurance and/or verification to CalRecycle within ten (10) days after notification of CalRecycle's intent to award the Agreement. The Agreement will not be executed nor can work begin unless said Certificate of Insurance and/or verification is provided to CalRecycle.

The Certificate of Insurance must be in effect and shall include the following terms and conditions:

- (a) CalRecycle, its officers, agents, employees, and servants shall be included as additional insured.
- (b) The dates of inception and expiration of coverage shall be specified.
- (c) A minimum liability coverage of not less than \$1,000,000 per occurrence for bodily injury and property damage liability combined shall be specified. The coverage shall not include a deductible feature.
- (d) The insurer will not cancel the insured's coverage without thirty days prior written notice to CalRecycle.
- (e) CalRecycle is not liable for the payment of premiums or assessments on said policy.
- (f) The insurance coverage shall be on an occurrence basis only.

In the event the Certificate of Insurance should expire or be cancelled during the term of this Agreement, the Contractor agrees to provide, at least thirty days prior to said expiration or cancellation, a new Certificate of Insurance evidencing coverage, as provided for herein, for not less than one (1) year or for the remainder of the contractual agreement, whichever is greater. In the event the Contractor fails to keep in effect at all times insurance coverage as herein provided, CalRecycle may, in addition to any other remedies it may have, terminate this Agreement upon occurrence of such event.

17. <u>LIABILITY FOR NONCONFORMING WORK</u>: The Contractor will be fully responsible for ensuring the completed work conforms to the agreed upon terms. If nonconformity is discovered prior to the Contractor's deadline, the Contractor will be given a reasonable opportunity to cure the nonconformity. If the nonconformity is discovered after the deadline for the completion of the project, CalRecycle, in its sole discretion, may use any reasonable means to cure the nonconformity. The Contractor shall be responsible for reimbursing CalRecycle for any additional expenses incurred to cure such defects.

- 18. <u>LICENSE OR PERMITS</u>: The Contractor shall be an individual or firm licensed to do business in California and shall obtain at his/her expense all license(s) and permit(s) required by law for accomplishing any work required in connection with this Agreement.
 - In the event the Contractor fails to keep in effect at all times all required license(s) and permit(s), CalRecycle may, in addition to other remedies it may have, terminate this Agreement upon occurrence of such event.
- 19. OWNERSHIP OF DRAWINGS, PLANS AND SPECIFICATIONS: CalRecycle will have separate and independent ownership of all drawings, design plans, specifications, notebooks, tracings, photographs, negatives, reports, findings, recommendations, data and memoranda of every description or any part thereof, prepared under this Agreement. The originals and all copies thereof will be delivered to CalRecycle upon request. CalRecycle will have the full right to use said originals and copies in any manner when and where it may determine without any claim on the part of the Contractor, its vendors or subcontractors to additional compensation.
- 20. <u>PATENTS</u>: The Contractor assigns to CalRecycle all rights, title, and interest in and to each invention or discovery that may be capable of being patented, that is conceived of or first actually reduced to practice in the course of or under this Agreement.
- 21. <u>PUBLICITY AND ACKNOWLEDGEMENT</u>: The Contractor agrees that it will acknowledge CalRecycle's support whenever projects funded, in whole or in part, by this Agreement are publicized in any news media, brochures, or other type of promotional material.
- 22. RECYCLED-CONTENT PRODUCT PURCHASING: In the performance of this Agreement, the Contractor shall purchase used and/or recycled-content products as set forth on the back of the Recycled-Content Certification Form (Exhibit D, Attachment 1). For assistance in locating recycled-content products, please search the recycled-content product database available at: www.calrecycle.ca.gov/rcpm. If after searching the database, contractors are unable to find the recycled-content products they are looking for, please notify CalRecycle's Contract Manager. All recycled content products purchased or charged/billed to CalRecycle that are printed upon such as promotional items, publications, written materials, and other educational brochures shall have both the total recycled content (TRC) and the post-consumer (PC) content clearly printed on them.
 - In addition, any written documents such as, publications, letters, brochures, and/or reports shall be printed double-sided on 100% post-consumer (PC) paper. Specific pages containing full-color photographs or other ink-intensive graphics may be printed on photographic paper. The paper should identify the post-consumer recycled content of the paper (i.e., "printed on 100% post-consumer paper"). When applicable, the Contractor shall provide the Contract Manager with an electronic copy of the document and/or report for CalRecycle's uses. When appropriate, only an electronic copy of the document and/or report shall be submitted and no hard copy shall be provided.
- 23. <u>REMEDIES</u>: Unless otherwise expressly provided herein, the rights and remedies hereunder are in addition to, and not in limitation of, other rights and remedies under the Agreement, at law or in equity, and exercise of one right or remedy will not be deemed a waiver of any other right or remedy.
- 24. <u>SETTLEMENT OF DISPUTES</u>: In the event of a dispute, the Contractor shall file a "Notice of Dispute" with CalRecycle's Director or his/her designee with ten (10) days of discovery of the problem. Within ten (10) days, the Director or his/her designee shall meet with the Contractor and CalRecycle Contract Manager for the purpose of solving the dispute.
- 25. <u>STOP WORK NOTICE</u>: Immediately, upon receiving a written notice to stop work, the Contractor shall cease all work under this Agreement.

- 26. <u>SUBCONTRACTORS</u>: All Subcontractors previously identified in the bid/proposal submitted are considered to be acceptable to CalRecycle. Any change or addition of Subcontractors will be subject to the prior written approval of the Contract Manager or the Director or his/her designee. Upon termination of any Subcontract, the Contractor shall notify the Contract Manager or the Executive Director immediately. If CalRecycle or the Contractor determines that the level of expertise or the services required are beyond that provided by the Contractor or its routine Subcontractors, The Contractor will be required to employ additional Subcontractors. Nothing contained in this Agreement or otherwise, shall create any contractual relation between CalRecycle and any Subcontractors, and no Subcontract shall relieve the Contractor of its responsibilities and obligations hereunder. The Contractor agrees to be as fully responsible to CalRecycle for the acts and omissions of its Subcontractors and of persons either directly or indirectly employed by any of them as it is for the acts and omissions of persons directly employed by the Contractor. The Contractor's obligation to pay its Subcontractors is an independent obligation from CalRecycle obligation to make payments to the Contractor. As a result, CalRecycle shall have no obligation to pay or to enforce the payment of any moneys to any Subcontractor.
- 27. <u>SUCCESSORS</u>: The provisions of this Agreement will be binding upon and inure to the benefit of CalRecycle, the Contractor, and their respective successors.
- 28. <u>TERMINATION</u>: CalRecycle shall have the right to terminate this Agreement at its sole discretion at any time upon thirty days written notice given to the Contractor. In the case of early termination, a final payment will be made to the Contractor upon approval by the Contract Manager of a financial report, invoices for costs incurred to date of termination and a written report describing all work performed by the Contractor to date of termination.
- 29. <u>UNRELIABLE LIST</u>: Prior to authorizing a Subcontractor(s) to commence work under this Agreement, the Contractor shall submit to CalRecycle a declaration from the Subcontractor(s), signed under penalty of perjury, stating that within the preceding three years, none of the events listed in Section 17050 of Title 14, California Code of Regulations, Natural Resources, Division 7, have occurred with respect to the subcontractor(s).
 - Placement of Contractor on CalRecycle Unreliable List anytime after award of this Agreement may be grounds for termination of Agreement. If a Subcontractor is placed on CalRecycle Unreliable List after award of this Agreement, the Contractor may be required to terminate the Subcontract.
- 30. <u>WASTE REDUCTION</u>: In the performance of this Agreement, the Contractor shall take all reasonable steps to ensure that materials purchased or consumed in the course of the project are utilized both effectively and efficiently to minimize the generation of waste. The steps should include, but not necessarily be limited to, the use of reusable products, the use of recyclable and compostable products, discretion in the amount of materials used, the provision of alternatives to disposal for materials consumed, and the practice of other waste reduction measures where feasible and appropriate.
