- 1. Attached is a list of all businesses who have expressed an interest in the contract to date (Attachment 1).
- 2. Attached is a list of those who attended the Pre-Bid Conference on August 17, 2018. (Attachment 2).
- 3. The IFB has been revised and the corrections where text additions are displayed in **bold** and <u>underlined</u> and text deletions are displayed as strikethrough text (i.e., strike).
- 4. The following questions were submitted in response to the IFB and answers to each follow the question.
 - Q1. Can you please confirm that the bid date is August 27th? On Page 12 of the RFP, the bid date says August 23rd?
 - A1. The Bid package is due on August 27, 2018 by 2:00 p.m., as shown in the REVISED IFB (attached).
 - Q2. Are bid tabulations available for the above subject contract, DRR17075?
 - A2. CalRecycle will provide this information and it is available for viewing on our ftp site for 30 days under the Carr Fire folder:

Enter Username: ftpuser1 and Password: crftpuser1 (Internet Explorer users may encounter a "The page cannot be displayed" error and will need to change a configuration setting. Go to the "Tools" menu, select "Internet Options...", then the "Advanced" tab, then make sure the "Enable Folder View for FTP Sites" checkbox is checked.)

- Q3. I am trying to find information for previous awarded contracts and I have hard time finding them online I wonder if you could help me. I am looking for the bid results for the following past contracts:
 - DRR17075 Fire Debris Removal and Recovery Services for the Wind Complex Fires in Butte, Nevada and Yuba Counties

- DRR17074 Debris Management for the Wind Complex Fires in Butte, Nevada, and Yuba Counties
- DRR15047 Debris Monitoring for the Valley and Butte Fire Remediations
- DRR15042 Fire Debris and Recovery Services for the Valley Fire in Napa and Lake Counties
- A3. Yes. See A2 for access information.
- Q4. In item 10b, the Est. Quantity and Multiplier do not match. Please clarify.
- A4. The correct multiplier is 2,400 cubic yards. The estimated quantity is correct and the multiplier has been revised to 2,400.
- Q5. In Items 23-25, at 170 tons per lot, shouldn't the total be 136,000 tons? This would match Item 12. At 170,000 tons it seems to imply 1,000 lots will be cleared. Please clarify.
- A5. The correct multiplier is 136,000 tons. The estimated quantity and the multiplier will both be revised to 136,000.
- Q6. In item 50, the Est. Quantity and Multiplier do not match. Please clarify.
- A6. The correct multiplier is 800 mobilizations. The estimated quantity is correct and the multiplier has been revised to 800.
- Q7. Will the Contractor be able to invoice twice per month as in past CalRecycle Debris Removal projects?
- A7. Yes.
- Q8. Is there a current to date interested parties list, for the DRR18052 and or the DRR18053 RFP? I have the addendum dated August 14 2018.
- A8. Please review Attachment 1 for the interested parties list for the subject IFB, DRR18053. If you have Addendum 1 to RFP DRR18052 then you are already in possession of those interested parties.
- Q9. On the website it says submittals due 8/27 in the document on Page 12 it says they are due 8/23. Which is correct?
- A9. See A1.
- Q10. In past debris removal projects, CalRecycle has reimbursed the Debris Removal Contractor for costs associated with rental, set-up and take-down of laydown areas at cost plus a 10% markup. Will that be the case on the Carr Fire Project?
- A10. Yes. As laydown areas have not been identified, this will be addressed through a Change Order through the Contract Manager.

- Q11. Cost Bid Schedule. Item 10b. The column 'Estimated Qty' indicates 2,400 cu. Yd total. However, the 'Multiplier' on the Bid Form = 1,800. Which is correct?
- A11. See A4.
- Q12. Cost Bid Schedule. Item 50. The column 'Estimated Qty' indicates 800 mobilizations between lots. However, the 'Multiplier' on the Bid form = 600. Which is correct?
- A12. See A6.
- Q13. Cost Bid Schedule Item 56, Safety Fencing. Does the safety fencing become the property of the homeowner or will the contractor be required to remove the fencing in the future?
- A13. It will become the property of the homeowner and will be left at the property.
- Q14. If the contractor is to remove the fencing in the future, how long should the contractor leave the fencing on site?
- A14. See A13.
- Q15. Also, please confirm that the pricing is based on a linear foot and not a lot, correct?
- A15. Correct.
- Q16. Under Debris Removal Per Lot Asbestos Abatement (if applicable): Item 10b is the per yard cost for proper transport and disposal of asbestos containing materials to an approved facility. To allow contractors to compliantly plan for transportation and disposal, and allow CalRecycle to establish a uniform basis of estimate for ACM waste disposal volume, can CalRecycle provide an estimated quantity for both "Friable ACM per lot"?
- A16. CalRecycle treats all identified asbestos as friable during this project. The quantities estimates in the Bid Schedule are based on all material being friable.
- Q17. Alternatively, can CalRecycle provide two separate line items in the pricing sheet, one for non-friable ACM and one for friable ACM? Note that this issue stems from the fact that the local landfills can accept non-friable ACM but may not be able to accept friable ACM; therefore, the shipping and disposal costs will vary greatly between friable and non-friable ACM.
- A17. No, please see A16.
- Q18. Section V Description of Work, Tasks. Under bullet C., it states that work "may involve...related support services, such as... community air monitoring..." Items 5a. and 5b. only relate to Personnel Air Monitoring. No specifications were included for community air monitoring, and there is no line item on the Cost Bid

- Schedule for this activity. Would a Work Order for such services constitute a Change?
- A18. Community air monitoring is not envisioned to be a part of this contract and is included in the scope of the consultant services contract (DRR18052).
- Q19. Section 1. Service Needed. Reference to statement, "Every fifth Saturday will be a non-working day and considered a safety stand-down day." Will CalRecycle hold, or expect the Contractor to hold, a special safety-related event with mandatory attendance on the safety stand-down days?
- A19. No, this is intended as a day off to provide crews a break from the project and there are no requirements for this non-working day.
- Q20. Section III. Overall Project Costs. Items 20-31 Transportation. Description of this scope includes "traffic control". Is this a separate and distinct activity than Item 4 Community Traffic Control? Please explain.
- A20. Traffic control is not included in the transportation item and has a separate Bid Schedule Item 4 to address the activity.
- Q21. Mandatory Pre-Bid Meeting. Can the sign-in sheet for this meeting be provided to Bidders?
- A21. Yes, see Attachment 2.
- Q22. Section III. Number of Copies. Is the hard copy documentation required to be hole-punched?
- A22. The hard copy does not need to be hole-punched, however the documentation must be organized.
- Q23. Appendix J. The ftp. Site for the DROP requires username and password. Will CalRecycle provide this? ftp://ftp.calrecycle.ca.gov/RetainedUpTo90Days/Carr%20Fire/
- A23. Enter Username: ftpuser1 and Password: crftpuser1

 (Internet Explorer users may encounter a "The page cannot be displayed" error and will need to change a configuration setting. Go to the "Tools" menu, select "Internet Options...", then the "Advanced" tab, then make sure the "Enable Folder View for FTP Sites" checkbox is checked.) You may have to cut and paste the website into the browser address window rather than click the address for it to work properly.
- Q24. The Link to the Debris Removal Operation Plan (DROP) found on page 77 of the IFB is not working. Please provide DROP document.
- A24. See A23.

- Q25. Page 30 of the IFB, first paragraph states that CalRecycle will have the option to dictate the number of asbestos and debris removal crews utilized at any given time. The scope states that we are to provide two asbestos abatement crews and one chimney tipping crew within 48 hours. We are to supply 15 debris removal crews within 5 days and up to 35 additional debris removal crews within 21 days. Given the statement where CalRecycle can dictate the number of crews utilized, please provide the required time frame for providing additional asbestos abatement crews and chimney tipping crews should we receive notice.
- A25. The number of additional asbestos abatement and chimney tipping crews are not known at this time and the desire is that the Contractor provide additional crews when requested within 5 days of the request. There will be no contractual requirement added to the IFB or contract for the timeliness of the additional crews.
- Q26. Are there additional maps of the damaged structures? If so, please provide.
- A26. The only mapping information available at this time is the GIS system managed by the California Department of Toxic Substances Control (DTSC). The link to the DTSC mapping is: https://www.dtsc.ca.gov/SiteCleanup/ERP/wildfire-waste-removal.cfm.
- Q27. Our company, JA Snyder Pacific West was up there on Friday and signed up on the list. I do not see the company on the list of bidders. Was there determination of who made it on this list?
- A27. CalRecycle shows you on both the sign in sheet from the Pre-Bid meeting and the interested parties list. See Attachment 1 and 2.
- Q28. Please clarify the bid submittal date. Conflict between pg. 3 with date of 8.27.18 and pg. 12 with date of 8.23.18.
- A28. See A1.
- Q29. Is the soil confirmation sampling part of the contract time?
- A29. Soil confirmation sampling will be done by CalRecycle's consultant. The time needed to sample is part of the contract time, as this contract will perform other work, such as soil rescrapes and erosion control, after soil sampling is complete. The debris removal to be completed by November 17, 2018, includes the removal of asbestos, burn ash and debris, concrete, and contaminated soil removal, and does NOT include soil sampling, rescrapes, erosion control, and other items of work that may take place after the contaminated soil is removed.
- Q30. Please provide current link to the DROP.
- A30 See A23.
- Q31. With the small number of lots expected to require debris removal how likely is it that more than 25 crews will be requested?

- A31. CalRecycle intends on using up to 50 crews to remove fire debris and the Contractor work force (Prime Contractor and subcontractors) needs to be able to provide the requested resources within the timelines described in the IFB.
- Q31 Please provide link to the DTSC website reference in the Mandatory Pre-Bid conference?
- A.31. See A26.
- Q32. Please provide disposal site referenced in Attachment K.
- A32 Disposal sites for each material have not yet been identified. Although all material is likely to go to the Anderson Landfill or another local resource, CalRecycle has not identified locations and may need the longer haul trucking items in the bid schedule to move material. The recycling/disposal site costs will be a pass through item per the Bid Schedule and IFB.
- Q33. Regarding items 11, 12,13,14,15, will the workers be required to be asbestos or haz wopper trained?
- A33. Workers in the exclusion zone will be required to be 40-hour HAZWOPR trained.
- Q34. Please identify what the typical miscellaneous metals are (Item 11).
- A34. There are a wide range of metals at these sites. Examples of typical metals found are appliances, air conditioning equipment, metal roofing, and propane tanks.
- Q35. Regarding items 53 and 54, is stump removal included?
- A35 Stump removal is not required for this project.
- Q36. Item 52 and 52b compacted or just spread?
- A36. Compacted.
- Q37. Items 57 what size?
- A37 Provide a bid for a 1,000 gallon septic tank, with 1,000 gallons of septage removed and filled with 2 sack sand slurry.
- Q38. Item 15: is this a uniform removal of a few inches over the entire site or spot removal?
- A38. A few inches over the entire impacted part of the site where fire debris removal work was performed.
- Q39. Item 51; what is crew size?
- A39. Two laborers and one skidsteer.

- Q40. Item 10: how will asbestos be identified?
- A40. CalRecycle's consultant for the project will be performing a site assessment that includes an asbestos assessment. Sites containing bulk asbestos will be identified as lots are assigned to the Contractor.
- Q41. Item 12: Please be more specific as to what separation will be required. ("Direction from CalRecycle") directions during the work cannot be priced into the per ton price at bid time.
- A41. The material separation that is referred to in Bid Schedule Items 11, 12, 13, 14, and 15 is contained on pages 17 and 18 of the sample DROP. The separation being referred to is the separation and separate handling, hauling, and disposal of asbestos, metals, burn ash and debris, and concrete and is contained in both the the DROP and text in the IFB.
- Q42. Will any of the existing concrete slabs or foundations be required to be saved/protected from damage from the removal efforts?
- A42. The concrete slabs within the burn ash footprint will be removed, as will all building foundations. A limited amount of slabs may be saved/protected upon homeowner request, but this will be limited. Retaining walls may remain in place.
- Q43. Item 15, what separation is required for this task? Directions during the work cannot be priced into the bid.
- A43. See A41.
- Q44. CalRecycle's past performance requirements limit competition to those firms that have performed a minimum of three fire-related private property debris contracts for CalRecycle in the past five years. Specifically, the IFB calls for "the Bidder's team to provide a minimum of three (3) verifiable post-private property debris removal emergency projects in the State of California as a prime or subcontractor." Further, the IFB states "the prime contractor is required to have at least one previous contract (or subcontract) with the State of California on a fire debris project, with the two other references begin on fire debris removal projects in California. Subcontractors do not need California fire debris removal experience."

Reference requirements were discussed during the pre-event meeting and were clarified as three references from CalRecycle fire-related private property contracts in the past five years. These bidding requirements as stated could potentially threaten CalRecycle's FEMA reimbursement. 2 C.F.R. 200.319 Competition discusses specific situations that the federal government considers to the restrictive of competition including: 1) placing unreasonable requirements on firms in order for them to qualify to do business and 2) requiring unnecessary experience and excessive bonding.

We respectfully request CalRecycle remove this requirement that severely restricts competition and jeopardizes FEMA reimbursement.

A44. The reference requirement for the Prime Contractor (the Bidder) is as stated in the IFB: at least one reference for performance on a fire debris removal project performed by the State of California, either as the prime contractor or as a subcontractor. The other two references must reflect work performed on fire debris removal projects performed within California, but not necessarily on behalf of the State of California (for example, work performed for a city or county within California would qualify). For the Bidder's proposed subcontractors, any appropriate experience within or outside of the State of California is adequate.

The debris removal work required under this contract has significant differences from how this work is performed in other areas of the country or for other types of disasters. Because of the urgent need to begin work and desire to complete work as soon as practicable, CalRecycle believes this is a reasonable requirement and necessary to assure that the prime contractor can perform the necessary work correctly and efficiently as soon as possible. CalRecycle also believes this requirement does not excessively restrict the pool of eligible prime contractors.

Because a reference for work performed as a subcontractor for a State of California cleanup can qualify a contractor to bid as the prime contractor for CalRecycle's future fire debris removal projects, CalRecycle encourages contractors not currently meeting the requirement for work in California to seek subcontracting opportunities with qualified bidders in order to gain the necessary experience and familiarity with these operations.

- Q45. Will we be allowed to pre-load trucks with debris?
- A45. No.
- Q46. Is pool water acceptable for dust control? In the debris removal meeting they told home owners no pools would be drained.
- A46. Assume it is not for the purpose of this IFB.
- Q47. Will pools that have not been drained need to be fenced? In the debris removal meeting they led homeowners to believe all pools would be fenced.
- A47. In general, pool areas will need to be fenced. The contractor is providing a bid item for Safety Fence installation at the direction of CalRecycle.
- Q48. CLIN 12 (burned debris and ash) under debris removal per lot has a quantity of 170 tons per lot with 136,000 tons total. CLINs 23, 24, 25 (hauling of burned debris and ash) have 170 tons per lot and 170,000 tons total. The hauling CLINs seem to assume there are 1000 lots, where the loading is for the projected 800 lots. Which is correct?
- A48. 800 lots, see A5.
- Q49. Can 4-8" riprap be substituted for the 6" that CLIN 52c calls for?

- A49. Assume 4-8" riprap for the purposes of this IFB.
- Q50. With the "firenadoes", some of the fire debris has been scattered off of the land owners property; debris could be on private property where there is not a ROE present or possibly on BLM or state ground. How will this material be cleaned up and paid for?
- A50. Material clearly within the burn ash footprint will be removed during this project. The limited amounts of material moved by the "firenado" or other subsequent winds is not part of this project.
- Q51. P. 8 states that a copy of the bidder's minority certifications need to be submitted with the proposal. Do subcontractor minority certifications need to be provided pre-award?
- A51. CalRecycle does not offer an incentive or preference to minority-owned businesses and requires no such certification. On page 7-10, the IFB describes the Small Business (SB) Preference program and the Disabled Veterans Business Enterprise (DVBE) Incentive program. If a bidder or their subcontractors are California certified SB or DVBE then CalRecycle requests that you submit a copy of your certification with the Bid package.
- Q52. Do we need to return the draft sample agreement with the Proposal Submittal?
- A52. No.
- Q53. The Link to the Debris Removal Operation Plan (DROP) found on page 77 of the IFB is not working. Please provide DROP document.
- A53. See A23.
- Q54. Page 30 of the IFB, first paragraph states that CalRecycle will have the option to dictate the number of asbestos and debris removal crews utilized at any given time. The scope states that we are to provide two asbestos abatement crews and one chimney tipping crew within 48 hours. We are to supply 15 debris removal crews within 5 days and up to 35 additional debris removal crews within 21 days. Given the statement where CalRecycle can dictate the number of crews utilized, please provide the required time frame for providing additional asbestos abatement crews and chimney tipping crews should we receive notice.
- A54. See A25.
- Q55. Are there additional maps of the damaged structures? If so, please provide.
- A55. See A26.
- Q56. Page 15 and 16 of the RFP state that the contractor is to include HAZWOPER Certifications for all proposed Site Superintendents and Foremen. Does this mean that HAZWOPER certifications are only required down to the level of site

- superintendent and foremen? In other words, are each of the crew members being supervised (operators and laborers) required to have HAZWOPER Certifications?
- A56. The Contractor is to include HAZWOPR certifications for the superintendent and foremen with the Bid submittal. All workers within the exclusion zone are required to have HAZWOPR certifications.
- Q57. Additional information on truck inspections.
- A57. The Level 1 truck inspector shall be preapproved by the CalRecycle Operations Chief, as reflected in the revised IFB, on page 19.
- Q58. Will CalRecycle allow the combining materials from multiple properties to minimize small loads for trucking?
- A.58. CalRecycle will allow combining of materials for trucking with the following limitations: a). the same material is being combined in the truck (e.g.- concrete with concrete), b). no more than two properties are combined, and c). a visual estimate is made by the consultant's Task Force Leader to document what happened at each property.
- Q59. How many approved ROEs are there?
- A59. Information on ROEs is just beginning to be disseminated to the public. CalRecycle does not know the number of ROEs collected to date.
- Q60. Will the United States Army Corps of Engineers (USACE) be part of this project?
- A60. No. The project is FEMA funded, but will not involve the USACE.
- Q61. Will water be provided by the City?
- A61. The water provider is not known at this time. Contractors are to assume that water will be paid for through this contract as a pass through cost once it is identified, documented by a Change Order.
- Q62. Is there information on concrete sizing requirements?
- A62. Concrete sizing is usually a requirement of the receiving facility. Since none has yet been identified, CalRecycle has no information on concrete sizing.
- Q63. As all items in the bid schedule will not be used for individual properties (i.e. longer haul trucking), the estimates of cost using the Bid Schedule for a Work Order will be artificially high for bonding purposes, meaning we will be carrying more bonding than work performed. Work performed is how we typically pay for bonding. Will this bonding cost with no work be additionally compensated in any way, including Change Order?
- A63. CalRecycle will not pay for any inadvertent cost for bonding that will not be tied to work and those costs should be covered in the unit costs for the contract.

CalRecycle will work diligently to release lots as soon as practicable after they are completed to free up the bonding.

The bonding requirement for this project is tied to Work Orders based on a cost estimate, which are issued to assign a number of lots to the Contractor that are ready for debris clearance. Work Order cost estimates are not directly tied to all of the units in the Bid Schedule, which will be used for contract payment.

Q64. I am writing to formally request a copies of awarded fire debris removal contracts and bid documents of all proposers (to include all bid tabulations/unit rate prices for each line item) submitting proposals for the fire debris removal contracts procured by CalRecycle.
