RE: "Tree Removal Field Management for the Camp Fire", DRR19103"

Addendum No. 1 To the Request for Proposal

- 1. Attached is a list of all businesses who have expressed an interest in the contract to date (Attachment 1).
- 2. RFP p. 12 (California Only Restriction) is amended to read as follows:

For DRR19103 Tree Removal Field Management for the Camp Fire RFP, a new restriction will be placed on Proposers. To be eligible for consideration, Proposers must be certified as a California-based entity. Proposers must complete Attachment J: California Only Restriction form thoroughly, from Sections 1 through 4, or Proposers will be deemed ineligible for consideration for DRR19103. Attachment J and all supporting documents must be submitted along with the Proposal package by the deadline set in Section 1 Overview Process Schedule.

3. RFP p. 57's Attachment J (California Only Restriction) is amended to read as follows:

For DRR19103 Tree Removal Field Management for the Camp Fire RFP, a new restriction will be placed on Proposers. To be eligible for consideration, Proposers must be certified as a California-based entity. Proposers must complete Attachment J: California Only Restriction form thoroughly, from Sections 1 through 4, or Proposers will be deemed ineligible for consideration for DRR19103. Attachment J and all supporting documents must be submitted along with the Proposal package by the deadline set in Section 1 Overview Process Schedule.

Attachment J includes 4 Sections that must be completed entirely by Proposers, including:

- Section 1: Proposers must select one of the two definitions to be considered as a California entity (modeled partially after the Target Area Contract Preference Act).
- Section 2: Proposers must <u>be prepared to</u> provide supporting documents to support their certification
- Section 3: Proposers must also answer a questionnaire to verify their certification as a California entity
- Section 4: Proposers must sign, under penalty of perjury, the certification contained in this form to be considered as a California entity

- 4. RFP p. 93 is amended to read as follows: The following clauses apply to this contract to the extent allowed by California law. unless California law imposes a more restrictive standard.
- 5. RFP Pg.25 is amended to read as follows:
 - k. Task Force Leader (Tower Monitor Log Storage and Processing Yards):
 - Track each truck and weigh-in the tonnage estimate the volume in cubic yards
 of vegetative debris entering and leaving the Log Storage and Processing
 Yards debris management site.
 - ii. Track each truck and **weigh-in the tonnage** estimate the volume in cubic yards of vegetative debris entering final destination wood waste facilities.
- 6. The following questions were received during the Questions and Answers period.
 - "California Only Restriction" and Attachment J
 This is an important contract for the residents and businesses in the area to clean up
 from a devastating fire. We are concerned that the "California Only Restriction" is
 counter to several principles of Federal and State public contract law, and may result in
 withdrawal or denial of Federal funding for the project, to the detriment of those
 California residents and businesses. It may also result in CalRecycle awarding a void
 public contract, which would preclude payment under California law to the contractor,
 even if they performed the work. We request that CalRecycle carefully consider the
 following questions to 1) protect California residents and businesses, 2) protect Federal
 funding, and 3) protect the selected contractor.
 - Q1a) Under the Federal Grantee Procurement Standards (2 C.F.R. sections 200.317 through 200.326), section 200.317 provides that "a state must follow the same policies and procedures it uses for procurements from its non-Federal funds." This is consistent with section 200.318(a), which requires a funding recipient to "use its own documented procurement procedures which reflect applicable State . . . laws and regulations, provided that the procurements conform to applicable Federal law and the standards identified in this part." Please confirm that, although this procurement process may be expedited under the emergency declaration, CalRecycle will be following the same policies and procedures for procurements that are required by the Public Contract Code to avoid any risk to the Federal funding.
 - A1a) The Written Questions are intended to facilitate clarifying the requirements of the solicitation. Questions regarding federal reimbursement or the State's compliance with federal grant requirements are beyond the scope of the Written Questions section at page 4 of the RFP. However, please note, CalRecycle is soliciting this contract under the authority of the Governor's Proclamation of a State of Emergency, dated November 8, 2018, and Executive Order B-57-18, dated November 14, 2018. The Proclamation, dated November 8, 2018, suspended applicable provisions of the Government Code and the Public

Contract code in order to assist local governments and for the protection of public health.

- Q1b) Federal Grantee Procurement Standards, section 200.319(a) (Competition) requires that procurements "must be conducted in a manner providing full and open competition consistent with the standards of this section." (Emphasis added). One example of a process that is contrary to full and open competition is "[p]lacing unreasonable requirements on firms in order for them to qualify to do business." Under California law, Public Contract Code section 10339 provides that no state agency shall draft specifications "that limits the bidding directly or indirectly to any one bidder," and any contract awarded under such specifications is void.
 - (a) Given that CalRecycle had only two responsive bidders in the last bid, one of which cannot qualify under the "California Only Restriction," please eliminate the "California Only Restriction" as inconsistent with full and open competition, particularly since such restrictions have not been used (or found necessary) before.
 - (b) If CalRecycle does not eliminate the California Only Restriction and receives only one responsive bid, please confirm that CalRecycle will reject that bid instead of attempting to award a to the sole bidder that would be void.
- A1b) This RFP is solicited under the authority of the Governor's 11-8-2018 Proclamation of a State of Emergency. This order provides that "applicable provisions of the Government Code and Public Contract Code, including but not limited to travel, advertising, and competitive bidding requirements, are suspended to the extent necessary to address the effects of the Camp Fire." The California Only Restriction will remain in place.
- Q1c) Public Contract Code section 100 states that the Legislature's objectives in enacting the Public Contract Code include to "provide all qualified bidders with a fair opportunity to enter the bidding process, thereby stimulating competition in a manner conducive to sound fiscal practices." This is consistent with the Federal requirement for full and open competition. Please eliminate the "California Only Restriction" as inconsistent with this policy of the Legislature (as well as Federal policies).
- A1c) The Written Questions are intended to facilitate the clarification of the requirements of the solicitation. Questions regarding policy are beyond the scope of the Written Questions section at page 4 of the RFP. The California Only Restriction will remain in place.
- Q1d) Public Contract Code section 10340 requires three competitive bids for any solicitation, except in limited circumstances. The "California Only Restriction" is likely to limit the bidding pool, and there is a substantial risk that CalRecycle will not receive three competitive bids. In particular, CalRecycle cannot satisfy the exception for advertising in the California State Contracts Register because CalRecycle cannot "solicit[] all potential contractors known to the agency" given

that one of the two responsive bidders from the last procurement is known to the agency but would be excluded by the "California Only Restriction." As a result, to protect the potential award under the section 10340(b)(2) exception to the requirement for three bids, please eliminate the "California Only Restriction."

- A1d) See answer A1(b) above.
- Q1e) Public Contract Code section 100 states that the Legislature's objectives in enacting the Public Contract Code include to "eliminate favoritism, fraud, and corruption in the awarding of public contracts." Caselaw makes clear that public entities are required to avoid even the appearance of favoritism in public contracting. If competition is limited by the "California Only Restriction" and the selected bidder is the bidder who has been awarded so many contracts by CalRecycle for fire clean up, it raises an appearance of favoritism. Please eliminate the "California Only Restriction" as inconsistent with the policy of avoiding even the appearance of favoritism in public contracting.
- A1e) See answer A1(c) above.
- Q1f) Federal Grantee Procurement Standards, section 200.319(b) requires that CalRecycle "must conduct procurements in a manner that prohibits the use of . . . administratively imposed state . . . geographical preferences in the evaluation of bids or proposals, except in those cases where applicable Federal statutes expressly mandate or encourage geographic preference." Although this restriction may not apply to CalRecycle as a State agency, we believe the Federal government has made clear that geographic restrictions are heavily disfavored. Please eliminate the "California Only Restriction" as inconsistent with Federal contracting policies.
- A1f) See answer A1(a) above. The California Only Restriction will remain in place.
- Q1g) Some states apply reciprocal penalties on companies whose home states impose geographic preferences or restrictions. By applying the "California Only Restriction," CalRecycle may be barring California companies from bidding for this type of work in other states. Please eliminate the "California Only Restriction" to avoid reciprocal penalties against California companies.
- A1g) See answer A1(c) above.
- Q1h) If the primary concern is employment of California residents, please consider eliminating the "California Only Restriction" and, instead, require that a specified percentage of the employees on the project be permanent California residents.
- A1h) The California Only Restriction will remain in place.

- Q2 The position of "Deputy Operations Chief" appears in the RFP; however, there is no defined role and this position is not listed in bid sheet. Please clarify.
- A2 The definition of a deputy operations chief as it relates to the Contractor has been removed from the RFP.
- Is only one Task Force Leader (TFL) expected to perform all the following tasks per site? More than one TFL may be needed to fulfill all these items because several activities are occurring simultaneously requiring a TFL to observe, direct, coordinate, inspect, document, and communicate concurrently.
 - Read and fully understand the Timber Harvest Plan/Conversion Exemption for the area within which properties that the TFL will be monitoring, prior to monitoring any tree cutting and harvesting;
 - The TFL will accompany the Arborist during their initial property hazard tree assessments.
 - The TFL will document all of the trees that are marked by the Arborist for placement in a database. The Arborist will determine the trees in need of removal, tree number identifier (pre-approved by the IMT), its diameter (at 4.5 feet above ground level), its type, and its GPS coordinates.
 - The TFL will then document all of the collected data, electronically, for each property including number, type and diameter of trees on each APN. The Arborist will prepare a map of the trees, for each property that will be provided to the TFL so that the TFL can place it with the photos and other recorded information about each tree to be removed in a database folder for each property by APN number and available to the IMT by "Box" or other similar and IMT approved database;
 - TFLs will be responsible, along with the Hazard Tree Contractors, to keep hazard trees felled on ROWs and private Properties (APNs) separate throughout all phases of the operation, including felling, hauling processing, and end use. The slash from these two sources of trees must also be kept separate and reported as such, for purposes of FEMA reimbursement;
 - Bring to each property and fully read, understand, and follow the requirements included in the initial site plan and the ROE for that property and/or public right of way from which trees will be cut and harvested;
 - Attend daily Incident Operations Chief/Tree Removal Contractor initiated safety meetings to discuss possible personal and community hazards;
 - Locate any septic systems, valves, utilities and anything else that should not be driven over and have the crew mark/flag the feature;
 - Be responsible to carry out, under the direction of the OC, the Branch Director, and the Division Supervisor, the Timber Harvest Plan/Conversion Exemption requirements for each individual property assigned, and to read and follow the Homeowner's directions, listed on the signed and County approved Right of Entry (ROE) Forms or within the Town or County ROWs;

- The Task Force Leaders shall be the Property owner's point of contact until the trees on their property have been removed and the property has been cleared by the County;
- Inspect each Tree Removal Contractors' truck supporting work on each property and ensure that they each have a safety check placard, issued by the Assessment and Monitoring Contractor's DOT commercial truck inspector teams:
- Inspect, monitor, photographically track, and document the trees cut and removed from the property by type, height, diameter, and number marked on the tree by the Arborist from each assigned property and right of way;
- Provide documentation of trees removed by street, route, and date.
- Document the truck number on which each tree was placed and transported to the Log Storage/processing yard. This documentation shall be in a database or Excel format or other formats utilizing a Survey 123 data collector software including providing their own tablets or other similar electronic type devices;
- Complete and submit to PC and/or any additional governmental agency all documentation that is required for CalRecycle to receive the maximum reimbursement for all covered trees removed and related costs.
- Task Force Leaders must also electronically record the GPS coordinates of all felled trees removed by the Hazard Tree Contractors from the ROW;
- Watch and advise the tree removal crew's activities if any health and safety or environmental controls and/or activities (i.e. controlling dust, water run-off of burn ash, proper donning of PPE, track out, dust suppression etc.) should be addressed during the hazard tree felling, processing, removal, and transport operations;
- Give Site H&S Orientation to Visitors;
- If there are any existing stormwater BMPs (such as wattles, compost socks, hay bales, erosion control matting or other such BMP) on the property, ensuring that they are not disturbed by the tree removal operation;
- Per the Timber Harvest Plan/Conversion Exemption, work with the Arborist to be sure that any environmental and/or archaeological BMPs or AMMs required are in place and noted to the Tree Removal Contractor prior to commencing tree removal operations. The Tree Removal Contractor will not be allowed to work on any property that is not appropriately protected per the THP/CE;
- Fill out and submit daily activity logs per property documenting Contractor labor staff and hours, equipment used, trucks that hauled materials from the property, log storage and processing yards or timber end use locations where trees and any processed materials from that property were taken to directly;
- Inspect traffic control devices and procedures for compliance with the operationspecific traffic control plan;
- Coordinate how trucks will pull in, park, and exit the site with the crew;

- Provide daily oral status reports to the Division Supervisor, the Branch Director, and the OC, or designees, at the end of each day:
- Obtain site clearance/approval from OC once all designated hazard trees have been removed from the property to allow for a final walk through by the OC or designee;
- Coordinate and work cooperatively with the Tree Removal Contractor, the State Forester's Site Inspection Team, the Operations Team's and Tree Removal Contractor's Health and Safety Officers, air sampling consultants (if required), and other Operations Team Members;
- Coordinate and communicate with the State OC and PC on a regular basis or as needed, including reporting any unresolved issues, concerns, or complications that may be occurring with the Tree Removal Contractor;
- Be present during any hazard Tree cutting and removal activities, and related onsite management, which shall take place from Monday through Saturday, up to 12 hours per day if safe conditions allow unless otherwise stated by the OC;
- Perform other requests as directed by the OC and/or the PC;
- Review property owner instructions in the ROE and share information with the tree removal contractor;
- Ensure trucks have the appropriate placards to indicate they have passed inspection;
- Maintain detailed notes of property owner interactions and discussions;
- Coordinate with Federal/State/County/City agencies as needed and keep detailed notes of any interactions;
- Document if property damage occurs;
- Document property conditions prior to/during/after hazardous tree removal;
- If trees are chipped or otherwise processed, document how they will be processed separately as either ROW chipped trees or private property chipped trees;
- Document how each tree that is chipped to be documented as chipped and tracked as chipped materials when taken to the end use facilities; and
- A3 The role of Task Force Leader encompasses many different jobs on this project. Some of the twenty-nine (29) duties shall apply to all TFL positions and other duties shall apply to a select few. It is expected that the more senior TFL's with more knowledge and experience shall have the most complex positions. Below is a list of some of the TFL positions.
 - Right of Entry (ROE) and possible Right of Way (ROW) Arborist TFL will work with the Arborist survey crew to survey and log in data of the trees to be removed.

- ROE Cutting TFL will work with the cutting crews. They will contact and
 coordinate with ROE owners. Ensure boundaries and obstacles are determined.
 Convey important information to the cutting crew. Observe and document
 cutting. Determine where the trees will be hauled to the appropriate wood
 processing site and dispatch the noted trees in each truck. Note that ROE trees
 shall be kept separate from ROW trees.
- ROW Cutting TFL will have the same duties but will not have contact with ROE owner. Note that ROW trees shall be kept separate from ROE trees
- Cleanup ROE & ROW TFL may be needed if the contractor phases work where the cutting is done by one crew and the pickup and cleanup could be completed by another. Coordination of issues and obstacles from the cutting TFL will have to be relayed to the cleanup TFL.TFL will assist the Tree Removal Contractor in dispatching of trucks with trees understanding that ROE and ROW trees. Separate areas of Wood Processing sites or even separate sites all together will be used to keep the ROE and ROW trees separate from each other.
- Wood Processing Sites and End Use Facilities shall have TFL's assigned to log incoming and outgoing trucks. Duties could include, logging in/out of trucks, weight of trucks, visual inspection of loads, and verification of program certified trucks and GPS tracking devices.
- Some TFL positions shall have specific job duties. These positions could include, DOT inspection stations, Erosion Control Specialists, Environmental Specialist, Air Monitoring or other specialties not specified.
- Q4 RFP, Section III Proposal Submittal Requirements (p.7). There are is no reference to alternative proposal submissions in this section or elsewhere in the RFP. Is the customer amenable to an alternative proposal submission focusing on the State's 75 Percent Initiative to include highest and best use of all materials in California?
- A4 The 75% initiative is included as part of the operation. Alternative proposal submissions will be accepted in the submission, as long as the proposer submits a submittal that for the requested bid. The submissions will be evaluated and considered, but there is no guarantee that the alternatives will be considered in bid review or implemented as part of the operation.
- Q5 RFP, Section III Proposal Submittal Requirements Methodology Line item 2 (p.8). This line item requires "a description of the Proposer's experience in providing debris and tree removal management and monitoring services as outlined in the Scope of Work…" Does this experience have to come solely from the Prime Offeror / Proposer or can the Proposer utilize relevant examples from teaming partners?
- A5 The proposed team must demonstrate experience in providing similar scopes of work. Therefore team members that have specific experience that meets the scope of work described in the RFP, such as the RPFs and arborists in assessing hazard trees and meeting similar proposed Timber Harvest Plan Exemptions for post fire cleanups. Team members must be placed in positions that use their proven experience and skillsets. CalRecycle staff are looking for a

- demonstration that the proposed team can successfully accomplish the required scope of work.
- Q6 RFP, Section III Proposal Submittal Requirements Methodology Line item 4 (p.9) This line item requires professional resumes for key project personnel as well as branch directors division supervisors and other project personnel. Is it a requirement for these personnel to be employed by the Prime Offeror / Proposal upon proposal submission? If not, are Letters of Commitment required and how will that impact the evaluation under Qualifications/Resources for this criteria?
- A6 Evaluation of submittals will be based off the entire submission package. Including resumes from key project personnel proposed to be used. These personnel may not be employed by the prime contractor, but are committed to be a part of the proposed team. Letters of commitment can be submitted but may not ensure selection. The evaluation will consider teams with the purpose of ensuring that the selected contractor team will be able to meet the Operation's needs.
- Q7 RFP, Section III Proposal Submittal Requirements Samples of Written Work (p.11)
 This section states "The Proposal must include a copy of a final report from a project
 that is similar in nature to the proposed project" Does this final report have to come from
 a project performed by the Prime Offeror / Proposer or can the Proposer provide a final
 report from a teaming partner?
- A7 Samples of Final Reports from the Proposer and key team partners will be accepted.
- Q8 On previous RFPs, CalRecycle reimbursed GPS units on a daily basis. It appears this bid sheet is requesting a one-time single rate per GPS unit that is used for the project. This is difficult to estimate a cost because there is no way to confirm how long each unit will be used. Will the State consider a daily/weekly/monthly rate for these units instead?
- A8 No. Contractors will need to determine the time and number of units needed for the entirety of the project. The field operations are anticipated to last 9-12 months, depending on many factors outside of CalRecycle's control.
- Q9 Based on previous projects requiring GPS trucks tracking, the use of cell phones for fleet tracking in the project area was insufficient due to lack of cell tower coverage. Will the State require more reliable, commercial-grade, satellite-based, GPS fleet tracking units with real-time mapping software? This built-for-purpose application would provide reliable tracking to support IMT requests and/or requirements?
- A9 The Contractor shall be responsible for installing and monitoring Global Positioning System (GPS) tracking on all haul trucks, street sweepers, and community water tenders. The Contractor shall provide access to the tracking software to the IMT and Tree Removal Contractors. The Contractor must ensure accuracy and reliability of GPS units.

- Q10 Prior to breaking ground for installing address signs or other potential ground-breaking work, please confirm underground service alert notification and ticketing will be mandated by the State as a universal precaution (and as typically required in CIH/CSP-approved Health and Safety Plans). Previous projects have sometimes allowed or requested skipping this urgent and appropriate step due to the emergency nature of this program. Although it is an emergency, protecting underground utilities is imperative for protecting property owner utilities and will reduce potential claims against the State.
- A10 Details for address signs are addressed on page 36 for the RFP. Underground Services Alerts via 811 calls are required for installation as specified in the RFP on page 36 "[t]he Contractor shall post each sign and notify USA 811 before installing."
- Q11 Could the State please clarify the scope of work for the Finance and Administrative services contract and how this will interact with this contract?
- A11 CalRecycle's goal for the Finance & Administrative (F&A) contract is to obtain services and expertise which will serve to maximize reimbursement from FEMA. The F&A Contractor will primarily provide finance & administrative services for the post-award/performance and administrative phases of the other CalRecycle service contracts, including:
 - One (1) Hazard Tree Assessment & Monitoring contract;
 - One (1) Assessment & Monitoring Consultant; and
 - Two (2) Hazard Tree Removal contracts.

The F&A Consultant will be responsible for document development, management and control including

- Contract documents;
- Change orders and work orders;
- Invoices and supporting information; and
- Other project documentation.

The F&A Contractor will review and examine all CalRecycle service contractors' invoice packages prior to submission to CalRecycle.

- Q12 When will the Finance and Administrative Services contract be awarded and expected to start?
- A12 The Finance and Administrative Services RFP was advertised on May 11, 2020. The Notice of Intent to Award that contract is anticipated to be issued on June 15, 2020.
- Q13 While Survey 123 can be used on the front-end for the initial surveying and data capture of hazardous trees, this is not a suitable substitution for an Automated Debris Management System (ADMS) to track and document hazardous tree removal, transportation, and final disposal for FEMA reimbursement. Further, an ADMS system should meet FEMA and USACE guidelines and specifications such as role-based user security, transactional record generation, audit tracking, and a secure system database.

- Is it the intent of the State to use a documentation system that meets the minimum requirements at audit (validated ADMS or multipart paper tickets) to document hazardous tree removal and disposal?
- A13 Yes, it is the intent of CalRecycle to use a documentation system that meets the minimum requirements at audit (validated ADMS or multipart paper tickets) to document hazardous tree removal and disposition and other Operational needs as directed by the Contract Manager. The Assessment & Monitoring Consultant shall integrate data collection with Survey 123. Survey 123 is the software used by multiple entities and will continue to be used to monitor data and information related to the assessment, tracking, processing, and disposition of hazard trees. Trees shall be tracked as they are marked, cut, processed and delivered to the End Use Facilities. If the Proposer utilizes a separate data management system, then that proposer will need to find a solution on how to integrate the data effectively and efficiently. The winning proposal shall include a plan to use and/or integrate the Survey 123 generated database with their proposed ADMS.
- Q14 On page 24, Overall Tasks to be Performed, Item D. Please confirm that "the marking of property boundaries if access to hazard trees that are marked to be cut requires access across such a boundary" would be completed by the Professional Land Surveyor and not the Arborist / Task Force Leader?
- A14 Page 24 D. 3. states "The Task Force Leader shall "h. Be prepared to mark property boundaries if access to hazard trees that are marked to be cut may require access across such a boundary or if the trees may fall across such boundaries after being cut. Mark this possibility on the site map." If there is a dispute of the property boundary then a Licensed Professional Surveyor is required. Refer to page 36, V. 5. "The Contractor shall provide Licensed Professional Surveyor(s), as required by the IMT, to resolve boundary disputes on affected properties."
- Q15 On page 37 it says "The Contractor will not be compensated for delay costs if the Contract Manger, or designee, or the IMT provide twenty-four (24) hours or more advanced notice of delays." Would the State consider changing this to 48 hours to give the contractor reasonable time for demobilization?
- A15 CalRecycle does not express or guarantee the quantities of services or goods specified in the SOW. "Delays" refer to periods of limited duration where work cannot proceed, as evidenced by the table on page 37. Twenty-four (24) hour notice is sufficient for delays. CalRecycle reserves the right to increase and reduce contractor personnel at its discretion. Proposers shall take this under consideration when providing personnel labor rates on their bid sheet.
- Q16 Who on the State's IMT will be authorized to provide direction to the awarded Contractor regarding cost items that are within the Scope of Work of this Agreement? What form of communication will be required for tasking?

- A16 CalRecycle's Contract Manager is the authorized representative of the State of California responsible for administering a contract & monitoring the contractor's performance [State Contracting Manual 9.00]. The CalRecycle Contract Manager or their designees (e.g., Finance, Operations, and Planning Chiefs) are the point of contacts for all contract decisions. Contract directives will be made in writing. The Contract Manager, with the support of the Operations Chief, will prepare Work Orders and Change Orders directing the Contractor's work. Some minor directions may also be given to the Contractor by email.
- Q17 Could the State provide a status report on the progress of the project in regards to number of ROEs, expected number of trees, status of permits, environmental reviews/exceptions, completed timber harvest plan conversion exemptions, etc.?
- A17 CalRecycle does not make any guarantees on the number of Hazard Trees. The number of ROEs is dynamic and the most recent numbers can be found at, offered for reference only, https://buttecountyrecovers.org/private-property-tree-removal-map/. The estimated total number of trees can be found on page 62, 3. Background "To date, it is estimated that over 300,000 trees were damaged in Butte County that require removal." Page 22, "Work to be Performed E", in part states "one Lead RPF, to prepare or direct the preparation of Timber Harvest Plans/Conversion Public and Private Utility Right of Way Exemptions, one for each of the five (5) branches. These Exemptions have been drafted by a State RPF for this Operation, but will need to be reviewed by the Contractor's RPFs. The State has also completed an Environmental Protection Plan (EPP) and an Environmental Compliance Plan (ECP) in support of California State Waivers that are currently being considered by CalEPA and the California Natural Resources Agency. CalOES and CalRecycle have been coordinating discussions with CalFire, the California Department of Fish and Wildlife and the Regional Water Quality Control Board with respect to meeting permit requirements while developing the EPP and ECP. FEMA has also commenced consultations with United States Department of Fish and Wildlife and the National Oceanic and Atmospheric Administration with respect to meeting Federal Environmental requirements. FEMA is also consulting with local tribal nations for the purpose of meeting federal Historic Preservation requirements.
- Q18 Can the State give us a better understanding of their intent or success to extend the emergency period for this disaster event and thereby also extend the NEPA or CalEPA exceptions?
- A18 Page 66 Work to be Performed, G. H. I. and J. all state in the last sentence "under emergency operations." CalOES and the Governor's Office have all confirmed that this operation will be operated under the Governor's Emergency Declaration.
- Q19 Has the initial windshield survey been completed and will the State share the results of that?
- A19 An initial hazard tree survey was completed by CalFire, "Camp Fire CalFire Tree Inventory Sampling", October 18, 2019, which CalRecycle is offering for reference only. This document is shown as "Miscellaneous1" from this link: (https://www2.calrecycle.ca.gov/Contracts/Advertisement/1854). This report presents

estimated numbers of hazard trees along public and some private roads that could fall on public property and/or on private rights-of-way. The estimated number of hazard trees ranges between 280,779 trees to 303,473 trees (lower to higher confidence levels). This study was conducted based on CalFire staff perceived hazard trees located on approximately 17,000 private properties, on Town and County Rights-of Way, and on certain public and commercial properties in both the Town of Paradise and Butte County. No additional surveys have been conducted since.

- Q20 If a subcontractor does not have a major office in California but can demonstrate that it can conduct business within the State by providing valid California Good Standing Certificate would that be sufficient to qualify?
- A20 No, bidders must certify that they meet Attachment J's "California Only Certification" requirements. Proposals without a certification per Attachment J will be rejected.
- Q21 Is this a voluntary tree program or a forced hazard abatement program?
- A21 The public has a choice of using private tree removal contractors for hazard tree removal at their expense or participating in the State Hazard Tree Removal Program. All affected properties are required, by Town and/or County Ordinance, to remove hazard trees or local authorities may initiate a process to abate hazard trees.
- Q22 Please confirm Personal Protective Equipment (PPE) level D will be required for staff working in and around the tree removal cleanup and disposal operations?
- A22 PPE level D is the anticipated minimum level for hazard tree removal. This does not include any PPE needed due to COVID 19, The Contractor's own prepared Safety Plan will need to address these issues. Refer to Answer 30 regarding COVID-19 protocols.
- Q23 The RFP refers to "GPS tracking of commercial fleet". Will the RFP for the tree removal contractor specify that they will be required to use fleet tracking equipment? Additionally, will the cost of lost or damaged equipment for commercial fleet tracking be the responsibility of the debris removal contractor or reimbursed by the State to the Proposer?
- A23 The Contractor for this RFP shall be responsible ensuring the tree removal contractors Global Positioning System (GPS) tracking on all haul trucks, street sweepers, and community water tenders. CalRecycle will not facilitate, mediate, or arbitrate disputes between the Contractor and another entity; nor will it determine responsibility for the performance of work.
- Q24 When will the debris tree removal contractor(s) be awarded and expected to start?
- A24 CalRecycle estimates that the tree removal contractor(s) will be awarded on June 22, 2020. A Notice to Proceed is currently anticipated to be issued between the end of June and mid-July.

- Q25 Per page 11 Samples of Written Work, requires the Proposer to submit a copy of a Final Report from a project that is similar in nature. Final reports for these types of projects can be several hundred pages. Would the State consider allowing for the sample final report to be shared via a URL in the proposal document that will allow access to a website where the final report can be viewed?
- A25 CalRecycle will accept flash drives in place of hard copies for the Samples of Written Work, but cannot accept an internet link.
- Q26 Payment Withhold and Progress Payments and Payment Withhold, refer to the withholding of ten percent (10%) retainage per invoice to be held until all required work is completed. Would the State consider adjusting the RFP language to allow for retainage release on specifics tasks once completed and non-labor project related costs, similar to the revised Progress Payment and Payment Withhold language applied in Addendum 1 of DRR18087?
- A26 CalRecycle will not release early retainage for this operation. Prospective bidders should consider this when planning budgets and cash flow.
- Q27 Can the State please clarify the labor category type and number of resumes required. The RFP provides difference resume requirements on pages 9 and 10.
- A27 The resume requirements listed on Page 9 are for the key project personnel who will be providing leadership for the teams. It shall also include the RPFs and the Arborists. Page 10 describes what type of experience CalRecycle is interested in seeing documented in those resumes listed on page 9.
- Q28 Per page 17 Grounds for Rejection of the RFP, one ground for rejection is "Duplicative staff from other current fire debris removal projects are proposed for primary staff positions within the proposer's team." Can State confirm that staff currently working on large scale tree removal projects within the State for municipalities or public utilities would be considered duplicative staff?
- A28 The statement on page 17 for the RFP refers only to staff working on current fire debris removal projects. If your key and/or primary staff are working on a fire debris removal project, for other municipalities or utilities, at the time of the bid, there is a possibility the bid will be rejected.
- Q29 RFP indicates that a community air monitoring plan be generated for the community locations, but under Environmental Unit Leader / air quality, it states that those staff will also be setting up air monitoring units around working teams in the field felling trees, will this require an additional plan to be generated for the incident?
- A29 Page 33 L ENVIRONMENTAL UNIT LEADER/AIR QUALITY states in part "The Air Quality teams will typically set up continuous operating monitoring stations at key community sites, which will be checked on throughout the day. Additionally, the teams will set up 3 continuous air monitoring stations at up to one-third of the hazard tree removal task force teams, which could add up to approximately 25 task forces in need

- of air monitoring." The air monitoring plan includes both community sites and at tree removal task force teams.
- Q30 Will there be any restrictions or contract requirements dealing with COVID-19, specific PPE, social distancing requirements, etc.?
- A30 Cal/OSHA has issued "COVID-19 INDUSTRY GUIDANCE: Mining and Logging." The guidance can be found at this link: https://covid19.ca.gov/pdf/guidance-mining-logging.pdf. This should be consulted for operations. All Contractors will be required to develop their own health and safety plan and monitoring their own staff safety. Contractors may utilize the CalRecycle Site Safety & Health Plan which includes a section on COVID-19 to inform their health and safety plan.
- Q31 Page 22 of the RFP states "The five (5) sub-areas have been by the IMT". Can the State please provide more detail on this statement?
- A31 The subject incomplete sentence has been removed from the RFP. The five sub-areas generally are defined by regional drainage areas within the fire's burn scar. Two areas are located within the town of Paradise on the east and west sides. Magalia and the burnt area north of Paradise is another. The lower portion below Paradise and areas west are grouped together. Concow and Yankee Hill are considered the last. East/West Paradise will be completed by one tree removal contractor and the other three areas will be completed by a second contractor. Each sub-area will also represent Branches for work organization.
- Q32 Environmental Unit Supervisors are discussed in the scope of work section under section I page 23, but no roles are described for this position. Please provide role requirements?
- A32 Page 66 (4. Work to be Performed I.) states "Provide an adequate number of experienced Environmental Unit Leaders and an Environmental Unit Supervisor, to assist the RPFs in preparing and overseeing the appropriate implementation of each of the Timber Harvest Plans/Conversion Exemptions with respect to the state California Environmental Quality Act (CEQA) and federal National Environmental Policy Act (NEPA) environmental protection requirements, for protection of endangered and impacted species and their habitats under emergency operations." Page 77 S. "The Environmental Unit Leaders and supervisors will be responsible for overseeing and supporting the field work conducted by the Biologists and Archaeologists in addressing the environmental requirements of the Timber Harvest Plans."
- Q33 Under methodology number 3 of the RFP it discusses / references Subject Matter Experts (SMEs), SMEs are not a role or position defined in this RFP. Please provide a role and add to rate sheet if required?
- A33 The term Subject Matter Expert (SME) as listed on page 9 under Methodology refers to personnel who have expertise in certain fields related to the project. A Registered Professional Forester, lead biologists, and lead archaeologists could all be SMEs.

- SMEs with unique skills not mentioned which may benefit the project should be included. Their resume of unique skills will be evaluated and considered for inclusion.
- Q34 Will air sample costs be a pass through with markup for the air samples to be collected from the community and perimeter air monitoring and sampling equipment? If so will a markup line be added to the cost sheet?
- A34 CalRecycle will reimburse the Contractor for air sample laboratory costs on a direct pass through basis. The Contractor may provide a Laboratory Markup not to exceed ten (10) percent of the laboratory analysis fees. The markup is intended to cover expenses associated the packaging, shipping, postage, and other ancillary costs incurred to process the samples. The Contractor shall include the Chain of Custody forms and laboratory reports as supporting documents in the invoice packages submitted to CalRecycle.

The Contractor is required to use qualified analytical laboratory(ies) to analyze analytical samples collected in support of the Hazard Tree Removal Program. Qualified analytical laboratory(ies) shall be California Environmental Laboratory Accreditation Program (ELAP) certified for the respective specific analyses requested. The Contractor shall disclose, the nature, circumstances, and pertinent facts, regarding any affiliation between the Contractor and a laboratory it intends to engage to fulfill the terms of the contract.

- Q35 What will be the required Turnaround Time for air samples collected and will that data need any level of data validation?
- A35 Typical laboratory turnaround time will be 72 hours.
- Q36 Page 12 of DRR19103 introduces a "California Only Restriction" for this solicitation. By description this restriction limits eligible proposers to those that are organized/domiciled in California, or those that have a significant footprint and are able to provide certified payroll or other documentation that establishes the employment of Californians for the past three years. This restriction is extended to subcontractors as well. We are unable to locate reference to such a policy in the California Public Contract Code?
- A36 See answer A1(c) above.
- Q37 2 CFR § 200.319 Competition (Code of Federal Regulations) Prohibits restrictions that restrict competition by (a) (1) Placing unreasonable requirements on firms in order for the to qualify to do business, and (b) prohibits the use of statutorily or administratively imposed state, local, or tribal geographical preference...When contracting for architectural and engineering (A/E) services, geographic location may be a selection criterion provided its application leaves an appropriate number of qualified firms, given the nature and size of the project, to compete for the contract?
- A37 See answer A1(a) above.

- Q38 Based on other information provided in DRR19103 it is evident that the solicitation is dependent on or anticipating financial recovery assistance from the Federal government through FEMA. Violation of 2 CFR's contracting requirements jeopardizes project cost reimbursement eligibility. DRR19103 and the California Only Restriction as is currently written prohibits qualified service providers from offering services in response to this RFP. We request that CalRecycle removes or revises the California Only Restriction to open up competition to all qualified firms that are authorized to do business in the State of California.
- A38 See answer A1(a) above.
- Q39 As of May 1, 2020, the submittal date of the RFP, numerous COVID-19 restrictions and recommendations are in place to protect Californian's from contracting the virus. Due to the rapidly changing conditions associated with COVID-19, is the State of California willing to approve change orders, as needed, for COVID-19 social distancing and personal protective equipment-related items including, but not limited to, additional vehicles if carpooling is restricted, additional lodging if staff cannot share accommodations, and additional PPE including face masks, antibacterial wipes, and gloves, if required?
- A39 Program/Legal The Contractor must consider CalOSHA COVID-19 Guidance on Requirements to Protect Workers on Corona Virus

 (https://www.dir.ca.gov/dosh/coronavirus/Health-Care-General-Industry.html),
 CalOSHA's "Covid-19 Industry Guidance for Mining and Logging," and CalRecycle's Community Health and Safety Plan (attached) when preparing their Proposal Sheets and labor rates.
- Q40 Does CalRecycle intend on providing office space at the TROC for the Contractor? Will the TROC implement social distancing as required at the time?
- A40 If additional office space beyond the space provided in the TROC shall be at the Contractors' discretion and expense. The contractor is expected to follow the safety plan for social distancing and worker safety.
- Q41 Will CalRecycle provide office space for the Contractor independently of the TROC? Or will CalRecycle financially support the Contractor to obtain their own office space?
- A41 If additional office space beyond the space provided in the TROC shall be at the Contractor's discretion and expense. This will also include any necessary storage warehouses for equipment and materials.
- Q42 What is the minimum number of California-only business/professional licenses, certifications, payroll records, residency records, etc. over the three-year period?
- A42 Interested parties are advised that a Proposer's subconsultants or subcontractors, if any, must also meet Attachment J's certification at the time of Proposal submission and through the life of the contract.

- Q43 A bidding company may have hundreds of employees in California so providing files could be a monumental task. Would one representative record for each form type meet the minimum expectation?
- A43 Prospective bidders shall provide information to demonstrate minimum qualifications for all of the expectations set forth in the RFP. Contractors shall meet the requirements of Attachment J at the time of proposal submission and throughout the life of the contract.
- Q44 The RFP mentions air monitoring samples shall be collected; however, there is no mention of a laboratory. Will this be resolved by adding to the bid rate sheet or by use of a change order? Also, should we assume the laboratory must also meet the California-only criteria?
- A44 See answer A34.
- Q45 What is the purpose of having multiple Planning Chiefs and Operations Chiefs? Does the State plan to have specific tasks split between these Chiefs?
- A45 The purpose of two Planning Chiefs and Operations Chiefs is that there will be two contractors completing work on the project; one for the Town of Paradise and one for the areas in Butte County.
- Q46 The position of "Arborist Technician" appears in the RFP; however, there is no defined role and this position is not listed in bid sheet. Can the State please clarify?
- A46 "Arborist Technicians" have been removed from the RFP
- Q47 The position of "Logistics Chief" appears in the RFP; however, there is no defined role and this position does not appear in the bid sheet. Can the State please clarify?
- A47 "Logistics Chief" has been removed from the RFP.
- Q48 The position of "Environmental Unit Leader" appears in the RFP; however, there is no defined role and this position does not appear in the bid sheet. Can the State please clarify?
- A48 Page 77 S. "The Environmental Unit Leaders and supervisors will be responsible for overseeing and supporting the field work conducted by the Biologists and Archaeologists in addressing the environmental requirements of the Timber Harvest Plans." Page 44 has 3 positions listed Environmental Unit Supervisor, Environmental Unit Leader/Water Quality BMPs, Environmental Unit Leader/Air Quality
- Q49 The position of "Planning Assistant" appears in the RFP; however, there is not defined role and this position does not appear in the bid sheet. Can the State please clarify?
- A49 Planning Assistant is defined on Page 33 of the RFP also listed on page 44 and page 76.

- Q50 The RFP states: "All Proposer field staff shall be Occupational Safety and Health Administration (OSHA) certified." What specific OSHA certification is the state referencing? Can the State please clarify the minimum training expectation?
- A50 CalRecycle will strike this sentence and rephrase it to, "All proposer field staff shall be trained at Contractor's expense in CalOSHA tree work safety guidance for the Logging industry the types of activities included in this scope of services, according to guidance issued by the Department of Industrial Relations (available For Reference Only here: https://www.dir.ca.gov/dosh/Tree-Work-Safety.html).
- Q51 RFP page 47, Proposal Scoring Sheet: 2c. "Abilities of assigned staff to conduct the necessary research with proficiency and accuracy and without omission and/or proposed training to be conducted to enhance staff capabilities." Can the State please clarify what this means?
- A51 CalRecycle will strike this sentence and rephrase it to, "Abilities of assigned staff to conduct the required work activities described in the required scope of work."
- Q52 Are Bidders requested to include resumes for 5 or 10 RPFs?
- A52 Section 4 on Page 9 of the RFP requests professional resumes for key project personnel, including ten (10) Registered Professional Foresters.
- Q53 According to the RFP bid sheet, "Land Surveyor" hours are posted at 14,560. This seems high. 14,560 / 2 staff (assuming 10 hour days) = 728 10-hour days. This is roughly 2 surveyors full time for over two years. Please confirm the appropriate number of hours for the "Land Surveyor" role. It appears 4,560 would be appropriate?
- A53 There are five expected Branches for this operation. Each Branch shall have a team of up to two Professional Land Surveyors for a total of up ten Professional Land Surveyors available for the operation. The 14,560 value on the cost bid sheet has been revised to 8,424.
- Q54 Please confirm each DOT Inspector on the two-person crew needs to be independently qualified to perform the inspections; hence, two qualified inspectors per crew?
- A54 All DOT inspectors shall have qualifications to perform the inspections independently. A two-person crew team should be utilized for both production as well as safety for working around and under trucks.
- Q55 Please confirm how many hours are in a DOT Inspector Crew "day." Can we assume 8 hours?
- A55 The DOT inspection location should be set up for full days as directed by the IMT. Typical working days could range from a few hours up to twelve (12) hours.
- Q56 Will CalRecycle have State database specialists available to perform CalRecycle dashboard maintenance in coordination with the Contractor?

- A56 CalRecycle will coordinate with the Contractor to ensure appropriate maintenance of the dashboard.
- Q57 The RFP does not mention stump removal. Does the State plan on having any stumps removed?
- A57 Stump removal is not anticipated to be part of this project.
- Q58 Please confirm that the provided GPS fleet tracking equipment will be replaced or reimbursed by the Tree Removal Contractor if lost or damaged?
- A58 The Assessment and Monitoring Contractor shall issue GPS fleet tracking devices to the Tree Removal Contractors. The Assessment and Monitoring Contractor shall replace lost or damaged GPS fleet tracking devices. The Tree Removal Contractors shall be trained in their operation and use. The Tree Removal Contractors will generally be responsible for lost or damaged devices issued to them. CalRecycle will not facilitate, mediate, or arbitrate disputes between the Contractor and another entity.
- Q59 What is the anticipated lead-time between the start of the Contractor and the start of the Tree Removal Contractor?
- A59 The anticipated lead-time for the Contractor and the Tree Removal Contractor is from 14-30 days. Circumstances may change and the timeline may be reduced to less than 14 days.
- Q60 What is the anticipated ramp-up schedule for tree removal crews?
- A60 Tree Removal Contractor are expected to start with 20 crews each. Twenty (20) for the Town of Paradise and twenty (20) for the surrounding areas in Butte County. It is anticipated that additional crews shall be added in phases. 40 crews for each contractor is the expected maximum. The maximum number of crews is subject to change based on operational needs.
- Q61 What is the maximum number of tree removal crews CalRecycle expects to have working at any one time and for how long of a duration?
- A61 The generally expected maximum of 70-80 crews will be needed. It is estimated that the 70-80 crews shall be needed for 60-90 days. Crews should ramp up and down from this maximum. The maximum number of crews is subject to change based on operational needs.
- Q62 Please confirm who will be responsible for determining load classification at each site in real-time?
- A62 Trees are classified by their origin as either Right of Way trees or Private Property (a.k.a PPDR) trees. The TFL is responsible for verifying the origin of the tree as marked by the Registered Professional Forester directed Arborists. Hazard trees shall be tracked separately from felling to processing to end use based on their origin

- Q63 Is it possible to get a list of the contractors who will be bidding this project as a Prime or General Contractor. We feel we can be of help but do not have the resources to bid this project as a General Contractor or Prime.
- A63 Please see Attachment 1 for a list of interested parties.

All other terms, conditions, and requirements of this Request for Proposal will remain the same.
