1. CalRecycle is issuing Addendum 4 to communicate a revision to the Process Schedule. The IFB has been revised and the corrections where text additions are displayed in bold and underlined and text deletions are displayed as strikethrough text (i.e., strike).
  - A. Section I Overview, *CalRecycle Contact Information*, on page 4 of the IFB is revised and shall read as follows:

CalRecycle reserves the right to amend the term of this Agreement as needs arise.
