OF ARAKELIAN ENTERPRISES, INC. of ARAKELIAN ENTERPRISES, INC. (hereinafter "RESPONDENTS") on September 13, 2005. RESPONDENTS negotiated a Stipulation For Issuance of Administrative Decision (Stipulation) with the CIWMB instead of attending the administrative hearing scheduled for November 16, 2005. Pursuant to the Stipulation dated November 15, 2005, entered into by the the CIWMB and RESPONDENTS and good cause appearing therefore, the following Stipulated Factual Findings and Conclusions of Law are made, and the following Stipulated Order is issued.

## STIPULATED FACTS AND VIOLATIONS OF LAW

The CIWMB and RESPONDENTS have entered into a settlement of the complaint herein, pursuant to which they hereby stipulate to the following facts and violations of law:

- 1. The CIWMB has authority to regulate and conduct enforcement actions regarding Waste Tire Haulers within the State of California under PRC section 42950 et seq. and attendant regulations contained in Title 14 of the California Code of Regulations (CCR).
- 2. RESPONDENTS are responsible for the transportation of waste or used tires by a person not holding a valid waste tire hauler registration from the CIWMB.
- 3. On June 1, 2004, RESPONDENTS first became registered as a Waste Tire Hauler with the CIWMB. The hauler registration Tire Program Identification (TPID) number issued to it was 1323441-01.
- 4. According to CIWMB, on July 9, 2004, the CIWMB Waste Tire Hauler Registration & Manifest Program was contacted by FRANK GUTIERREZ who represented himself as an agent for Art's Disposal Service (TPID 1000255-01) located at 127 Van Norman Road, Montebello, CA 90640. He requested that the CIWMB close the business account for Art's Disposal Service, a registered CIWMB waste tire hauler, showing that the business no longer existed and was no longer liable

 for hauling waste tires. MR. GUTIERREZ stated that the business had been sold to ARAKELIAN ENTERPRISES, INC.

- 5. On that same date, the CIWMB called MR. CHRISTEN WARNER of ARAKELIAN ENTERPRISES, INC. after being informed by MR. GUTIERREZ that ARAKELIAN ENTERPRISES, INC. had purchased Art's Disposal Service. MR. WARNER acknowledged that a transaction took place on or about June 15, 2004. CIWMB staff told MR. WARNER to remove all existing decals from the trucks purchased from Art's Disposal Service and to replace them with the new decals issued to the ARAKELIAN ENTERPRISES, INC. MR. WARNER acknowledged that he had the new registration certificates in his possession.
- 6. A letter of violation was issued by the CIWMB Waste Tire Hauler Registration & Manifest Program on October 4, 2004 to CHRISTIAN WARNER, ARAKELIAN ENTERPRISES INC. for incorrect usage of the CIWMB decals because ARAKELIAN ENTERPRISES, INC. was using A.D.S.'s cancelled decals.
- 7. Pursuant to 14 CCR 18455(b), all waste tire hauler registrations expire annually on January 1<sup>st</sup>. No waste tire hauler renewal application was received by the CIWMB by January 1, 2005.
- 8. On January 13, 2005, the CIWMB Waste Tire Hauler Registration & Manifest Program cancelled ARAKELIAN ENTERPRISES, INC. for failing to renew the waste tire hauler registration for the 2005 calendar year. CIWMB asserts a cancellation letter was sent to RESPONDENTS advising them of this cancellation.
- 9. On March 24, 2005 RESPONDENTS submitted a valid Waste Tire hauler renewal application which was received by the CIWMB Waste Tire Hauler Program.
- 10. During the time that RESPONDENTS were not registered with the CIWMB, RESPONDENTS continued to haul waste or used tires in disregard of the applicable waste tire hauler registration requirements. RESPONDENTS hauled at least 26 loads of waste tires. The following manifests and dates reflect these transactions:

13. RESPONDENTS violated PRC section 42951, which makes it unlawful on or after January 1, 1995, to engage in the transportation of waste tires unless holding a valid Waste Tire Hauler Registration, unless exempted as specified in PRC section 45954.

- 14. RESPONDENTS violated PRC 42956(a), which requires that waste and used tire haulers are to permanently affix decals issued by the CIWMB to the lower right hand corner of the windshield.
- 15. RESPONDENTS state that the above-mentioned violations were administrative errors that did not result in financial gain, that all other regulations were complied with, and that no health and safety violations occurred.

## STIPULATED LEGAL CONCLUSIONS

- 16. RESPONDENTS are in violation of Public Resources Code (PRC) section 42951, which makes it unlawful, on or after January 1, 1995, to engage in the transportation of waste tires unless holding a valid Waste Tire Hauler Registration, unless exempted as specified in PRC section 42954; and PRC 42956(a), which requires that waste and used tire haulers are to permanently affix decals issued by the CIWMB to the lower right hand corner of the windshield.
- 17. The CIWMB's auithority to assess administrative penalties against MICHAEL ARAKELIAN, INDIVIDUALLY AND AS AN OFFICER OF ARAKELIAN ENTERPRISES, INC.; RON ARAKELIAN, JR., INDIVIDUALLY AND AS AN OFFICER OF ARAKELIAN ENTERPRISES, INC.; AND KEVIN HANIFIN, INDIVIDUALLY AND AS AN OFFICER OF ARAKELIAN ENTERPRISES, INC. of ARAKELIAN ENTERPRISES, INC. of ARAKELIAN ENTERPRISES, INC. as a waste tire hauler is set forth in PRC section 42962 (c) and Title 14 of the California Code of Regulations (CCR) section 18464.
- 18. The negotiated penalty of \$5,000.00 (Five Thousand Dollars) is within the CIWMB's discretion pursuant to 14 CCR section 18465.

## **ORDER**

Good cause appearing. THE FOLLOWING ORDER is hereby made:

RESPONDENTS are ordered to pay an administrative penalty of \$5,000.00

(Five Thousand Dollars) within 30 (thirty) days of the date of this Decision.

This DECISION shall become effective December 13, 2005.
