Dear Mr. Burke Lucy:

In response to California Senate Bill 486, Ferring submits the following plan describing our proposed action to support the safe collection and proper disposal of home-generated sharps waste:

Ferring supports the safe collection and proper disposal of home-generated sharps waste through educating patients who use our injectible products about safe sharps management. This information will be offered in the product labeling and online.

1) The following wording will be proposed to FDA for approval to included under the directions for use in the product labeling (package insert and patient package insert) for products usually intended to be self-injected at home:

Disposing of needles and syringes:

To safely dispose of medical sharps, place used needles and syringes in a closeable, puncture-resistant container, such as a red biohazard sharps container. Sharps containers should then be taken to a collection center for proper disposal. Ask your physician or pharmacist or reference our website for more information about safely disposing used sharps.

State Laws:

In some states, it is illegal to throw away medical sharps in household garbage, recycling, and compost bins. Needles and other sharps must be placed in an approved sharps container and disposed of at an approved drop-off site.

Medical Sharps Disposal Information

Improper disposal of medical sharps (including needles, syringes, and lancets) can cause needle-stick injuries and spread infectious diseases. It is important to dispose of needles properly in order to avoid needle sticks at home and protect garbage and recycling workers.

How to Safely Dispose of Sharps

Place needles and other medical sharps in a closeable, puncture-resistant container, such as a red biohazard sharps container. When the container is three quarters full, seal and take the container to a collection center for proper disposal.


