



Recycled-Content Trash Bag Program Summary of Wholesaler Compliance: 2013 Report Year

The following summary is based on Plastic Trash Bag Certifications received by the Department of Resources Recycling and Recovery (CalRecycle) for the 2013 reporting period* and includes wholesalers that:
