

## Recycled-Content Trash Bag Program: Summary of Manufacturer Compliance, 2015 Report Year

The following summary is based on Plastic Trash Bag Certifications received by the Department of Resources Recycling and Recovery (CalRecycle) for the 2015 reporting period\*.

**Compliant Manufacturers:** Submitted self-certification, and met the requirements of the law. **Non-Compliant Manufacturers:** The manufacturers listed in this section are non-compliant due to one of the following reasons: they did not self-certify or respond to CalRecycle's request to certify; self-certified but had insufficient percentage of Recycled Plastic Postconsumer Material (RPPM); self-certified after the statutory deadline date; self-certified and claimed an exemption; stated no sales to California; or submitted self-certification but claimed non-compliance.

\*CalRecycle's database may not include all manufacturers or wholesalers that are subject to the law and who should submit the required certification. **The law does not provide for extensions.** Manufacturers who are non-compliant, or who were non-responsive, may certify for the next reporting year.
