The Agencies in *Table 2: Fiscal Year 2016-2017, SABRC - Non-compliant Agencies* below did not comply with the purchasing requirements for certain product categories; nor provided a reasonable explanation for non-compliance. As a result, CalRecycle is referring each agency to the Department of General Services' Purchasing Authority Unit (PAU). The PAU will send the agency a deficiency notice as part of the delegated purchasing authority renewal process, requiring an explanation as to how the agency will address the SABRC purchasing requirement.
