#### CARE's Executive Director's Message

Third quarter results indicates continuous progress with growth in both gross collections and recycled output. Carpet backing material continues to gain traction and is beginning to contribute to recycled output in a material manner. Start-up of both Fiber Composite Technologies' new plant and the American Fiber Cushion plant are underway. The full fiber demand of both these plants will *dramatically increase* recycled output in 2017. A visit was arranged for CalRecycle to tour the new CLEAR plant operating in Lincoln during November. All these developments are a result of the enhanced subsidy program and grants implemented in the fall of 2015 and are right on schedule in term of impact timing. As a reminder, we still expect to see seasonal fluctuations tied to the annul selling cycle of new carpet.

Efforts are underway to roll-out the assessment increase to 25 cents/sqyd effective January 1<sup>st</sup> using multiple communication avenues.

CARE beat its timing objective to hold face to face visits by 6 months with 50% of all CA-based carpet retailers, estimated at between 1,700 and 2,000. The effort has been extended to contact remaining retailers via additional face to face and phone call outreach.





#### AB 2398 Performance Trends (percentage)



#### Gross Collected PCC Sent Back to Landfill\*




Q3-2016 Gross Collected: 30.0M pounds – 6.5M sent back to landfill Cumulative back to landfill: 106.8M lbs.







ACCRUAL BASIS





### CA Recycling Jobs (FTE\*)





### Drop-Off Site Program Update Q3 2016




## **Program Costs**

- Tipping Fees: 31% of Q3 Total Cost




## Total Cost vs. Pounds Collected

- 2) Approve Processor subsidy\* (\$1,206.2K)
- 3) Approve Manufacturer subsidy (\$1,256.7K)
- 4) Approve Administrative reimbursements (\$1,022.2K)
- 5) Approve Grant payouts (\$713.2K)

Total Payout Q3: \$4,521.4K
