#### CARE's Executive Director's Message

CARE submitted its revised and conditionally approved 5-Year Plan in December and can now report that Plan was *fully approved* by CalRecycle on February 20, 2019.

Data indicated Q4 was the weakest quarter on record for sales performance. This result continues the steep downward cycle for sales into CA. Total 2018 sales were 86M yd2 while the original budget was 90M yd2. This budget shortfall equates to a \$500,000 lower revenue vs budget for the full year. While not insignificant, it does not create a concern as the payouts for subsidies are also below the original budget. Finally, the assessment is set to increase to 35 cents/yd2 effective January 1, 2019. Thus, from a cash flow perspective the fund balance is still strong and fully funded.

Clearly the suspension of operations by a major manufacturer and the loss of a significant, high-volume outlet for PC4 has taken a toll on recycled output in 2018. While we anticipate start-up and demand to come back in Q2 for the manufacturer, there is no guarantee at this time. The good news is that the loss of a major PC4 outlet has now been replaced and should be fully on line for 2019.

The rate of gross collections was up again in Q4 over Q3 driven in part of a growing demand for N6. Our Q4 Recycling Rate (15.6%) was up vs Q3 due in part to record low sales in the quarter. Total expenses for the quarter were approximately \$4.8M or flat vs Q3 with 60% of those funds going to the recyclers along with initiation of Grant Cycle 2 payouts.

CARE is currently working to address all conditions and actions outlined in the newly approved 5-Year Plan.

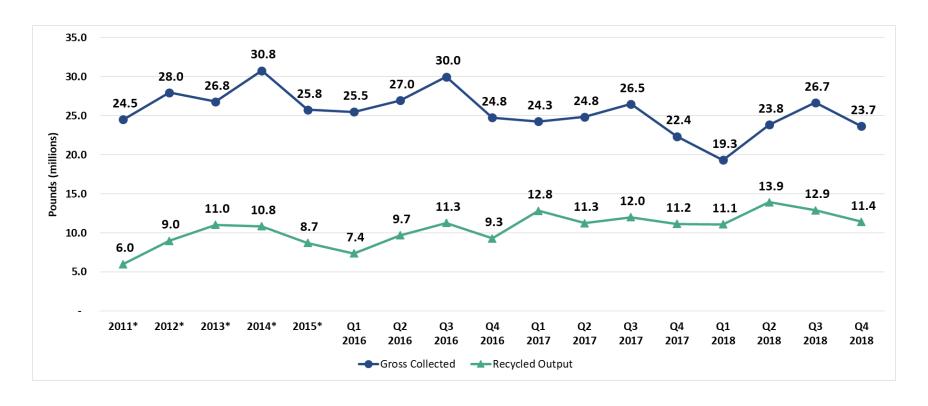

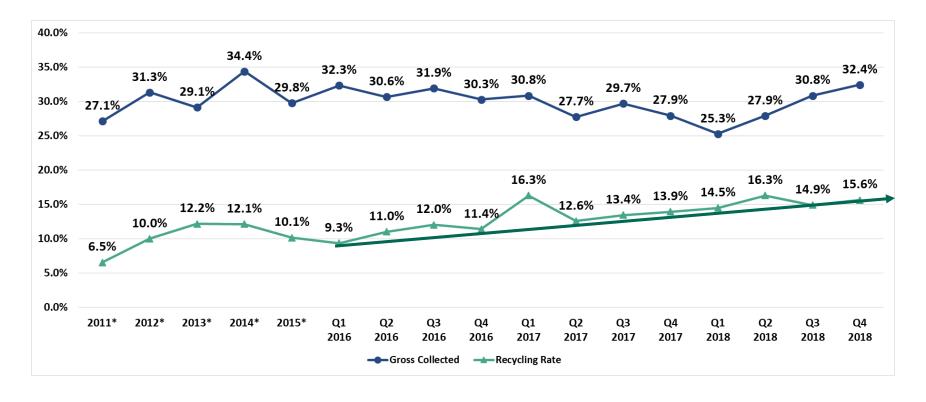
#### AB 2398 Performance Trends (millions of pounds)

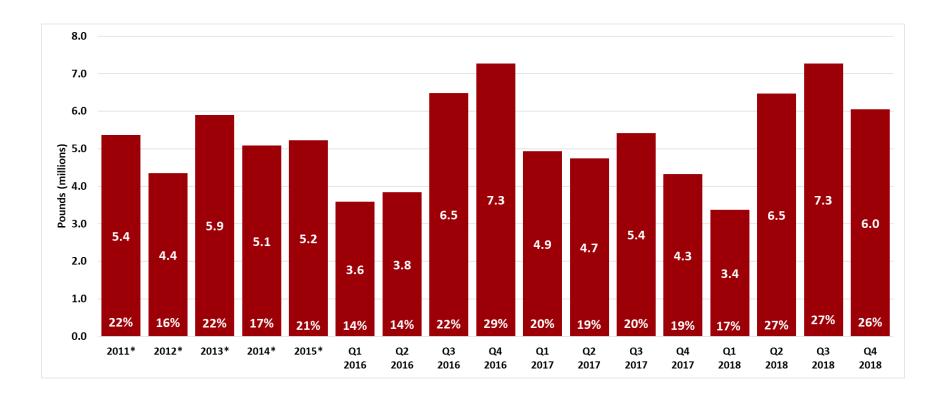
#### AB 2398 Performance Trends (percentage)

Q4-2018 Gross Collected: 23.7M pounds – 6.0M sent to landfill

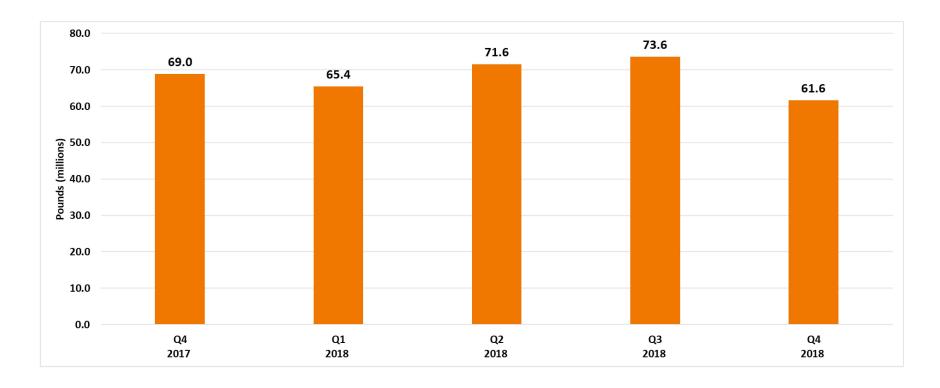
Cumulative to landfill: 156.7M lbs.

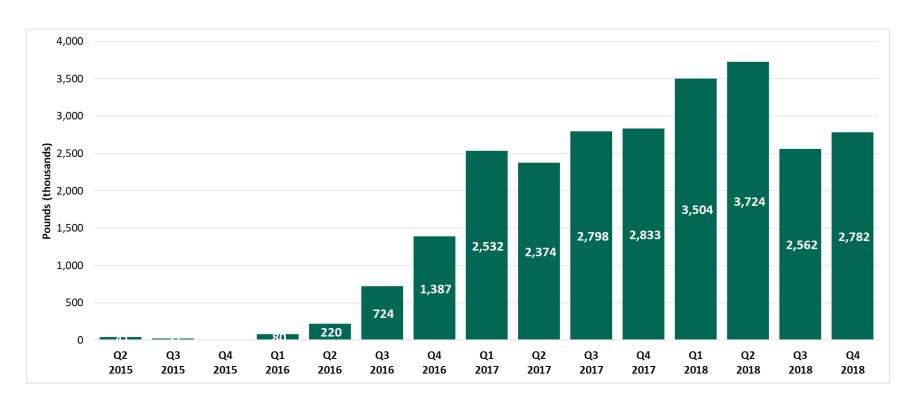

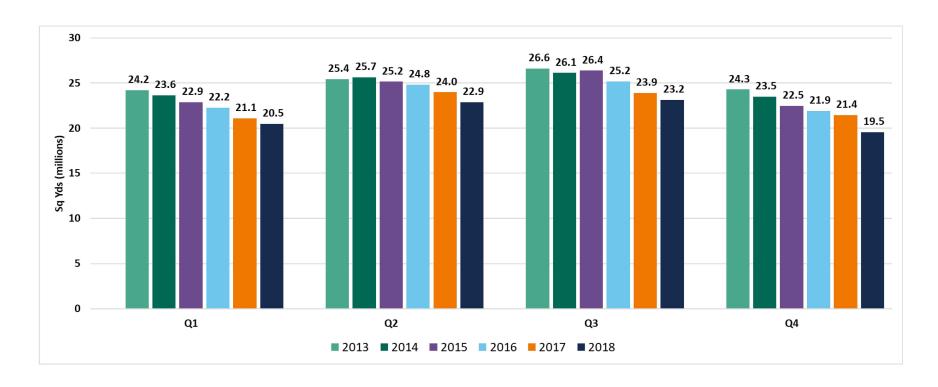

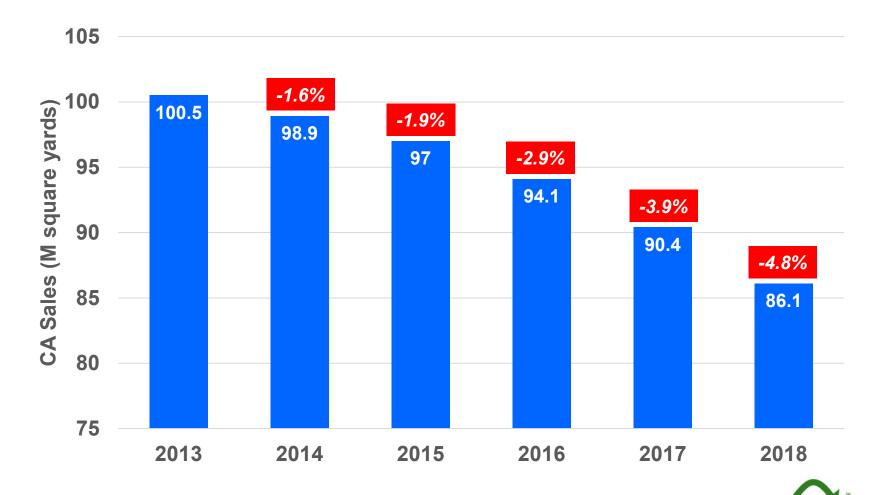


#### Sales by Quarter

CA sales Decline n Rate



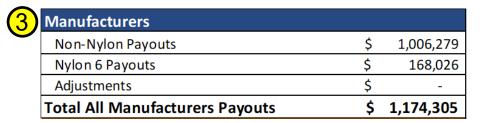

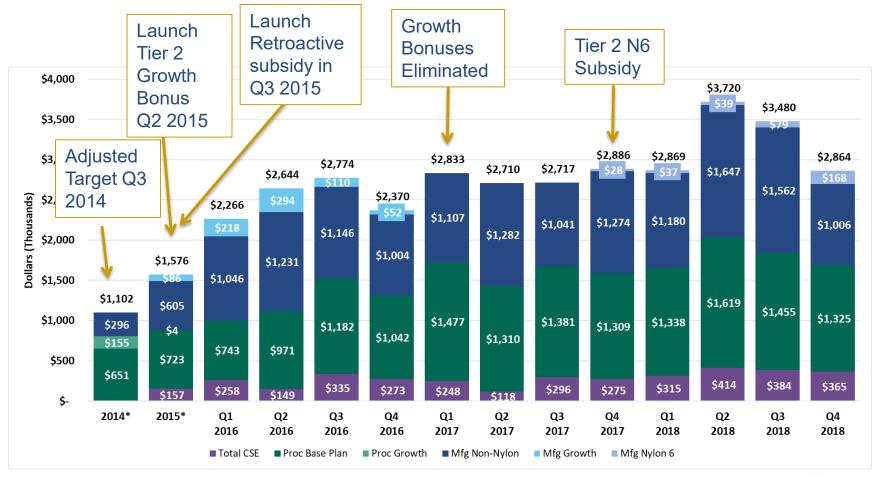

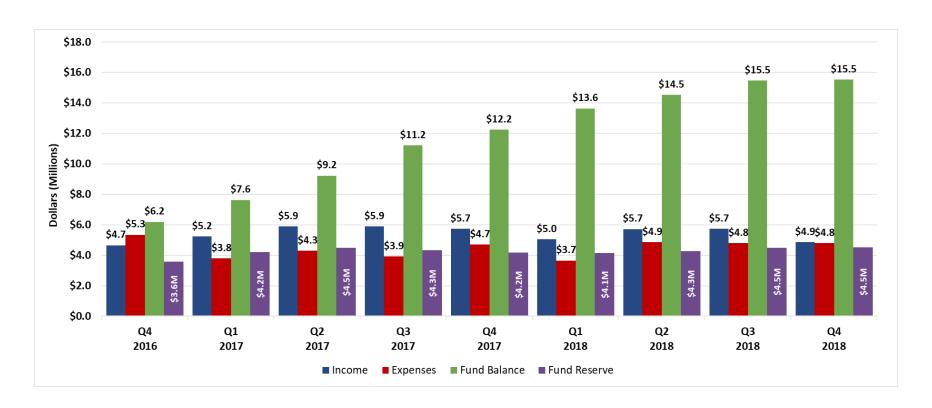

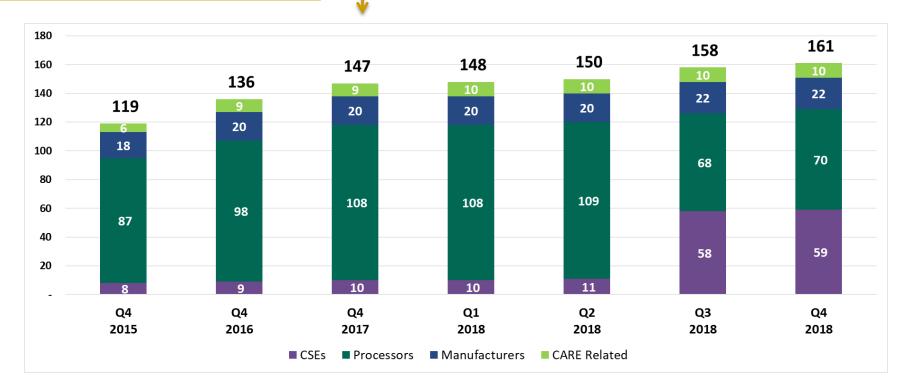




#### CA Employees (FTEs\*)

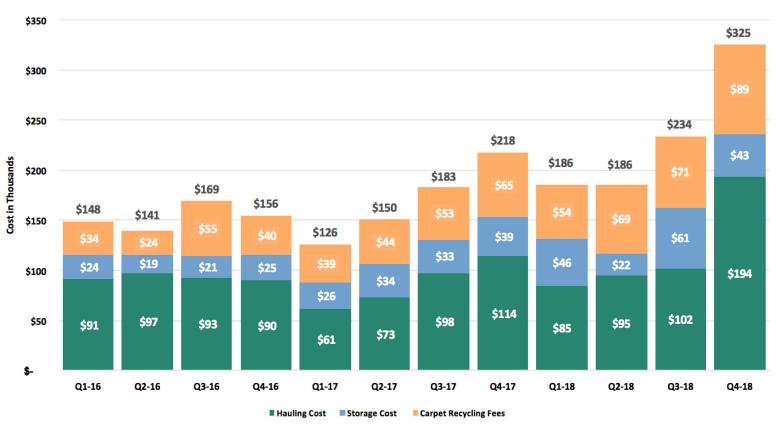


## Drop-Off Site Program Update Q4 2018



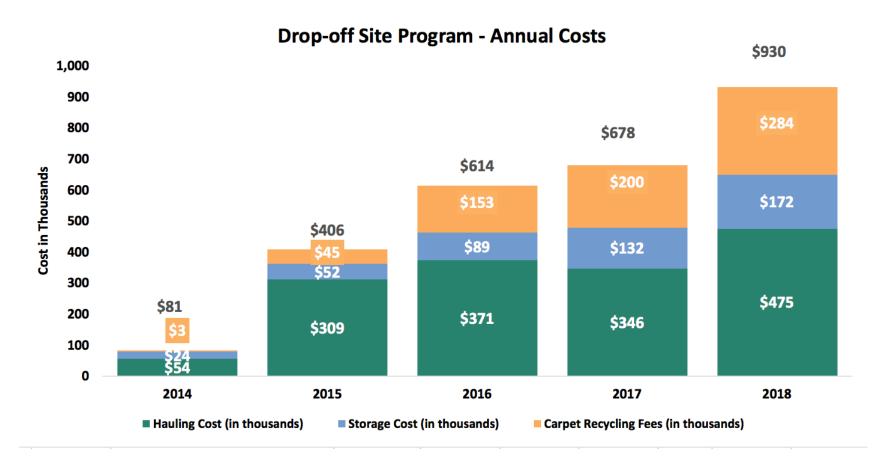
#### **Drop-Off Site Total Program Costs**

#### **Annual Cost Comparison**

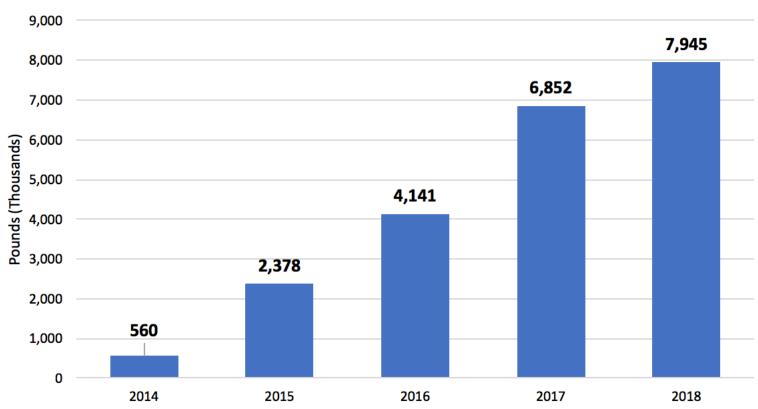
