

AB 7 (8X) (Chapter 5, statutes of 2010) was enacted as an urgency measure to address matters of fiscal solvency for the Beverage Container Recycling Fund (Fund) and was effective March 8, 2010. Due to this legislation, cities and counties were paid at 55% of the total \$10.5 million appropriated for FY 09/10, or \$5.775 million. Each city was eligible to receive a minimum of \$5,000 and each county was eligible to receive a minimum of \$10,000, or an amount calculated by the Department based on per capita, whichever was greater.
