Re: Advisory Committee Recommendations related to the *Draft California Carpet Stewardship Plan 2018-2022 (July 2018)*

As required by the Product Stewardship for Carpets Law (Public Resources Code Section 42970 - 42983), the California Carpet Stewardship Advisory Committee ("Advisory Committee") has received a copy of the *Draft California Carpet Stewardship Plan 2018-2022 (July 2018)* from Carpet America Recovery Effort ("CARE"), the carpet stewardship organization, 30 days before the Plan will be submitted to CalRecycle.

Included in this letter are recommendations to CARE by the Advisory Committee based on the review of the *Draft California Carpet Stewardship Plan 2018-2022 (July 2018)*. As required in Section 42971.1, to the extent feasible these recommendations are to be incorporated into the carpet stewardship plan by CARE before being submitted to CalRecycle.

If CARE is unable to incorporate the recommendations, a written explanation must be provided to the Advisory Committee and CalRecycle. The explanation should detail whether CARE plans to incorporate the recommendations into a subsequent carpet stewardship plan or subsequent amendments to the Plan.

California Carpet Stewardship Advisory Committee Members

The Product Stewardship for Carpets Law (Public Resources Code Section 42970 - 42983), requires CalRecycle to appoint an Advisory Committee to provide recommendations to a carpet manufacturer or stewardship organization and to the department on carpet stewardship plans, plan amendments, and annual reports. An additional appointee to the Advisory Committee is also made by both the Senate Committee on Rules and the Speaker of the Assembly.

The Director of CalRecycle appointed the members to the California Carpet Stewardship Advisory Committee according to the general stakeholder categories recommended in the statute. The committee member from the Senate Committee on Rules has also been appointed. The committee member appointee from the Speaker of the Assembly has not yet been announced.
