As a property owner, tenant or person with vested interest in the project vicinity, please be advised that the County of Monterey, Solid Waste Local Enforcement Agency (LEA), has accepted an application to revise an existing Solid Waste Facility permit (SWFP) from Republic Services for Salinas Disposal, Transfer & Recycling facility located at 1120 Madison Lane, Salinas, CA. The LEA, certified by the Department of Resources Recycling and Recovery (CalRecycle), enforces state laws and regulations at solid waste sites within the County of Monterey, including all disposal facilities.

Purpose of the Meeting:

The LEA shall provide public notice and conduct an informational meeting upon accepting an application to revise existing SWFP as complete and correct, Title 27, California Code of Regulations (T27 CCR) Section §21650. Public notification will be provided in accordance with T27 CCR Section §21660.3, and the meeting will be conducted within 60 days of receipt of the application.

Description of Project:

On February 18, 2020, the LEA received a permit application from Republic Services to revise the existing SWFP for Salinas Disposal, Transfer & Recycling facility located at 1120 Madison Lane, Salinas, CA. Republic Services is revising the existing permit to include the following:

Increase daily tonnage from 500 tons per day (TPD) to 900 TPD

- Add Saturday operating hours of 8:00am to 5:00 pm.
- Change facility name from Salinas Disposal Transfer & Recycling to Republic Services Post-Collection Facility of Salinas

Findings:

The LEA has determined that:

- The requested changes will require a revision of the existing SWFP
- The application meets the requirements of the California Code of Regulations, Title 27, Section 21570, for a revised permit application and was accepted as complete and correct on March 18, 2020.
