Dear Dr. Peoples,

CalRecycle reviewed CARE's document titled "CARE Update on Deliverables and Proposed Changes to CalRecycle," which included requests to extend deadlines for 10 projects or deliverables. Upon consideration of the factors explained in the cover letter submitted with the document, including impacts caused by the COVID-19 pandemic, CalRecycle approves the deadline extensions, as indicated in the attached table.

CARE proposed to submit a revised discards formula and implementation plan (Item 2 of the 2018-2022 Plan Items) by June 30, 2021. While CalRecycle agrees with that approach, staff request that CARE begin utilizing the revised discards formula in its next carpet stewardship plan, rather than during the remaining duration of the current plan. Because updating the discards formula affects how CARE estimates carpet disposal and calculates the recycling rate, CalRecycle has decided to delay implementation until a new carpet stewardship plan is approved. Additionally, pursuant to Public Resources Code section 42972.2(b), CalRecycle shall review and may adjust the recycling rate and program goals based on information included in plans and annual reports, as well as any other relevant information. An update to the discards formula is a relevant factor that CalRecycle will consider in its review and potential adjustment to the recycling rate and program goals.

We look forward to continuing to work with CARE on these projects. If you have any questions, please do not hesitate to reach out to the carpet team at carpet@calrecycle.ca.gov.
