Re: CalRecycle's Completeness Review of UltiMed, Inc.'s Stewardship Plan

Dear Mr. Erickson:

The Department of Resources Recycling and Recovery (CalRecycle) received UltiMed, Inc.'s (UltiMed's) stewardship plan for home-generated sharps waste on July 2, 2021, titled, "UltiMed Sharps Stewardship Plan." The California Code of Regulations (CCR), Title 14, Section 18973.1(b) requires CalRecycle to determine if the stewardship plan is complete and notify UltiMed of its determination within 30 days of receipt.

Staff reviewed UltiMed's stewardship plan for completeness pursuant to the requirements in the Public Resources Code (PRC) section 42032(c) and CCR section 18973.1(b) and found the stewardship plan is incomplete. This completeness determination is separate from the compliance determination CalRecycle will conduct once it receives a complete plan (see CCR sections 18973.1(d)-(f)). Attachment 1 identifies the additional information required, including the location(s) in the plan, where, based on CalRecycle's understanding, UltiMed attempted to meet the requirements (see 3rd column of table for page and section numbers).

UltiMed must resubmit its stewardship plan to CalRecycle within 30 days of CalRecycle's notification that its stewardship plan is incomplete. If CalRecycle determines, upon resubmittal, that UltiMed's stewardship plan is complete, CalRecycle shall have 90 days from the date of receipt of the resubmitted stewardship plan to review for compliance with all statutory and regulatory requirements and approve, conditionally approve, or disapprove. Should it be necessary for CalRecycle to consult with other state agencies, CalRecycle's review time may be extended (see CCR section 18973.1(c)).

Include the recommended funding level necessary to cover the stewardship plan's budgeted costs and to operate the stewardship program over a multi-year period in a prudent and responsible manner, as outlined in CCR section 18973.6(d).
