I. Call to Order--Larry Sweetser, Chair

III. May 26, 2021 Meeting Notes

Committee approved Meeting Notes.

IV. Presentation/Discussions – agenda order modified

A. Discuss Observations Related to COVID

The Chair indicated that future agendas will include discussion of COVID with regard to collection, community cleanups, and illegal dumping. Tedd Ward mentioned cleanups have increased but there are concerns with injuries as there is limited capacity in hospitals. Ted Horton of Sacramento County indicated slowdowns in responding to picking up illegal dumping.

B. Update by Mattress Recycling Council (MRC)

Mike O'Donnell stated he had no news. Larry Sweetser mentioned that the MRC is doing good things, and offered to allow committee members an opportunity to provide input. Ted Horton mentioned that the mattress program is running well for Sacramento County. They switched boom trucks to make it easier. Additionally, the public likes the program. However, statewide people still dump mattresses illegally. Mike offered to speak directly with anyone. Mike explained some hurdles for participating in the program such as administrative burden. Tedd Ward proposed for Del Norte to have a mechanism for managing illegally dumped mattresses. Avneet mentioned that the program is easy to set up including the illegal dumping program.

C. Local Illegal Dumping Initiatives

The Committee heard a brief recap on local programs. Sacramento County is doing a full evaluation of community beautification programs. Their illegal dumping reporting has declined most likely due to pro-active sweeps of hot spots. However, due to sweeps of hot spots, jurisdictions may have created unintentional drop-off spots. Doug asked if there was an increase in self-haul illegal dumping due to people staying home. Olympia Williams from City of San Jose' indicated an increase in residential dumping of self-haul. Frank Foster restored bulky block parties in May for Oakland. CalTrans will shadow this kind of event in order to replicate drop-off events. Peter asked about metrics, Oakland commits to no longer than 3 days. Sometimes sooner. County of Sacramento runs about 5-8 days for pickup. Mario Kalson of Humboldt County asked for ideas for subsidizing community cleanups such as how to have administrative penalties cover costs for cleanups. Tedd Ward stated that the penalties in Del Norte are assessed to gain compliance and the funds are not used for volunteer cleanups.

Doug and Peter offered information on the CRRA Conference and presentations on illegal dumping along with a summary of other presentations at the conference.

D. CalTrans – Overview of Clean California Initiative

Committee heard a presentation by CalTrans staff regarding the Clean California Initiative. Separately, Anand provided an overlay of the program including grants to local governments. Members queried staff at CalTrans on specifics such as free dump days, or using coupons. District 7 would prefer to see more enforcement. Committee members stressed the importance of segregation of recoverable and recyclable materials. The key would be to for CalTrans to coordinate with the local jurisdictions. Frank Foster mentioned how the City of Oakland helps with source separation and processing of debris at their bulky block parties. Tedd Ward asked about how CalTrans will divide resources among districts and how to engage with CalTrans to work with them on cleanup events. Approximately \$290M available for local governments for cleanup and beautification projects. CalTrans encouraged people to attend workshops. CalTrans has Clean California coordinators in each district. Trent Manning mentioned how to find the coordinators via reaching out to Public Information Offices instead. Hammer Sui mentioned that CalTrans has done free dump days based on heavy concentrations of trash, and asked for specific contact information for CalRecycle grant programs.

E. Google - Litter Insights Platform

Three staff from Google, Raina Saboo, Sujit Sanjeev, and Robert Little explained Google's platform to help identify and quantify litter on streets. They provided background on impacts of litter and waste on streets, and the scope and scale of the litter problem. The platform intends to help municipalities solve the problem and take action. Three parts of the problem: Where, How Much, and What is the type. Find the <u>presentation</u> on the IDTAC's Google Drive.

Questions: How often are maps updated? Cadence roughly every six months. However, users can upload additional information. What about rivers and other areas not on streets? Start with street view, and potentially include aerial information from satellite, drones, planes as well as voluntary images uploaded. Are intensity maps translatable to volume and weight? Google is exploring inclusion of features to identify metrics. Google posed several questions to gather input to help inform their platform. F. IDTAC Work Plan—Review progress—Sweetser

- Toolbox status update: CalRecycle staff continue to add information, update
 membership list, and include features in the Program Update section. Under <u>Additional</u>
 <u>Resources for Residents</u>, uses can find the GeoMap in beta form. <u>Stakeholders</u> can also
 access a <u>Google Group</u> for general peer-to-peer discussion. The committee also
 indicated a need to share files quickly amongst themselves. Nate explained how to gain
 access to Google Drive and the <u>folders</u>.
- 2. Work plan Subcommittee Updates Identify updates to <u>online version</u> Subcommittee leaders periodically meet with the Chair and Vice Chair to review progress and identify next steps and goals for the group(s).

- a. Enforcement Alyce Sandbach reviewed the updates from the subcommittee. The group continues to develop a training module for those involved with illegal dumping enforcement. The group solicited stakeholders for interest in joining an enforcement network, akin to a listserv style of communication. Further, the group discussed barriers and solutions to aid in citation authority through camera surveillance and possibly legislation.
- b. *Strategy*(s) for cleanup, prevention, education and reporting, case studies Doug Kobold mentioned they had no new updates.
- Outreach messaging, promotion of subcommittee recommendations/results.
 Veronica Pardo looks forward to using the IDTAC toolbox for messaging the CalTrans efforts.
- d. Standards/Training/Data Larry Sweetser continues to work on the data form, and continues to seek ideas on disseminating it through a free or subscription-based method. Many are interested in testing the form. The Subcommittee is compiling resources for individual cleanups.
- 3. Discuss mission of potential statewide organization. The Committee tabled discussion on a possible statewide illegal dumping oversight entity.

V. Old Business/Updates

A. Legislative and Regulation Updates

Doug Kobold presented status information on legislation related to illegal dumping. Of note, AB 246 (Quirk) Contractors Disciplinary Action Law adds illegal dumping to the list of violations that constitute a cause for disciplinary action against contractors (eff 1/1/22). Other legislation discussed included an urgency bill, AB 332, headed back to assembly for concurrence, then to the Governor for signing and immediate implementation. All the alternative management standards for treated wood waste will be in the bill. AB 659 (Mathis – dumping on private property, now a 2 year bill), AB 684 (Fong) in suspense, and SB 557 (Wieckwski) died in appropriations. SB 1383 implementation continues and the committee may want to watch for impacts on illegal dumping. One other note, the Department of Toxic Substances Control will become a Board. DTSC is looking to develop regulations of auto shredder fluff.

B. IDTAC Business Updates

C. CalRecycle Cleanup Grants – Steve Santa Croce/Rebecca Oliver/Stephanie Becker CalRecycle staff provided updates on CalRecycle's cleanup grants.

Disposal Site Grants

Rebecca Oliver presented the status of the Solid Waste Disposal and Site Cleanup <u>Grants</u> program. Applications for the current cycles are due September 29, 2021. \$500,000 available per public agency. She also discussed the availability of CalRecycle as contractor for cleanups.

Farm and Ranch Grant

Stephanie Becker, CalRecycle, presented information on the <u>Farm and Ranch Cleanup and</u> abatement program

- Provides funding to clean up illegal dumping on California's rural lands, farmland, forest lands, and urban gardens, appurtenant easements, homeless encampments, certain illegal marijuana grows, tire piles
- Eligible applicants: cities, counties, resource conservation districts (RCD), federal tribes (partnerships are encouraged)
- Receives \$1M annually, with \$200K per applicant, capped at \$50K per site Stephanie Becker <u>Stephanie.becker@calrecycle.ca.gov</u> is available to do presentations, and encourages interested parties to sign up on the listserv for updates see <u>listservs</u> managed by CalRecycle.

VI. New Business

A. Additional Items/Updates

Doug asked that we update our membership to show Ted Horton representing Sacramento County Solid Waste. Also, Doug asked that we share the current vacancies — County Engineers, CCDEH, and Industry. Tedd Ward indicated that the Recycling Commission would like the IDTAC to help develop a policy statement on illegal dumping. The Commission provides policy documents that the legislature or CalRecycle can work with. Further, a policy proposal on illegal dumping would aid the work of the commission. Larry mentioned that the Strategy or Outreach Subcommittees could work on this subject.
