10:09:48:Presenter: To have a significant impact on California's recycling rate moving forward in 2020, Californians generated about 77.4 million tons of waste materials. 44.9 million tons went to disposal.

10:10:02:Presenter: In disposal, related activities are roughly 4 million ton reduction from 2019. I left us with a 42% recycling rate for 2020. That's up from 37% in 2019, but as director Wagner.

10:24:57:Presenter: An emergency regulation was approved to amend California Code of Regulations, Section 2975 that changes how the reasonable financial return is calculated for calendar year 2022.

10:25:09:Presenter: This change will provide stability to the processing payment calculation by ensuring the reasonable financial return stays at a constant 10%. 10:25:23:Presenter: And the latest Budget act, SB 170 of 2021 authorized \$10 million for quality incentive program pig quality.

10:25:32:Presenter: Incentive payments to curbside programs and certified drop off collection programs to increase clean loads of PET containers.

10:25:46:Presenter: Starting July 1st, 2021 through June 30th, 2022, Cal Recycle may make quality incentive payments for PT beverage container loads that contain a maximum.

10:25:53:Presenter: Of 2% of PT thermoform containers and other contaminants as determined by calrecycle.

10:29:12:Presenter: Policy director Zoe Heller is back now with how Calrecycle gathers key information on waste and recycling Zoe.

10:29:22:Presenter: So earlier I talked about the state of disposal and recycling report, which relies heavily on data reported to calrecycle by jurisdictions and other facilities. 10:29:35:Presenter: Another major tool we use our waste characterization study. Take

a look at this short video to see how examining what's in our trash can. Help us make less of it. Truck my truck California landfill scales show the magnitude of the problem. 10:29:40:Presenter: We dispose 40 million tons of waste a year.

10:29:43: Presenter: But to solve California's trash crisis.

10:29:57:Presenter: We have to know what's in the trash. We need to understand what materials are in the waste stream so that we can then look at how do we target these materials? Waste characterization studies. Pick apart what we throw away.

10:30:11:Presenter: It's how we know food, yard and other planet warming organic waste makes up over half of our trash. The only way that we can actually tell is by having sorting cruise take apart the samples and tell us how much organics is left. 10:30:24:Presenter: Characterization is how we know packaging makes up about a quarter of what we throw away. Understanding what the composition of plastics and packaging in landfills right now help us figure out what material types and packaging are particularly.

10:30:37:Presenter: Problematic and waste characterization helps us see trends like how the pandemic changed our trash, personal protective equipment that is now a new material type that we have included incorporated into the study. People are interested in doing more shopping. 10:30:51:Presenter: Home and you kind of see that in an increasing hard word to do the study. Coward cycle hire skilled specialists to separate waste. Once our vehicle surveyor alive gets a sample, a load selected, they come over and they dump it over here from there.

10:31:00:Presenter: We pull out our 200 pounds process it. We take our photos. The garbage is then sorted. Categories, categorized and recorded.

10:31:14:Presenter: And got it. We record the weight on a digital tablet with a data management platform that we've got of the various reports on what Californians throw away. Waste characterization is the only one to get detailed about what is in our garbage.

10:31:28:Presenter: Right now power cycle is conducting its six statewide characterization study. There's a big focus in this study on packaging and food waste. The 2021 study takes a deep dive into trash at 30 facilities in 19 counties.

10:31:41:Presenter: Throughout the state, making sure everybody's trash is represented in a study of this scale, California uses the data to set benchmarks for progress, then measures the outcomes of policy and laws. 1383, I think is probably the biggest.

10:31:54:Presenter: Current example in the statewide organic waste law, the legislature set a target for California to cut organic waste 75% by 2025. Waste characterization data from 2014 was used to establish.

10:32:07:Presenter: The baseline, how much are we reducing by 75% in 2018? We had new numbers. We went from about 67% organics to about 56% organics, which was a pretty big shift and we can.

10:32:22:Presenter: Look at potential reasons why that may have occurred and one is mandatory. Commercial organics recycling was impactful as California moves to disrupt the endless stream of single use. Trash polluting our neighborhoods and warming our planet.

10:32:35:Presenter: Waste characterization studies are an important tool to identify the problems and measure change. We want policy that is based on sound science and good information. The circular economy is all about making sure.

10:32:49:Presenter: The material that you bring into the system can be sustained perpetually, so you minimize raw material that you bring in. You maximize reuse and recycling, minimizing waste to maximize.

10:32:57:Presenter: Our economy and moved California closer to a zero waste future with less trash pollution and more green jobs.

10:33:20:Presenter: We'll have data to share with you from the 2021 waste characterization study next year, and we look forward to presenting it in an upcoming public meeting.

10:33:29:Presenter: K So switching gears on the next two items represent the ferry first stewardship plans for the new statewide pharmaceutical and Sharps program.

10:33:43:Presenter: Governor Brown signed Senate Bill 212 in 2018 enacting the statewide pharmaceutical in Sharps Waste Stewardship Act in establishing the very first statewide statewide stewardship program for both covered drugs.

10:33:46:Presenter: And home generated sharps waste in the country.

10:33:54:Presenter: Calrecycle was required to establish regulations for these programs that became effective on January 7th, 2021.

10:34:09:Presenter: Similar to other stewardship programs that color cycle overseas for mattress, carpet, and paint, color cycle is required to review and approve stewardship plans. Annual budgets and annual reports from manufacturers or stewardship organizations.

10:34:11:Presenter: And provide oversight of the enforcement of the law. 10:34:25:Presenter: Because of pre existing and complex regulatory framework for these products, stewardship plans must first be submitted to the California State Board of Pharmacy and any other state agency with areas of authority relative to the stewardship.

10:34:25:Presenter: Yeah.

10:34:37:Presenter: By January 7th, 2022 covered drugs in Sharp, sold or offered for sale in Orinda, CA. Must be covered by an approved stewardship plant.

10:34:46:Presenter: A manufacturer can either develop and submit a stewardship plan individually, or join a nonprofit stewardship organization that acts on behalf of the Group of Manufacturers.

10:35:00:Presenter: A manufacturer or stewardship organization must design and operate a statewide stewardship program for the collection and proper disposal of covered drugs or home generated sharps waste at no cost to consumers.

10:35:12:Presenter: Stewardship programs for covered drugs must establish collection receptacles for consumers to take their unwanted medication with an option for mailing back unwanted medications in some circumstances.

10:35:24:Presenter: Stewardship programs for home generated sharps waste allow consumers to mail used or unwanted sharps waste in a secure sharps mailback container.

10:35:32:Presenter: Met Project is the stewardship organization that represents over 300 covered entities in its drugs plan. In over 40 covered entities under Champs Plan. 10:35:37:Presenter: Med projects submitted its plans to calrecycle on September 14th. 10:35:51:Presenter: Counter cycle found both plans to be complete on October 11th. Calrecycle was required to approve. Conditionally approve or disapprove the plans by December 13th. Our staff reviewed the plans to determine whether.

10:36:00:Presenter: All statutory and regulatory requirements were met and found that both have met projects proposed to her. Chip plans were substantially compliant with the statutory requirements.

10:36:11:Presenter: However, several components of both Med projects plans require additional information and actions by Med project for CALRECYCLE to determine the plans fully compliant.

10:36:18:Presenter: Therefore, met Project stewardship plans were conditionally approved by the director on December 9th, 2021.

10:36:33:Presenter: Approval of the plans is contingent upon Med project providing by January 10th, 2022. A letter committing to, revise and resubmit its plans to meet the conditions specified in the respective requests for approval documents.

10:36:51:Presenter: Carrie Cycles conditional approval of these stewardship plans means that met project may begin implementation of covered drug in home generated sharps waste programs.

10:36:59:Presenter: Med project must fully implement both plans by September 5th, 2022, which is 270 days from plan approval per statue.

10:37:14:Presenter: We'd like to thank those stakeholders who provided comments during the public comment period that we held in September. Comments were received from industry retailers, local governments in the environmental NGO community, the majority of which supported approval of the plans.

10:37:16:Presenter: Is aligned with the department's finding.

10:37:27:Presenter: It's important to the department that the public has an opportunity to provide comments on these important new programs and all the comments received were carefully considered during the department's evaluation.

10:37:33:Presenter: I also want to mention that review is currently underway for three additional stewardship plans submitted to CAL Recycle.

10:37:47:Presenter: Ultimate and independent sharps manufacturer submitted a plan to come submitted a sharp stewardship plan to the department on October 11th. Calrecycle found ulti med plan complete on November 10th and is a deadline.

10:38:00:Presenter: January 10th 22 to approve. Conditionally approve or disapprove the plan the drug take Back Solutions Foundation is a stewardship organization that submitted separate plans for covered drugs and sharps on November 19th.

10:38:10:Presenter: Calrecycle found the foundations plan complete on December 20th and has a deadline of February 17th 22 to approve, conditionally approve or disapprove the plans.

10:38:19:Presenter: Note that Calvary Calvary cycles approval deadlines are anticipated as those dates may be extended pending the need to consult other state agencies.

10:39:20:Presenter: Of post consumer recycled content in those products so you can think of these as different recycling fees for different carpet types based on what it costs to get them recycled.

10:39:30:Presenter: If a certain carpet material requires a higher subsidy to incentivize recycling, then it makes sense that material should have a proportionally higher consumer fee assigned to it.

10:39:34: Presenter: To address this statutory requirement.

10:39:49:Presenter: Care proposed a system of differential assessments based on whether the carpet is broadloom carpet as in rolled out or tile or carpet tiles, and also whether it contains greater than 10% post consumer recycled content.

10:40:03:Presenter: On August 27th of this year, the director content conditionally approved cares proposed system of differential assessments as an amendment to its 2018 through 2022 plan contingent upon care making specified.

10:42:22:Presenter: Cara cycle must publish that initial list of approved for food service packaging by March 6th of 2022. Though we will continue to accept applications and Dad approved items on an ongoing basis.

10:42:35:Presenter: To streamline the application process for manufacturers, calrecycle staff identified foodservice packaging materials that are known all ready to meet a subset of the recyclable or compost able criteria.

10:43:51:Presenter: Electronic waste these regulations finalized the emergency regulations approved by the Office of Administrative Line May of 2018, RE adopted in May of 2022 and set to expire in May of 2013. Readapted in.

10:43:54: Presenter: May of 2020 and set to expire in May of 2022.

10:44:08:Presenter: Power cycle initiated a 45 day comment period in September and in October we held a public comment and a public hearing and received no public comments. This is a issue that's been thoroughly discussed in the past.

10:44:11:Presenter: Are the regulations split this single?

10:44:25:Presenter: Covered electronic waste recycling. Payment rate paid to recyclers into two separate rates. One rate for cathode ray tube. Electronic waste, which are declining in volume and another.

10:44:28:Presenter: Different rate for non CRT?

10:44:42:Presenter: Electronic waste, flat screen televisions and laptops which are on track to become the majority by volume of CEW collected and recycled in this program. We need separate rates because.

10:44:56:Presenter: Non cathode ray tube devices are lighter, contain lower value materials, and they're harder to dismantle, so the recycling caught sort of processing costs are higher currently to standard combined.

10:45:09:Presenter: Rate is \$0.66 per ton for CRT CWND, \$0.87 per pound of non CRT CW right? So you can see that difference is intended to make.

10:45:16:Presenter: From the difficulty in the lighter weight recycling those non CRT. 10:45:27:Presenter: He wastes staff recommends adopting the proposed regulations. Calrecycle will then submit the regulatory package to the Office of Administrative Law for approval and for publishing.

10:45:41:Presenter: Sticking with E waste for a moment. Payment rates in the covered electronic waste program aimed to cover the average net cost of collecting and recycling covered electronic waste discarded.

10:46:53:Presenter: This item is delegated to me and I have already approved it, so get to work on those reports.

10:47:09:Presenter: Moving on to state agency programs. Uhm, i. I've always felt that state agencies need to need to walk the walk and set a good example. And Calvin cycle works very hard to make sure that.

10:47:22:Presenter: Uhm, that state agencies and large state facilities are doing exactly that every other year. Our team reviews state agency compliance with requirements related to 50% landfill diversion.

10:47:35:Presenter: Mandatory commercial recycling. Mandatory organics recycling as well as other requirements for state agencies to provide adequate containers, signage, education and staffing to help meet.

10:47:48:Presenter: Waste and recycling targets. During this year's review cycle, Calgary cycle found that all the three state agencies were fully implementing their waste diversion programs. This is a very good sign.

10:48:02:Presenter: That we are ready for 13 SB 1383 organic waste recycling and food recovery requirements that take effect in 2022. I want to share a few examples of some of the great practices that we've found.

10:48:15:Presenter: The Department of Consumer Affairs has a Verma composter bin at headquarters since May. The agency reports composting hundreds of pounds of food waste to reduce disposal and eliminate climate emissions.

10:48:28:Presenter: Also, providing a fantastic source of free worms to any fishermen who have access to the bin, Cal Sters started a organics recycling program back in 20. 10:48:42:Presenter: 2009 A which features green bins for organic recycling.

10:48:44:Presenter: Where on boarded into the organization.

10:48:58:Presenter: Those are some great examples of what we like to see. There are three agencies with gaps in their mandatory commercial organic recycling programs. That was the Coalinga State hospital, the CSU chancellors.

10:49:08:Presenter: Office and Caltrans District 7 but all three of those agencies responded with plans that will address those gaps and counter cycle is going to continue to monitor their progress.

10:49:24:Presenter: We also note that five state agencies failed to meet their state agency by recycled campaign. Recycled content purchasing requirements, so this is the California Correctional Institution in California State Prison.

10:50:59:Presenter: 26 caliber cycle has the authority to conduct these at any time. Reviews to make sure that cities and counties are in compliance with these programs. 10:51:13:Presenter: During staff's annual review of each jurisdiction, calrecycle found that unincorporated Butte County and also the city of Oceanside were implementing their programs. However, there is still a high level of non compliance among regulated. 10:51:15:Presenter: Businesses.

10:51:29:Presenter: And if you go to the RFA linked in the agenda, you can find a summary of how each jurisdiction plans to address this. These gaps up some of the solutions include adoption of an enforcement.
