Subject: 2021 Plastic Beverage Container Virgin and Postconsumer Resin Report

Beverage manufacturers regulated by the California Beverage Container Recycling and Litter Reduction Act are required to report the amount in pounds and by resin type of virgin plastic and postconsumer recycled plastic annually sold in California (see Public Resources Code (PRC) §14549.3). This report is due to the Department on or before March 1 of each year.

In publishing the 2021 reports, effort was made to make common responses consistent. If a beverage manufacturer indicated that they did not manufacture the bottles and did not know the plastic content of the bottles, "unknown" was used in the summary report.

Attached is a summary of the information received from beverage manufacturers who submitted a Plastic Beverage Container Virgin and Postconsumer Resin Report for Calendar Year 2021.
