First off, I would like to go in, too.

Go some basic information that you will need to do the ear.

1:49

First off, everyone on the outside who needs access to the database, needs to both be a contact for us, as well as have a web pass account created.

If you already are a contact and you can't get in, please contact logic at cal recycle dot CA dot gov or fill out the Contact Change Request Form, and we'll be able to add you through that.

2:12

When you are added as a contact, if you do not have a web pass already, it will send you an invitation to create one. If you already have a Webtest, it will let you know that access has been granted to logic using your existing web apps.

2:30

The webpage that is currently on the screen is an older version. Some of you who have been to our website before have noticed that various pages as well as the whole site has been going through a large upgrade, and pages related to the annual report.

Webtest and some other things will be getting an update in the next couple of weeks. but the basic information remains the same. You need to be a contact in the system and have a web test to be able to login.

For those of you who are listed context for the annual report, and two weeks, you'll receive a message or two weeks, about less than two weeks on June 15th. You'll receive a message that will have links to login and other information. Basic overview of some of the things that are different this year.

But if you ever need to log in, you can go to cal recycle dot CA dot gov slash ...

central slash my logic and from here, there's a logic system sign in.

3.30

You can press that, for the purposes of this webinar and training.

3:38

For the purposes of this webinar and training, we will be using our staging system. And so you'll see that when we're in this version of it, it's all going to have a yellow band across the top. But I just want to emphasize what we're showing is not final data.

3:53

Another this is real, it's all gonna be wiped out after we're done with the webinar. So anything that's being entered in here, as well as some of the information you'll see on the screens is not vital.

And don't take it as such, cleats, so first up after you login.

4:15

Cool.

4:16

Be prompted for a password.

And then after you login, it will take you to the county and jurisdiction affiliation screen on which you will see any jurisdictions that you have viewing or editing rights for the year on the website.

4:34

As you can see, for testing purposes, my account has a number of different jurisdictions aside, but for the demonstration, today, we're going to be using Los Angeles unincorporated.

4:44

And once again, this is not final data. Nothing you're going to see is actually happening in there, and it's all just test stuff.

4:57

On this launch screen here, you'll be able to see some old information for the ... system, that track disposal.

5:04

Please note the disclaimer here that all all disposal reporting is now done in the RDS, the Recycling and Disposal reporting system, and is separate from logic. And that data is ported over to help fill out the information and the disposal calculator in the year when we get to that point.

5:23

Couple of other nifty things on this page is that you can get access to previous years, ear summaries, going all the way back to 2000, if they exist that far.

5:33

And you can also see venue and summary, venue and event summary reports, as well as a link to the previous years diversion program notes.

5:46

From here, you can download any note for any program for any year going back as far as you want.

5:53

And if it's taking a little bit too long, we might skip that, but, basically, it'll open up this screen. It'll show all the notes with a couple of filters, and you can export it to Excel if you want to. Check, That did all the stuff.

OK, so with that, that is the basic introduction info up. There's the notes screen, so, yeah, this is these are all the diversion program notes. You can show all, you can export to Excel, and you can filter them for anything you want.

So, with that, I would like to move on and introduce our first new guest star for this year, Andrew Parish, who has been working extensively on this sort of year rebuild as it were. And he's going to be able to walk you through each of the new sections and what you'll be doing each of them. So, Andrew, please take it away.

OK, Presenter.

All right, there you go. Thank you, sir.

7:26

OK, I'm going to turn my webcam off to the screen's a little bit bigger here.

7:30

OK, I just wanted to go over kind of a little bit more.

7:34

Chris already touched on it, but a little disclaimer here on the PowerPoint.

7:40

So kinda calling this, the beta version, so what we're presenting is a beta version, We still have some tweaks that we're actively working on to kind of re-order stuff. Some type of changes, Tidal changes, an additional tool tips. So what you see today is not final. However, what is finalists kinda structure, how it works, how you fill it out. But I just kinda wanted to note that in the beginning, so if you look at this recording once, we do post it and once we process it and have everything ADA compliant, we'll send out a listsery message of where you can find this webinar and all these future. restructured your webinars on our website.

Then if you have any questions, you can always contact your lam representative and they'll be able to help you find these things.

OK, just want to switch over to Dan.

8:42

OK, that's my report showing up on the screen, just to make sure or the ear OK. Perfect, OK. So before we get into kind of the function of the report for this upcoming year cycle, the information that's going to be due in the Electronic Annual Report by October first, 2022, you may submit earlier if you choose will be AB 939. So that'll be your source reduction recycler and element and household hazardous waste. Diversion Programs report on the 212021 status of those for NCR and more report on the most current data through June of 2022 and for SB 1883. Or how we kind of refer to it in the ear, SL CP in the sections report on implementation from January first, 2022 through June 30th, 2022.

And I'll note it several times throughout the kind of walk through here. But if there's no data to report, since we're on the kind of doing that and this is specific to the SLC P 1383 portions.

There's still required fields. So, just either enter kind of a zero, or not applicable.

And there's also additional Description box, so you can kinda describe when things are going to be implemented since 2022 is not quite over, and that could still be some time to further implement S L C programs.

10:15

OK, so, in general, what you're looking at is kind of that summary home screen.

10:23

And we'll see if my little tool works. Is there a little red box showing up on your screen Just so I know whether I can use it or not?

10:34

Thank you, alright, so what you'll see here we can have the ear re-organized into different sections and so, kind of shifting over. And we've tried as much as possible to consolidate and eliminate any duplicative reporting between maybe 139 NCR, more, and SLC P So it kind of organize more by program and sector and material.

11:00

And so this is kinda the new structure, and I'll just kind of click through the sections, and we're going to take lots of breaks. We're going to go through a few sections, will take breaks and answer questions, and then keep moving, and we should have some time at the end to answer additional questions.

11:16

And so for this particular one, kind of previewing Canada, a single entity, some middle of an ear tomorrow, we're going to be covering what regional agency reports will look like. And then next week, on June eighth, we'll be doing a webinar, which is all kind of the same general structure and James. Same general function, but a slightly different focus.

11:39

So, next week, on the eighth, we'll have special collection districts provide solid waste collection services, and your electronic and report, And then, we're going to, again, do kind of a single entity, city and county focus on June ninth, if you want to tune into those as well.

11:58

So, the general layout of how all these pages work, and it's all the same build. And I've gone through and prepopulated some of that, so you don't have to watch all the clicks as I go through things here.

12:08

But you'll have these buttons up at the top, They allow access to edit all the information on the page.

12:15

So, your quick edit.

12:18

And, again, this particular page is going to be re-ordered a little bit, But the information remain the same.

So this first box, first grid, we like to column, is just kinda summing up the information, and these grids down below. You can't see both of them, but this one, and then one below, so that you can't interact with this top box.

12:36

It's just summing up information that you enter into these grids below.

12.41

So you'll go through and you can check boxes of all the recovered, organic, waste products that may apply. Again, site title, title change will have there. All these little question marks are kind of tool tips that provide more information if you need more information.

12:59

And then as you get into kind of the grid feature, right, and kept by grid, it's table, right? Connect just been referred to it as grid. So you click Edit on the main page, and then you have to click edit again and each one of these grids next to the jurisdiction name to access the functions of that grid.

13:16

And it opens up what we like to call as kind of a form screen. So you will see us, kind of a form screen.

13:24

You'll see this rural exemption.

13:26

I'm gonna address that in a few slides when all of the potential exemptions or waivers are high performance systems may apply Article 17.

13:35

So I'll address these checkboxes a little bit later, but generally, how it works, anything with the red asterisk is a required field.

13:43

So all of these, all the red asterisks here, and you'll notice that like the additional description field does not have one, so this is an optional box where you can provide additional information. And we built this in all the grids. So if a number entry doesn't quite describe your program, how you want it to, you can provide any additional information in this box here.

14:05

So the way it works, I kinda pre populated here. You'll see a couple of zero entries because it's still a required field if you try to do it without a blank and click save.

14:14

It's going to kick an error message to you. So if you just if you didn't, in this particular example, procure any of these materials, you just enter a zero into that grid.

14:26

And then you'll click Save.

14.28

And then you're kinda move on to the next question. What should be the adjustment recovered, organic waste product? This one, I didn't, prepopulated want to talk about it a little bit. There are

several areas where you're initially kind of asked a question, which is a required field. So if you wanted to submit for the adjusted recovered organic waste product kind of target, you click Yes. And then, I guess before I click, you'll notice these fields here are grayed out.

14:54

And as I click Yes and Activate, and then you'll be required to put these entries in here. If you click Yes.

15:03

And then you click Save.

15:06

And then if you wanted to say no, kinda graze those boxes out again and you do not have to put an entry. I'm gonna do yes.

15:14

Just so you can see where these numbers influence here, so can't quite fit it all ups. That's not what I wanted to do.

15:22

Can't quite fit it all on the same screen, but generally, these numbers here, and then these numbers up here.

15:29

I'll get summed up into this great up here, and it'll be a little bit easier to see on the actual release. We're going to re-organize this so that it's a little bit better, but it's doing the math, that our Procurement section has identified in the regulations for all of these different material types.

15.47

And then, kind of the last main feature is the Sri programs. So, your 939 programs. So, instead of them if, for those that report in the past we had kind of one grid, or, I'm sorry, yeah, one grid, kind of at the end where you have all your ... programs we've moved all the Sri programs into their appropriate sections. So, in this particular one, only procurement populates because we're in the procurement section.

16:12

And the way these function is you check the box which kind of activates the program, and creates a hyperlink.

16:20

This is, and I'll prompt you if you get. Actually, before I do that, let me save here.

16:27

So, I don't have to come back and do this again.

16:30

So, come back down, activates this hyperlink, and this will take you to a program details page that I think a lot of you are familiar with. So, if you need to update any of your existing program information, you can do so up here. one thing I did most of this, I don't think changes for most of you, but if it does, this is where you can do so by clicking the edit button here.

And one thing I just wanted to kind of highlight here, because a lot of times it's a process, this notes field, is where you may need to enter something. And I'll just show you a feature we built in here.

So, if all you need to do is kinda enter a note here, You can do it here, if you want.

17.22

Or, you can just kinda do it in this box down here. So, if you click Edit, and kinda come down this section, it's white instead of that gray.

17:31

So, this Notes field box is the same notes box if you need to enter any data, so you don't have to click on these program program details, unless there's something you really need to update. If you just want to put a note, you can just put it here.

17:43

And then, we'll also have an additional kind of note here, saying that if your program is described kind of up in these grids above, there's no need to put any additional information, kind of education outreach, and it applies, and then, you click Save.

17:59

You'll get kind of that same old green checkmark to tell you that this section has done. And then you can move on to the next section, which in this case is edible food.

18:08

You can click up here or here to move through. And I think we're going to pause for a minute here and see if there's any questions.

18:20

Hey, this is Julia. So far, the only questions we've had come in is regarding when the year will be open, and Ashley, wanted to note that. We're hoping to have an open in the next few weeks and we'll send out a Listserv message. The other question that has come in so far is, when the year is still. And Tara said that for this year, or the year, for all programs, is due on October first.

18:45

So we have another couple of questions coming in correction.

18:49

It's going to be due october third, because October first is a Saturday.

18.56

Thank you, Chris.

18:57

You're welcome to now. I'll hand it over to banks. We have done a few questions coming in.

19:05

Thanks, Julia. Our first question regarding procurement comes from Emily Emily Coven.

19:11

Emily, we're going to go ahead and unmute you on our head.

19:13

Our end, if you'd like to repeat your question and state your affiliation.

Oh, Hi. Yeah. This is Emily Coven from Recycling. I just had a quick question about that procurement target number that's shown on the screen right now. I know that came out in a report from Cal Recycle, but was wondering, will that be automatically populated when people go to enter this. Or, well, is there a way to enter that?

19:36

Yeah, no, thank you for actually asking that's something I did overlook. So this procurement target is based on your population. And so, that's prepopulated for each jurisdiction in the report, and the only ones that change will be this one or this one based on your inputs and those grids below.

19:54

Great. Thank you.

19:58

Our next question is from Ian Bevin.

20:02

Question is, Can you provide the link that will enable us to poke around and get acquainted with the new system? I really would like to see how different this new system is from the Model tool.

20:15

Um, yes, but kind of what I think Julia mentioned before, it's not quite open or should be opening in the next few weeks, and we'll send out a listserv message when it is open, and you can go in and see your individual report.

20:33

Thank you for that.

20:35

Next up, we have Katelyn Mills, who asks, what is the difference between organically procurement and adjusted procurement?

20:44

Yeah, this one might be better for our procurement team to answer for you.

20:49

But generally, this adjusted, recovered procurement target is if you wanted to change, wait.

20:58

Instead of having a population based procurement target, it would be based on your total. And I'll just scroll back down, so I get it right. Your total transportation, fuel, electricity, and gas used for heating applications usage, whether organically derived or not from the previous calendar year.

21:18

And then one note that we'll have our procurement team follow up with you on that, to provide a little additional information.

21:28

And that's all the question I'm seeing right now, Andrew.

Thank you, Julia. Alright, and we're going to have several breaks as we go through, because some of these credits are a little bit more complicated than others. So we'll pause frequently to ask questions kind of break this up a little bit.

21:43

But moving on edible food.

21:46

This one, I left blank, so you can kind of see the whole process, right? So I clicked at it on the page. Click Edit on the grid.

21:52

And this one is pretty straightforward, so you can just kind of enter your numbers as they apply to your jurisdiction.

22:00

Then again, write additional descriptions, not required, as indicated by the asterisk. And we have tool tips kind of located throughout, if you need additional information.

22:09

And they also a lot of them pop up, if you hover over, the green are the same ones that correspond to these question marks.

22.23

OK, so that's kind of it.

22:24

I'm not getting the red checkmark, and I think we'll have it in our system message. But this is a new build for us. So please be patient with us.

22:34

If you notice anything that's not working for you, please contact us so we can fix that as soon as possible as soon as the ear does open up.

22:43

All right.

22:44

Move on to collection systems.

22.50

So collection system.

22:51

This is probably the most complicated grid that we have in this entire report, and that's a little bit large. We're going to have as some additional tool tips to add some clarity for how this functions.

23:02

But I wanted to spend a little time here to kind of walk, walk you through how it will look. So edit on the top of the page. Again, Edit in the grid.

23:12

And I think the first thing that kind of becomes obvious that maybe didn't saw in the other grids is that the save and cancel buttons, right, or not, really, where you would think they were. And something that this crit also has, as its own scroll bar down here.

And that's really, just due to the size of the grid and to limit how much input jurisdictions had to do.

23:35

It made more sense for us to do it in one grade, as opposed to breaking into two, and you'll see why as you add haulers, in just a moment.

23:42

I wanted to point these two things out, so, you know, all right, I have kinda scroll bar on my page, but then this grid itself has one.

23:50

So if you kind of slide over, you'll find the save and cancel buttons and that's really, these are centered in the grid, not necessarily underneath the questions that are up here.

24.04

So, the way this, this functions, this might be a good time, since most of our waivers are here too. So, if.

24:14

Rural exemption, low population waiver, or kind of the high performance article 17, we haven't referred to here. The one that's not showing up in this particular grid would be the elevation waiver as well.

24:27

But the way these functions are, if you click the box, it kind of allows you to not answer the required field question. So, rural exemption doesn't have to have collection in this particular example.

24:40

So, if I click the rural Exemption, and then click Save, it allows me to bypass that entire grid and not entering the information, whereas if I don't select it, and try to pick save, and, again, length is created as its own scroll bar, and it's telling me that I have to do these required entries.

25:03

Just want to point that out.

25:04

Low population waiver works the same way in this particular grid, and, well, population. I kind of wanted to note as well that we haven't noted up here, and we're going to update this language a little bit.

25:19

But, essentially, what it's saying is it's jurisdictions responsibility, ultimately, too, know what they are waived from reporting and what are required to report it on.

25:29

Our system was kind of unable to eliminate particular Census tracks.

25:34

So, the low population waiver kind of bypasses those required fields, but if you still have census tracts that are required to collect, you need to report on those even though you're selecting that low population waiver box.

So, we'll kind of come back in here and go through just kind of a normal, non exempt and non waived area.

25:55

So, we split it into residential and commercial, for convenience, just in case they are, different collection systems.

26:04

For example, purposes. I'm just going to assume that they're both the same. So as you check the box, you'll kind of notice that these are white, as opposed to these that are still gray.

26:15

So, it's asking for that number of generators for the collection system selected.

26:22

Requires an entry in both of those, then again, that scroll bar at the bottom of the grid, and click Save.

26:30

And then you have recorded your entry, and that box here.

26:39

And some of these titles are going to shift a little bit to make a little bit more clear what we're asking.

26:44

And this is where I've kinda prepopulated, but I'll go in here and show generally how they work.

26:51

So, on these questions in the beginning, you do have to select yes or no.

26:56

On this top example, I selected yes, you only have to identify the facility that are that are allowing plastic bags, cripples plastics and then green container.

27:08

We built in a function that you can select the ... number. If you choose to identify the facility that way, it's not required for these particular reporting questions and the way it works as you highlight them.

27:21

We are going to include kind of a link to our RDS Facility Search page, so if you're not sure of the number, since that's how it's organized, you can click on the hyperlink.

27.29

It'll be it'll be about it'd be like, right here, wants to report your releases.

27:36

Click on that and you can search it so you know the number.

27:39

But you just hit Select, it moves them over into that selected category.

The second question I said, No. Just to kind of show you the difference of it happening at grayed out and not require an entry as well as the select and remove buttons also being grayed out.

27:58

You scroll back down, click save on that field, it updates that record.

28:04

one thing I want to note is that in the organic waste haulers grid, it does require you to enter the ... facility number.

28:15

So we do not give the Have the Text box option to identify how you choose, you have to pick the Arthur S Number out of this list here.

28:25

I've already kinda prepopulated, for example, purposes.

28:29

Come down to the bottom and click Save.

28:37

And as you see, I get my green check mark, and I'm done with this section. And I know this grid is kinda populated, so we're going to pause again. And see if there's any other questions.

28:51

We do have some questions, Andrew, first one B, Hayley ..., who asks, Do you need to report tier 1 and 2 generators for this first report?

29:04

Edible food generators, is that what the question is?

29:08

Yes, to one internship back over here, essentially, yes.

29:11

Danielle, can you mind answering that question for them?

29:16

Hi, Andrew. Yeah, I'm just double checking, because you're right, that, that Tier two generators are required to donate. Starting in 20 24.

29:27

I do want to double check, I might have to follow up with this, just because I wanna make sure that I'm getting this correct.

29:36

Thank you, Danielle.

29.40

I can chime in here. This is Ashley.

29.43

Um, so in the regs, for reporting for Article 10, it says the number of commercial edible food generators located within the jurisdiction. Andrew, I don't think we separate Tier one and Tier two Dewey in the report.

So, it would just be your total number that you have.

30:05

And this October report, as a reminder, it's for January of this year to June 30th, of this year for 13, 83 purposes.

30:15

So, there was another question that Kara and I responded to about 20 21. So, this again, and we're trying to do it for efficiency purposes for everyone. Instead of requiring two reports this year for the 2021 Sri, we MCR more data. We combined it with the 1383 Report. That's due August, October of this year. Sorry.

30:41

So that October report, um, which is this one that Andrew's going over, should have the 2021 data bursary and we, But also the data for 1383, from January until June 30th of this year.

30:57

Next year, on August first, we will cover all of 20 22. So you may, and as Karen noted in her notes, you may have some zeros or some information that you don't have yet for the first six months of 2022. We will get it next year in 20 23 about calendar year 20 22.

31:18

Very confusing. That is how the regs are, and so we're following the regs, but if you do need clarifying, please let us know.

31:27

I'll just add to that when it comes to providing the number of commercial edible food generators. Both Tier one and Tier two, as a jurisdiction, you already should have that information. That information as necessary for capacity planning numbers, which is due the county has to submit that report August one.

31:45

So, if, for some reason, you're still identifying those Tier two commercial food generators, please be sure to add a note and the annual report and explain why you don't have that completed as of yet, when you submit the annual report October one, that potentially is going to impact your capacity planning as well. Also, if you have a specific scenario or situational question, please contact your lamb's liaison, and we'll talk about your particular situation, then how to address that in your annual report data.

Thanks, Ashley.

Our next question comes from Karin.

32.28

Karen is just wondering if multi-family dwellings are included in commercial and non residential reporting?

32:36

Yeah, so, that's kind of getting a little bit ahead when we can address it.

Now, it's in enforcement and monitoring, and, I guess, it's in that collection systems grid, too. But, as part of the 1903 regulation, multi-family with five plus units as part of the commercial business definition. So, to simplify and compliance reviews so the SLC P grid, MCR and more the commercial businesses includes both kind of the traditional commercial businesses you're used to, as well as multi-family units with Pi Plus Units.

I'll touch on that again when we get to enforcement and monitoring.

33:18

You have no further clarification. Is needed there. Will go to Emily coven. Next question.

33:26

So to clarify, if you have low population waivers for some But not all census tracts, should you check the low population waiver box and then enter the data for the non live tracks? Or do you not check the box?

33:37

Emily couldn't tell if checking the box disabled the fields.

33:42

It doesn't disable them. So, yes. Check the box.

33:46

It's kind of serving two purposes, because our systems, it's a little bit limited, unfortunately, So we couldn't customize it to kind of account for all potential center and arrows, but yes, check the box. It still allows for entries in here, but it just doesn't require entries, so you would report on those census tracts that are not waived from collection.

34:12

All right. Our next question is again from Emily coven.

34:16

Emily's asking, What happens when you click the Additional Haller button?

34:20

Oh, thank you. I Totally forgot to go over that. Thank you so much for doing that.

34:26

So we realized to that you're probably going to have more than one haller so for each color and you can click this as many times as you want.

34:35

But you click on the additional Ad hauler. We put a holler name, just more. You don't have to. It's not required to put the holler name in here, but just for kinda more tracking purposes for you to make sure you're accounting for haulers. We just put a holler name box here, so you could type in, however you want to identify them. So, Holler, one in this case.

34:56

I want to just assume they have that same collection system with a very small jurisdiction.

35:04

And then you come over and save hauler and then it will populate as another row.

So you can do this as much as you want. Thank you for bringing that up.

35:14

Color, too.

35:15

And then, if even if you add some customization, where no low pop applied to one jurisdiction, I guess, I don't really apply in this particular case, but you can click these buttons as well.

35:27

If it happens to be a holler in those census tracks and then it bypasses and you don't have to enter those required fields that answer the question.

35:41

Yes, thank you, Andrew.

35:44

Next question comes from Chintzy 10, apologize if I mispronounce your name. Are residential organics go to different facilities than the commercial and commercial generators are allowed to use compostable bags, but residential or not?

35:57

Will you have an additional grid to separate the infill for residential versus commercial generators?

36:04

Not in these grids down below.

36:07

So, I mean, based on what I'm hearing, it sounds like you would just be answering.

36.11

Yes, that they're allowed and the green container for your jurisdiction. But, no, it's not specific to your residential or commercial collection.

36:19

You just kind of say yes and yes.

36:22

You can identify it here.

36:28

Or select our DRS facilities that they go to and then click Save to update that record. So you just combine kinda both commercial and residential into that. What if it were applied or not?

36:44

Thank you, Andrew. Our next question comes from Wendy Villi.

36:49

Wendy's question is, Can you make it clear which tabs relate to 20 21 data persons, which apply to Jan, 1, 2022 through June 30th, 2022 data?

37:02

So, the ear, again, is kinda instead of being organized by 939, MCR Moore and 1983.

It's organized by sector and material type.

37:15

So it's all combined. Sri programs, I think are very obvious. Most of these grids, for the most part, are ... information, but the entire ears required to be completed. So it'll be clear as you go through that just everything is required, or if you have waivers or exemptions is not required.

It's not enough clarity. You want me to go further, and I think you'll see it as we get a little bit further in the commercial and residential tabs, in education, outreach of how that works a little bit better.

Our final question for this segment is from Susan ....

Susan asks, For the 2021 report, the food recovered is from recovery organizations within your jurisdiction.

Yes, I believe it's those located in your jurisdiction, but I'll let Danielle speak on that.

Yeah, it's the total pounds of edible food recovered by food recovery organizations and services located in that jurisdiction, regardless of where the food was recovered from.

38:29

Thank you. And then we have one more question that just popped in from Wendy buoy as a collection systems. should we report on what is current at the time of the report?

38:41

Yeah, the regulation specify to report on the collection system that is provided.

38.46

If you were hadn't quite collected as an example food waste or food to a paper, you can kind of put these this additional notes field to say when that collection will begin.

39:02

You can do that and kind of a per hauler basis if that matters if that if there's differences.

39.14

I think that covers it. For now, Andrea.

39:17

Thank you.

39:19

OK, so, the first kinda three sections here, we're really more mostly focused on 13 0, ....

39:27

As we move into the report a little bit, you'll start seeing blend of all programs, 939, MCR, more and 13 83. And we try to capture that. Right. So, some of the sections, we found a better to put kind of a tool tips or clarity up top and just this bullet point format. As opposed to the question marks, which are on the specific material types.

I've kind of already gone through it, but again, you click at it on the page.

39:56

Um, there's not an entry required in each of these kind of sub sections of material types collected.

40:02

We just chopped it up a little bit, so it wasn't one giant list to look at, but you just come through here and check all that apply, whether kind of it what it says up here, includes all your programs. So, this is when we, kind of, start blending things together.

So, regardless of the container or the law that you're kind of reporting on, you just check all that apply in this list.

40:29

You just tapped it. It just requires at least one entry in one of these. But you click, click all that apply, have a box down here.

40:37

There's a few spots where we have something like that.

40:40

Or if you wanted to provide any additional information on material types, you can provide that detail here.

40:47

Then as we get into the Sri programs, so for commercial, kind of split them all off and put them in this section.

40:54

So as you go through and there's multiple shree programs, you are required to check these boxes.

41:02

And the, that's just kind of verifying these details up top.

41:07

here, just kinda verify that those program details are still current.

41:13

Still current.

41:14

And if you need to, you can type in here.

41:18

I just want to do this one more time.

41:24

So that you can see that you can do it kind of either way.

41:27

Let me click Save real quick, and a lot of times before, you move off a page, like I'm about to do, or save at the top or bottom of the page.

So if we click Save, no, it's requiring me.

41:41

I know it's doing that. But anyway, what I want to show you is, I just entered this note here in this text box.

41:48

And if I go to the program details of this page, you'll see that it shows up again, right here. So if all you need to do is type something in that notes field, you do not need to go to the program details page, which is on the screen right now.

You can just do that in the text box. that's in the kind of the main ear.

42:09

Then we also moved large venues over this section. So again, you have to check all of these check marks next to the Sri programs to verify that program details are current, and that those program details have been ported from what you previously reported in your ears. So, if there's no updates, you don't need to go to the hyperlink is just available for you if you do.

And then as we scroll down to the bottom, we have the large venues section, which I'm actually going to pass it back over to Chris, to talk about this.

All right, Chris. You should be able to drive.

Let me clear up my screen and get back, it's at the bottom here.

43:06

Sure, screen.

OK, so, this is the Venues and events section.

For those of you who have done the ear previously, this will look a little bit familiar, Not a lot has changed, just its placement down here as part of the commercial section rather than its own sort of tapped page at towards the end of the previous year.

43:35

From here, if you press Edit, you gotta remember that.

43.40

From here, you can either add a new venue and event, copy over it event from the previous year, or check a box that says you have no reportable events for demonstration purposes. I'm just going to copy an event from a previous year, since that's very likely what many of you are already doing.

Since we're in staging, it may take a second, does, have to load a bunch of old data, and bring it up.

Yes.

There we go. All right.

So from here, you can cut, you can look at the previous year's annual report and you can pick or choose any of the events, ideally all of them, to copy over to this year.

I don't think you wanted to have to do that.

So I've copied the event over, It says, it's incomplete, because each year, there's still just a little bit of information that needs to be put in to this section.

If nothing has changed with the type or the address, or what it is, you don't have to do anything on this page unless they did not.

Parks provide any information, in which case, you could check this box.

45:15

And on the practices page.

45:20

You do have to come in and put the level implementation of their plan.

45:24

Hopefully at this point, it's been fully implemented and you have to put in some disposal, tons or diversion tons and the version tons. If you don't have that level of specificity, just put zero.

45:38

And that will check the boxes off.

45:40

So they notice these fields, each have asterisks, which means they are required, carries over some information from previous years, but you do have to put in the implementation level. And some kind of total number.

You also have the option of updating any of the material types that are generated are diverted and or any associated local programs that correspond to the venue and event.

So, now that I've added this value, notice that, on this gray line, down here, it no longer says, incomplete, at the bottom, so this section is now completed, and the whole commercial program section is now completed.

So with that, we can, I will turn it back over to Andrew and or we can go to questions.

We're gonna go through residential.

46:36

I think before we pause for questions, since it's very similar Alrighty. Cool.

Thank you, Chris. And then we're going to do questions after residential and education outreach. I have another pause for questions. I was muted when I said that just a second ago. OK, so commercial section is complete, move on to residential.

Residential is very similar to commercial, so the same kind of material collection. There's slight differences in the materials, for the most part. It's the same, mostly down here in the Other category.

Then shrink Shree Programs, and I'm just kind of breezed through this sense.

It's the same as commercial, just for sake of time. So, again, check all the boxes to verify those program details are current.

Then, you're done with the residential with that kind of green checkmark right here.

Alright, Education, outreach.

So, as much as possible, we really tried to combine things if there is overlap between 139, MCR and more.

And you'll see that here in the question itself.

48:07

So for education outreach, in this grid, what we're saying, is that report on all education and outreach programs, whether it's ... more NCR sree or are your ... programs.

48.27

As you come in here.

48:30

So it kind of functions the same as before.

48:34

And I are the same as the Sri programs, but it combines them all into one, and I'll show you where those three programs are if you need to update them individually.

48:42

So, regardless, if it's NCAR, Moore, SLC P, our AB 139, you, check the appropriate box print, electronic, for this example.

48:54

I just selected print and electronic BSL SEPI requirement is just reporting on a number of generators.

49:04

So, that's where you enter that information. And then, you're also required as part of kind of 139 MCR Martin to describe kind of what your print. And so I just did some very simple examples down here in the box.

49:17

And then you can click Save.

49:19

So I'm going to spend a minute here since we have all of our checkboxes here, because it's a little bit different now, this section functions.

49:28

So all these checkboxes are doing, are waving you from 13, 83 requirements, not NCAR, more, or 9 39 requirements.

So if you check one of these boxes, you're still required to select your education and outreach that you're doing, but you don't have to put.

You don't have to put numbers number generators that are receiving the SLC P material.

So if you check one of these boxes, it allows you to bypass that.

I think the one difference might be on this high elevation waiver, because that only requires the food, waste, and food.

So, so, I just select just high elevation and click save, Still requires me to enter that number, and we just kinda put these in here just so it you can track where your waivers apply as well as our own staff.

And I guess one thing I did forget to mention is that these checkboxes only show up, if you've already been approved by the department for a waiver or exemption.

So these checkboxes will not be present, if one of these things does not apply to you.

So we'll just run through that again and save that. And then commercial edible food generators.

As per the Regulation C only, one that applies is Article 17, the high performance.

50.55

So you don't have to fill this out.

50:57

If you select article 17, I'll just do this example I guess here.

51:01

I guess you don't even have to check the box in this case, but it just allows me to save.

51:05

As far as the Sri programs, and again, we'll have an additional bullet here that says what I'm about to say. But if you have to already described your education and outreach above and the grids, you don't need to go in and specify what you did for electronic here, or print here as part of your sree programs. So, you can just put all of that information up in the grid, over in this Description box here.

You do still have to go through and check these check boxes to verify that the program details are current, And then we put these boxes here, which are optional to provide any additional clarification for 9 39, specifically, if you want to put that here.

Yeah, the material types collected are focusing on the materials diverted from disposal?

So yes, answer your question in that particular example.

Can a fault, asks, are we not required, or requested to report Tonnages first reprograms any longer? just update the details section?

53:30

Yeah, it was never required to report tonnage Information as part of the program, but I believe, we have left that there and what would be a good example of that?

53:41

I believe it's still there if you want to, And Andrew, I can update that a little bit. I think one of the, what you might be referring to as far as a diversion, tons, is the way the Tree Programs used to work with the easy button.

53:54

The way to get around having to update this whole screen was to use the easy button and just put it in tons.

54:00

So the way we've redone it is that it's going to default to zero tons. Just so this section can be completed but you're still more than welcome to the tons. And if you choose just sort of being de-emphasized due to all the other new fun 13, 83 items.

Thanks, Chris.

Our next question is from Allison Kjell Allison's question is: Will there be any information requirements the implementation record added to the final year? Or will there be any additional field requirements for individual cities not shown here?

54:41

I feel like there's multiple parts to that question.

54:43

So, I'm gonna start at the end, And if you're talking about kinda more regional agencies will cover how regional agencies and members of those agencies will what their ears will look like. So, address that tomorrow. So I tuned into that, to see that part.

Then, the, what the ear has is only the reporting requirements, and I'm not, remember in this section, I believe it's 1 8, 99, 4 2 someone correct me if I'm wrong. So, there is a little bit a difference between recordkeeping and reporting.

So only reporting requirements are in the ear, not implementation record requirements.

Did I answer all the questions?

55:28

Yes, thank you, OK.

55.32

Let me go ahead and combine the next couple of questions that we have, Employee Jones and Conditions on K, since they are both along the same, then you want to event reporting name.

Corey asked, two jurisdictions need to report on community colleges or split activities or venues, or events.

55:51

Well, can Nisha asks for clarification on the attendee limit for events reported? For, for instance, if there is an event that usually has 100 attendees versus an event with one thousand, with a smaller, that need to be reported?

56:09

Chris, do you want to take that one?

56:16

So, I can repeat it. I was trying to answer a chat question.

56:23

Yeah.

56:23

So, both of these are regarding venue and event reporting.

four is asking if community colleges or school activities need to be reported?

56:34

And niche is asking if attendee limits for events.

56:40

I reported, for example, if there is an event that usually has 100 attendees versus an event, with one thousand entities, with the smaller that need to be recorded.

56:48

OK, so, I guess I'll take the first one about schools and state agencies and beginning. Andrew, since you have the screen up, can you press the show button under venue event information, please.

Now, see what it says.

57:08

So, so that's got a definition of what is considered a large venue and event and what the expectation on reporting is, and so it's really just the top 10% of large events and venues based on the amount of solid waste generated.

So, I suppose a small town, a state agency or a school could be within that realm.

57:29

So, in that sense, you could you could require report state into your school but also the bin.

57:37

Public, it's less likely that they're going to meet some of the other criteria.

57:42

Andrew, can you hit the Show button on the one next to it now?

57:47

Because a large venue is defined as a facility that averages 2000 people per day of operation, say the same thing with an event. So a venue, if it is.

57:58

Open seven days a week and an average is 4000 people a day, that would qualify.

58:03

Unless, you know, as we're looking at Los Angeles on incorporate six flags, Magic Mountain, pretty big place, pretty big venue.

58:11

No, is a, is a museum necessarily going to be in that top 10, given some of the other options in that county, not necessarily.

58:22

So between these two boxes, I hope that kind of covers.

58:25

The what is the expectation on the news and events? But it's it's pretty liberal in the top 10%, not all venues, and these venues have to operate at 2000 people per day and charged admission price.

All right, thank you, Chris.

58:49

Our next question is from Caitlin Laos.

58.51

For commercial and residential, wouldn't you select all material types, since it includes trash slash landfill?

58:59

Not sure why, that would be helpful.

59:03

Yeah, so, the material sections are focusing on materials diverted.

59:08

The reason that we kind of specify all the containers here is just to cover all the potential different types of collection systems, whether it be 3 plus 3, 2, or one, but the focus of what you're selecting will be materials diverted, not the ones disposed.

Sadie Calder's asks, If we select the Street programs box and do not fill in new nodes. Does it Default to program details from 20 20?

59:45

So, the kinda easy button functionality of the Sri Programs is, has been removed.

59:52

What we'll copy over the kind of, program details, and a lot of times, anything you're entering need to enter here is captured in the Grid's above.

So, if you need to type anything in those program notes, you can do so here on the main page. You don't need to go into the program details.

1:00:16

Thank you. Our next question is from Emily, Kevin. Is it correct that in the top box, you check the box, for example, if you did print outreach for any rag, so more MCR, ..., et cetera, But you report the number of generators that received just SL CP materials.

Correct.

Explored enough, our next question comes from Paul Freund, just to confirm rural, exempt jurisdictions do not have to report how many generators received education material, even though we are required to notify our generators.

So, one thing, I think that, just, I'll go through the process here on just started over here. So education outreach is including 939, MCR, more, and SL CP.

So even if you collect Worrell exemption, you're still going to be required to select the material type because at 9 39, education and outreach. So if I click that right, it's still saying, I need to select something.

Here's a question, it's just going to be mostly your information of what materials go on which bans and how to divert those materials.

If you want to specify which material is for which law that it's satisfying, can do that in the described education outreach box.

We have a couple of questions coming in. And I just want to note that, for those of you who have asked questions about edible seed reporting, we will either respond to you in writing during this webinar, or follow up with you afterwards.

So our next question is from Justin Sullivan, How our jurisdiction is supposed to check the number of generators receiving electronic S L C P materials?

So it can be based on number of accounts for service, as well as population.

I think even an additional detail that might be helpful to know is you can include clicks of a website, or text messages sent.

That's other examples.

Thank you, Andrew. That's all the questions we have right now.

All right, fantastic, thank you.

OK, so, moving on to kinda see NDM, while I do want to point out this particular section, is, it's not gonna look a lot different, but it's maybe weren't re-organized a bit. The main change is going to be that it's only going to include ..., C, and D Cal Green and other programs, Ordinances, are going to move over into this enforceable mechanism section which is also going to change its name because I just want to note that that this particular section will look different. Even though it will function the same, I will just be re-organized slightly.

The basic functions of it are still the same. Once again, what you're seeing on the screen here is not final data.

This is not the final population of employment, or final disposal number, that disposal number.

We'll be changing as Facilities Report, or adjust information in the ...

system up's through.

This should be the data that CO be close of business on June 13. Will be the data that loads into this.

1:09:31

That we encourage jurisdictions to check the R D R S reports, see if there's anything that looks amiss in those and get in contact with the facilities to possibly get that changed before June 15th, if you can.

The general layout of this is the same when you press Edit, if you need to do adjust something the basic data for Spousal, tons Transformation Engineering engineered solid municipal solid waste screen ADC, unexploited ADC can't be changed.

If you do have a dispute or an issue with your reported tonnage and you work it out with our in our DRS with the facility and is updated you can submit a disposal modification for and let's say, this number. It's like this should be 914 14,000. This should be 900,000. We've already got it fixed with our DRS.

### 1:10:28

This is where you would make that adjustment.

#### 1:10:32

The other items below the disposal reduction credits are specific items that are allowed to be removed from a disposal Total.

#### 1:10:42

Disaster, as you'll see, disaster waste and class two are no longer editable fields, because those items are no longer reported by jurisdiction of origin in the ... system.

### 1:10:53

The medical waste Regional Diversion Facility Residual waste, which is a specific definition of a regional diversion facility, A, C, and D, waste for projects outside the jurisdictions controls, such as a Caltrans issue, or some kind of federal project that they are disposing of the waste. And even though you had a C and D or Lynch, you couldn't get them to do it. As well as out of state exported, diverted tons and other disposal amounts. Which is generally good at the for grape stakes and like quarantine green material that could be composted or diverted because we couldn't leave a quarantine area. So that would be for that last field there.

#### 1:11:36

As also the transformation number you get up to a 10% or 10% of total generation credit. This you would like to not claim that credit, you would put zero.

And after you've made any other changes you would like to make on this, we're just going to say 10 tons of medical waste and press Save.

They're not, they're refusing to acknowledge misreport, and you have some kind of proof or evidence. So, rather, you can definitely still contact the ... mailbox, but this form actually allows you to put in specific information about a facility, and you can attach other documentation explaining the issue that you're having.

So, that is the disposal rate calculator.

I'm going to make a couple other adjustments here to trigger some things in the next section.

So, that is the disposal rate calculator page, it's pretty much functioning the same as it was last year. The only major difference is the DRS complaint form rather than just going straight to the DRS mailbox.

The next page calculation factors is a little bit similar to the previous year's calculation factors page. You will notice, that, the disposal rate accuracy question, which used to be a completely different section of the year, is now added onto this page.

So one of the things I wanted to show Was since I changed the amount, the report, your disposal amount tons it says that I have an alter disposal tonnage because I made changes to the credits.

Then because there's green ADC in this jurisdiction if there's green ADC material then first question here, describe in the box below the jurisdictions plans to divert green material being used as ADC if there's any green material in this case 742.95 tons.

So we still had to include more exemptions but most of the time I think because it comes to physical space and de minimis, you'll be reporting in the ... jurisdiction issued waivers. Sit down here.

So, as you come into here, know, if you do have a rural exemption, low population waiver, you will need to come in and check these and enter the information number of generators that are waived from that collection service.

The rest, or if you have equipment failures, just put zeros.

For example, purposes, click Save, and then jurisdiction issued is where you'd be entering the de minimis and the physical space.

So this first jurisdiction issue, Waivers and I think we have some title changes to hopefully make a sort of more clear that it's for SEP.

And then if there's any more exemptions, that kind of ...

did not capture, in the case of, maybe, our population jurisdiction with only certain Census tracks waived, you'd come in here if there were any more exemptions to report in this field here.

So, we've got it built so that you can select route reviews, or waste evaluations, or both, if you prefer.

I don't know if you kinda noticed it on the screen, but if I have a route review selected, this box is grayed out and then this one is grayed out and we're going to change the wording here a little bit.

So it's a little bit more clear or asking, but I just wanted to kind of highlight that this is the only required field here, as well as kind of those notices.

And then you'd be done with the route reviews, you come back into it and went the other way, I went to waste evaluations.

Select that, so article 17 is here because they're not required to report on inspections.

So you select that checkbox there for high performance complaints.

Same idea. There's no complaints received or investigated.

Enter zeros because it's still a required field.

Click save.

All right, I'll pause here.

1:24:31

Actually now and go one more, because I think this will be where a lot of the questions come. Alright.

So this is kinda where the compliance reviews and again, like we stated before, our definition of commercial businesses and we put it here, right, includes multi-family width, those multi-family complexes with five plus units are part of the commercial businesses definition. So SLC P is this first grade or 13, 83 compliance reviews.

So, again, kind of coming back to that kind of some of the limitations of our system, back in February when we first presented this, we're kind of combining organics and recycling. And you enter those per generators.

There's some functionality with little rural and low pop that allows you to bypass The entries on the generators May slip to do the commercial part, so if you, even if you select a rural, I'll click Save.

Nevermind something we'll have to look at later.

1:27:05

Maybe it's a laptop, but anyway, so it allows you to bypass these sections as it applies to these.

Anyway, so you enter the number of violations, penalty orders, and enforcement actions resolved in all of these various grids for the different entity types listed.

The first one is from Emily Cavell.

Emily's question is So if your jurisdiction has 100 generators that were issued both SL CP, physical space waivers and AB 826, physical space exemptions, you'd enter 100 only in the jurisdiction issued waivers granted not in the 826 exemptions grid. Is that correct?

Yes. I believe in kind of this particular situation, the SLC P, physical space waivers would take precedence, precedence over the more physical space exemptions.

1:28:15

Karen, Ashley, there anything else you want to add on that?

1:28:25

Now, unless Emily has a follow up question.

1:28:35

All right. I think all needs to Jennifer next.

1:28:37

Jennifer's question is what does in compliance review me? If the jurisdiction is not under a compliance review? Do we put anything here?

1:28:48

Yes, You. So the compliance review title is going away so that should help alleviate that, that confusion. But yes, this will be the number of kind of generators, that desk audit. I think it's referred to in the regulations. Kara, did you wanna add on to that?

Thanks. Yeah, that's exactly.

what we're referring that for, is what's required, an article 14. So, for example, the desk audits of commercial businesses over two cubic yard, so that's what we meant by this term compliance review: it's what what you are doing to review compliance of the generators as required to do so in Article 14.

Can no more for their clarification you want to provide we'll move on to the next question, but for now, you are unmuted on our end.

Um, Notes, in a past webinar and the Model Implementation tool Word.

We indicated that in the past webinar model and Model Implementation Tool would model the system you came up with.

How much would you say that the system you are presenting varies from the Model Implementation tool?

If jurisdictions used a model implementation called design there, info collection systems, will we need to dramatically re tinker to match the data and eat it this system you are presenting.

That implementation, I mean, there's a little bit of difference between the implementation record, as well as what is required to be reported. So, that implementation records should contain everything that you need to report, but.

Just for clarification, because I'm not sure if they're asking about the implementation record tool, or the previous webinar where we did the show and tell of the model error, and that maybe we can get clarification.

Unmuted you, so you're self muted. You can go ahead and unmute yourself to clarification.

Yeah, so it was the model implementation tool.

1:31:11

It was presented in a webinar, I believe, in February, And it was my understanding that that tool would essentially mimics the sections that will be presented in early June, which is this.

And we basically built, for several cities, the data collection systems, based on that Model implementation tool.

And it was our, I mean, it was our understanding that each module would, like pretty much be comparable or similar. So yeah, if that's not the case, we might have to completely redesign, so this one, that's why I want to kind of know the difference, but maybe we'll have to take this offline.

Since enforcement is not required until 20 24, where if anywhere on the enforcement tab do we mentioned soft notices slash reminders that are given to generators who are in violation of some part of SB 13, 83?

Yeah. So, I mean, you are correct because you just be entering non zeros.

And these sections, if you're not issuing any penalty orders, and that just kinda comes down to what you have designed in your local ordinances, as far as the actions you will take for enforcement.

Because this is probably where, you know, if you've done education, or issued something kind of free enforcement.

Entity types listed.

Whereas the other ones that Canada's compliance reviews or desk audits are based on commercial businesses that have two plus cubic yards of solid waste disposal.

So, Andrew, just to put a fine point on this, and right here, we're talking about commercial, about food generators and food recovery organization services. Is that correct?

Yes, and then, I guess, there's the one column there at the end that does, say, number of commercial businesses.

1:35:40

So, this is included here because it's a reporting requirement in the regs, but kind of, as you see. We have the if applicable there.

And, it goes into, If you go hover over the tooltip that kinda gives you a little bit more information, about what that exactly means, and why it's there.

1:35:58

Yeah. And to that point, this is one aspect of where the regs kind of start talking. and we recognize that this is a reporting requirement, that, as the, the way Article 14 is written, you only have to do a desk audits, but should you need to, or want to do an inspection of a commercial business. This is included. But again, it's an optional, that's why we wrote, if applicable. and Andrew did a great job of adding into the tip there of what it means and how it relates. So hopefully that helps answer that question.

Now, take it, just one step further to, it's if you go into the, I guess, nevermind had, so as it, as kinda that required, asterisk failed. But again, just put, you have to put zero just to bypass the question, if it does not apply to you.

Same idea with the household hazardous waste supplement. If you update any of the things in the 9000 Code for a Teach W programs, you're making an update to your ear. So, the general idea of a revision is probably not needed.

Next up, the NDRC non disposal facility.

This, this, you could very likely possibly need to update some things.

So in this section, you could put yes and give us an idea of what it is in the box and the specific guidelines for ..., and what you would need to do to update. That document is listed right here at the website links.

It's noted, this process is much simpler than the three weeks. And for this case, all you really have to do is update a document saying, this is a new non disposal facility that we will be utilizing in our city or county. Send it to us, and we add it to your big file.

Next step is areas of concern.

This is from way back when, in the late eighties, early nineties, whenever you're, or, I guess, in some cases, the late nineties, early two thousands, whenever your actual planning documents were approved, if there was some specific item, the board at the time noted, that that was an area of concern. You're free to note that here, and remind us. So, ideally, that's probably been mentioned in the last 20 years worth of annual reports, if there was. So most likely, you'll say no to this.

Same thing with the conditional approval, if there was a conditional approval approval on those documents, you can note that here most likely will be no.

No, but this section is only for changes. So those ordinances that you submitted, if you've been notified that your April one report was complete, you don't need anything else from you. This is only if things change in those ordinances.

And I'll mention that we are in the process, we're still processing those April one Reports. So far we have renamed and uploaded over one thousand Documents to Logic for jurisdictions on those.

So if they were submitted on April first, we have them and any additional ordinances that were submitted after April first, you know, the ordinance needed to be changed.
