Right, So you can see the instructions for that on your screen will be pausing after certain sections to go through questions, um, the webinar itself, as well as.

We go through questions of each in each section of the ear and we will be doing those either through the Q&A or through the questions box in the goto meeting, or through live reading of questions if you are logged into the goto meeting.

So the next step we're gonna look at is how to get access to the ear if you don't already have it.

As you can see, on this page, to gain access to the logic system, to file the ear, you need to be a contact in the system.

And once your ad is a contact, you will receive a web pests invite from logic.

Or if you already have an active Webtest account, you will get a message saying that you have received access to logic using your existing web class.

Please, if any of you need to be added as a contact or revive or revise your current contact information, please fill out Reporting Entity Contact Change Request form noted on this page.

Again, this page is cow recycle dot CA dot gov slash LG's central slash my logic. We will be probably putting that in the chat in a little bit.

So that is the first step to gain access to the ear, if you do not already have it.

3:59

Yeah.

So, next up, we will sign into the system.

4:12 Oh!

4:22

It is.

4:26

That's important.

Cool.

4:42

There we go. Sorry about that.

4:47

Yes.

4:50

So, once you log into the system, you will see a list of jurisdictions that you have access rights to. As you can see, for testing purposes, I have a number of different jurisdictions and counties listed here.

5:02

For demonstration purposes today, we'll be looking at the Sonoma County with Waste Management Agency.

5:09

Thank you for letting us use you as an example. Once again, we appreciate it.

5:15

Once you are about Dell, you will arrive on this landing screen, and, from here, you can access previous annual report summary, is going back all the way of the Year, 2000 that they're available.

5:27

You can also access, then you do an event reporting summaries, as well as a link to the diversion program notes. From here, you can download the entire history of your diversion program notes into an Excel file if you choose. I'm not going to go back onto this page because it takes a little bit to load in staging.

5:49

But you can get all your notes there. The rest of this page you will see some information about the transition to the Recycling and Disposal Reporting System away from the previous electronic disposal reporting system noted below. There's still the old ERS information going back to 2000 up through or 2007 up to 20 19 is all in here.

6:13

But for current disposal data, you would want to look at our DRS.

6:18

There are links to the DRS Public Reports right here on the landing page.

6:24

So that does it for this bit of an intro section.

6:28

At this point I would like to bring along Andrew Parrish, who will walk you through the ear from this point on.

6:38 Cool.

6:41 There you are.

Andrew Unmute.

6:47

Thanks, Chris. Just give us a moment while a transition of presenter function will start walking through it.

7:14

Chris, you want to make me presenter, please?

7:24

OK, I'm going to turn my camera off, so you can see the screen a little bit better. So I just want to start with a little bit of housekeeping here.

7:31

So as Chris already mentioned, this is kind of a beta version. It is mostly complete, but as we step through, there are some minor changes that we're still actively working on.

7:42

And some of those changes are just going to be minor title changes, some typo fixes. A couple of the sections will have a little re-ordering of grids. And then we're adding some additional tool tips to help clarify things that may be confusing.

7:58

How that your functions and how it is filled out in this webinar will be the same as the final version, and then if you have any additional follow-up in, contact your lamb representative and to reporting problems you may have.

8:13

As some kind of general information before we get into the actual walkthrough, information is due in the Electronic Annual Report by October first, 2022.

8:22

That happens to fall on a Saturday syrupy October third this year.

8:27

And then for this upcoming year cycle wants you to report. For AB 939, your Sri ... report on 20 21 status for NCR and more. Report on the most current data through June of 2022.

8:42

And for SB 1983 R S LCP, you'll hear me referring to it, and as we do the walkthrough report on implementation from january first, 2022, through June 30th, 2022.

8:56

And I'll say it multiple times and now as we do the walkthrough, but if there's no data yet for any of the program, such as procurement or edible food, there are still required fields. You just enter zero and there's an additional note field. three can provide explanation if you choose to.

9:14

I also wanted to kind of let you know that upcoming on the eighth and ninth, we'll be doing the same webinar kind of walkthrough. Again, it won't be a regional agency focused, but it's the same for all jurisdictions. Regional agencies just have more jurisdictions populating the grids.

That June 28th and July seventh. After the ear opens, we'll have kind of an open Q and A session webinar, where, after you've been able to touch the ear, and you may stumble into problems. Or maybe some issues will be available to walk you through how those sections work. Or answer any questions, you can report any bugs you may find.

And with that, I think we'll get started on the walk through, OK, so couple of the majors.

10:03

Things I want to start with are just kind of highlighting up here, and which is the same kind of grid here. So we've organized the year instead of it being organized by AB 939 NCR, more, and SL CP or 1983 organized by my material and sector.

10:23

And we just found that there was a lot of overlap between the laws, and it made more sense to shift the focus. So in kind of combine all those elements and eliminate duplication, wherever we possibly could in far as what you're reporting.

10:37

Just want to walk through the different sections real quick. And we'll go through an order of these, and we're going to do several breaks as we go to kinda chop up the Q and A.

10:48

So if you have maybe a waivers and exemptions question, if you could just please hold off, until we get to those sections, to ask those types of questions, we'll be happy to address those there.

10:56

So, procurement, edible food and kind of looking up here.

11:01

That's where I'm going or the list down below.

11:04

Procurement edible food collection systems are mostly kinda SLC, P reporting requirements that commercial programs, residential programs, education and outreach, start to blend together all for AB 939. MCR more an SEL CIP.

11:23

Same with the ... and Ordinances section blends together. Some of those elements, hatters, hazardous waste programs is 939.

11:34

The disposal rate calculation and calculation factors are the same as they've always been.

11:40

Waivers and exemptions, contamination inspections and complaints, and enforcement and monitoring. Mostly SL CP, but there's a little bit of overlap. And we'll address those when I get to those sections facilities is AB 939.

11:54

AB 876 is dealing with AB 8 8, AB 876 and 8826, capacity planning, which on dress when we get to that section.

13, 83 enforceable mechanism focused on SLC P planning documents, as the same as it always has been, Chris will be talking about that. And an additional information is just kinda somewhere where you can report additional things. With that, I'm just gonna go ahead and get started.

12:23

Give it just a moment, a little slow on, staging. Like Chris noted, is saying, there we go.

12:29

OK, so then one of the big changes that we have in the ear is this grid structure. So this is kind of what I'm referring to, the grid structure for regional agencies. Specifically, it's going to be pre populated with all the member jurisdictions.

12:45

And, I guess, just to note, for those viewers that may be reporting for special collection districts that provide solid waste collection, your reports will look very similar to this, with all the special collection districts being listed as cannot separate jurisdictions. So, it's no longer kinda that one giant text box that you may be used to for reporting and MCR, and more for reporting on an individual jurisdictional basis, which will be pre populated.

13:14

Kind of this jurisdiction name, and all the Grid's is always prepopulated as we walk through this.

13:21

The first grid, there's no interaction, and this first grant and procurement target is your target based on your population. That's static. There's no way to manipulate this.

13:33

And for that matter, anything in this grid is not manipulated here, the annual procurement.

13:41

And actually, let me scroll down so you can maybe see just a little bit of the titles here. So, the Annual Procurement.

13:47

I'll come back up in just a second, Enter Procurement. It is populated by what is input here.

13:53

And the adjusted procurement target as populated.

13:58

But what is input in this grid?

14:04

All right, so, and all these pages, all these sections, how it functions is, you have to first click the edit button on the page.

14:14

I'll go ahead and click that and I've already gone through and all the numbers you see here, just for demonstration purposes, just prepopulated a lot of it, so you didn't have to watch me, just type in a bunch of numbers.

14:25

So, that's what you're seeing here. At. There's no significance to these numbers.

Just for demonstration purposes, So I've clicked edit, which opened up the page. You see there's nothing to interact with here, so you just kinda keep scrolling down one shift. This is one section that will shift around.

14:41

We're going to retitle some of the names here. So, be recovered organic waste products that are recycled product procurement, and the three goods will be together.

14:51

And then there's checklists. What kinda move down to the bottom won't be one change you'll see in the upcoming built, in the live version.

15:00

So as you go through here, for regional agencies, you're clicking on all the products that apply for all jurisdictions and these check marks sections. And I'll show you, I'll say that again and kind of commercial residential sections. So this applies to All jurisdictions.

15:17

Just select all that apply.

15:20

As you get into these grids, you'll see there's edit buttons next each jurisdiction. And then I'm gonna go down. I'll just start here.

15:28

So, as you open an individual jurisdiction, you will see cloverdale is here, and this is what we kind of refer to as the form screen.

15:39

I'll address the rural exemption checkbox here a little bit later, when you can see all the different potential waivers and or exemptions, or the Article 17 high performance systems and explain how that functions and I and a few sections.

15:55

Any asterisk you see is a required field.

16:01

So even if you have nothing to report, you still need to enter is zero to get through it.

16:07

And kinda what I mean by that is if I delete this and try to hit Save, prompt me and that I haven't Mulches a required field surf, You may not procure all these products, but for the ones you don't, just enter zero.

16:20

Can hit Save, and then you can move on through the next jurisdiction, so you go kind of jurisdiction to jurisdiction.

16:29

And then one other thing I didn't point out, so all these form screens look the same.

16:34

Each form screen, we always include a kindness additional description box, which you'll see does not have the red asterisk right here, and this is just kind of a notes field.

And we just provided this. It's optional, and it can be used to provide any additional detail is needed in each jurisdiction has this. So, if you want to just say things about some jurisdictions, but not others of the regional agency, you your feel free to do, so, that's why this box is here.

17:06

As we get down into the adjusted recovered organic waste product, as you open up each one of these, and this is if you wanted to submit for a different target.

17:18

Anytime there's a drop-down with like a yes slash no to the question, it is required to answer the question. So yes, would be.

17:27

If you want to fill this out and submit for the adjusted, recovered organic Waste product procurement, sorry, I'm kinda jumbling that adjusted recovered organic waste product, procurement target and then as I don't know, if you noticed, but I'll go back to now.

17:42

So currently, these are grayed out.

17:45

And so no additional information as required. You say now, you can just hit Save, and you can move on.

17:52

If you do want to enter that information, you would say yes, you enter the values as they may apply.

18:05

And then you'd hit Save.

18:07

So we did that for ..., which hopefully I'm saying that correct. So, this number is calculated, and then kinda populated backup and disk read.

18:19

So, if you want to kind of Senate for that adjusted target, I guess in this case, my numbers are too high.

18:25

Ideally, you want that less.

18:26

So, that's kind of that generally how that information input down below populates to this grid up top.

18:36

Then at the bottom of the sections where the Sri ... or AB 939, programs apply, we've moved them into their individual sections. So there's no longer kinda that Sri ...

18:48

program grid where everything is there all moved into these individual sections.

The easy button has been removed.

18:58

So, in order to mark this section complete, each tree program that happens only be one in this procurement section, as a subtle checkbox, buy on, check it, and you'll see the hyperlink goes away.

19:13

These notes are telling you what that checkbox does.

19:16

So, all programs have to have the checkbox checked for the section to be marked Complete in the system.

19:22

Once the program checkbox is checked, the program Duke, Tales of that program will be accessible through a hyperlink.

19:29

And I'll go to that just show, you will be the screen you're familiar with, The program details need to be updated, and click the hyperlink, and make the necessary changes.

19:38

If only notes need to be entered, you can use this box here, and I'm just show you what I mean by that, so I check this box.

19:46

And, then go to these program details you get prompted to save your information before leaving the page.

19:54

Just cancel real quick, and go ahead and save that, to open up that page again to Edit Mode.

20:02

Come back down and click that hyperlink I've already saved, so I'll say, OK.

20:07

This will move to that. Takes a minute faster than I thought So.

20:12

This is a screen you're probably familiar with. This part carries over year to year.

20:16

I think the one part that the easy button used to do for you is kinda pre populate this box with the zero. So it would complete this section.

20:26

In this new build, we're pre populating those boxes with zeros so you don't need to click anything to actually do that. It just does that automatically, but you are if you want to enter your diversion tons.

20:38 You click edit.

And then you can enter your diversion tans here.

20:47

The other part, I wanted to note, is this note box that you're probably familiar with, where you enter most these notes as kinda depicted below.

20:54

If all you need to do is enter notes here.

21:03

You can enter them here if you want, and click Save.

21:11

I'm gonna go back and takes you back to that section.

21:14

Me scroll down, you'll see that same message pops up here. So if there's only a program, known as program details, I showed, you need to be changed, And you just wanted to briefly describe specifically what you're doing for AB 939, this particular program, you can just type it into this field here, and it'll save it in those program details.

21:35

All right, And so I know that was probably a lot to get started, but just pause here and see if there's any questions so far.

21:44

We do have a question, on Frank asks, If the version times are known, are they required to be entered?

21:52

Paul, you're unmuted if you'd like to get some further clarification answers.

21:59

No diversion towns are not required to be entered.

22:05

Notice there's that red asterisks. And I know in, in the past years, we've submitted, for things that we didn't know, we would enter tons, but That's good to know, it's not required.

22:17

Yeah. So in the past, kind of an easy button would pre populate all that for you, and are trying to really simplify the report. So we don't want to make, you have to go to all those program detail pages to not to enter things that were not required. So that's why we kinda, Yes, you are correct. It has that required field, but it's already been pre populated with the zero, and if you'd like to change that, you can.

22:41 Perfect, Thanks.

22:45 That's the other way.

22:46 All right, well, we'll just keep moving.

Alright, edible food.

22:52

Again, in the Grid, you're always going to click on the edit page or the edit button on the page first to access the grid functions kind of see right now. There's no edit buttons here.

23:05

And then as soon as I click Edit, it opens a map on a per jurisdiction basis.

23:11

So, as you go in, per jurisdiction, you enter the required information.

23:19

Update record. It'll say save in the new report, so one of our typos.

23:24

Click that save, and it records that information.

23:27

And so you just do that for each one of your jurisdictions here, then there's no Shree programs. So there's no Sri Programs section at the end of this.

23:40

All right, I'm gonna keep moving here off, multiple breaks for questions.

23:46

Don't, don't worry if we moving too fast for you and we'll get your questions. Alright. So, this grid, I'm going to spend a minute on, because it's a little complicated, I think, especially as it comes to regional agencies.

23:58

So, again, edit buttons on the page, click Edit.

24:05

And then for each jurisdiction, so this grid is really large. Just kinda wanted to point out on my screen, I have kind of a scroll bar for the browser I'm using.

24:16

And then, this grid, and it's the only grid that has this, has its own scroll bar within the grid.

24:23

You'll see why, I'm pointing that out in just a moment.

24:27

So, if I go in here, and Edit, kind of takes up the whole page, and I don't necessarily see that.

24:34

I think a lot of you would probably expect to see that Save Cancel button right about here.

24:39

But because this grid is so wide, to kind of come down in a scroll bar, and you scroll across, it's really centered within a form.

So, the Save button, you have to scroll to the right to find it, and the reason for that is because of these column headers, right? We have it split between residential and commercial.

24:59

I have to go back down, so I can get to that scroll bar.

25:04

The reason we did that is if you potentially have different ... container collection systems.

25:10

For residential commercial, we wanted to give you the option to be able to specify that In the rain. Right. Here's where I'll start talking about these checkbox waivers.

25:22

But you select the programs.

25:24

And you will see that those boxes for a number of generators on gray now becomes a required field. So I'll enter my numbers, which I know are probably pretty small. It's all that is required on this page. And then, you go over, and you click Save, and it records that entry.

25:41

And then you move your way through the rest of the jurisdictions, OK?

25:49

These checkboxes here will only show up if you've been approved by the department for a Rural Exemption, or low population waiver, or not, or an elevation waiver.

26:01

Article 17 is referring to that high performance, because there's a lot of things you do not have to report if you go with performance based collection system, and what this is doing well on. So, if we on Check It, and then try to save.

26:19

You'll see, and again, I know it can be a little frustrating.

26:21

We'd love some feedback on massive how it goes for near using it.

26:27

You'll see I have the error messages that I have to do something, and there's if I check it for rural exemption.

26:32

Since collection is not required, if you have a rural exemption click save.

26:37

it bypasses that entry and allows me not to enter anything that's doing qatada here.

26:43

I'll just use another example and the same goes for low population.

26:48

I check that box and click Save.

It doesn't require that information.

26:53

So, based on some of the limitations of our system, we're unable if you only have certain census tracts that are waived and others are not too, get that granular.

27:06

So even though this allows you to bypass this section is still the responsibility jurisdiction to know what you have to report on.

27:14

And we have that signified in this note kind of up at the top which we're going to adjust the wording and text of that a little bit, but then same general message apply, that's still the jurisdiction responsibility to report on the sections that you're required to report on.

27:29

So, even though that low population will show up for you if you do have some census tracts waved, you stop to report on the ones that are not waived.

27:40

So you can still check this box and then also check whatever may apply as far as your collection systems, and then enter that required information.

27:52

Additional details is optional, See the no red asterisk that's just there if you need to enter any notes, such as maybe when food waste, your food to a paper collection may begin, if you're not quite collecting that.

28:07

And then to update that record you just click Save.

28:10

So you will have to do that on a per jurisdiction basis.

28:14

one other feature I wanted to point out with this particular grid so you have additional Hollar button.

28:22

This is here for those jurisdictions that may have more than one hauler.

28:25

If you only have one you can just use the first line and enter the information. But if you have multiple that you need to add you.

28:32

Click this button as a drop-down for the jurisdiction that you will want to associate it with.

28:38

Put a hauler name here which is not required.

28:42

I mean, it's required in the report, but the actual haller name is not required, and that's just really to keep all the information organized. So you can see, we have our examples of ..., too.

Specify that collection system that they may have.

28:59

Enter the numbers here.

29:03

Then scroll down, scroll over, save that holler.

29:08

Then you'll see it kind of pop to cloverdale now.

29:13

one with that original entry. And then one for that next taller that you may have. You can do this as much as you want for all the jurisdictions depending on how many hollers you need to add here to specify all those collection container systems.

29:29

OK, Loud materials and green to container and collection facilities.

29:37

And, again, I just want to point out, these will only show up if you have one of the department approved exemption or waiver, otherwise, these checkboxes will not be an option for you.

29:49

As you go into this grid.

29:51

Couple of things, I want to show, this one's a little bit large as well, but not wide.

29:56

Required to answer the question of yes or no, there's no, you know, you'll see it stays gray. No further information is required.

30:08

If you do select yes, you will see that it turns white, so I can identify it.

30:11

So for organics allowed to be placed in plastic bags or compostable plastics allowed, the regular regulations only specify that you have to identify the facility.

30:23

So you can say it by, you know, by address or however you want to identify at these tables that you see you at the ... numbers put in here for convenience.

30:33

So if you want to just use the RDS number, the facility, to identify it, you can just pick it out of the list and move it over.

30:42

We will be adding a kind of a tool tip right about here, which we'll link over to our DRS search page, if you're not sure of the number, so you can more easily find it to pick it out of this list.

30:58

Then you just click Save on that record.

You just kinda move through, So like, on, all of, these are just had picked multiple facilities. You can pick as many as you want, or you can just identify it however else you like.

31:15

So that's how that.

31:18 Grid functions Oops, sorry.

31:21

It's showing you the wrong line. That's how this grid functions as Identify column.

31:25

Then the difference I want to point out in the organic waste haulers grid as the regulations require that you pick the ... number of the facility that's processing the organics here.

31:40

So that's why there's not an identify the facility box. Here you have to pick the number and move it over.

31:49

You'll see the rural exemptions checked. So really, I do not need to enter in your information.

31:53

If you have that rural exemption, you can click save, no further information is required.

32:00

Go into it, take that off, try to hit save, prompts, and with error messages, which then requires me to enter that information.

32:13 Hit save.

32:15

To do that for each jurisdiction, we hit the save buttons down at the bottom of this page, Save buttons are the same ones that are at the top, and click either one.

32:25

Save that information.

32:28

Then you'll see that you're done with a section, the same as you always have with that green check mark right here, telling you that pick that section is done.

32:38

You can click this hyperlink here to move on or click up here to move on.

32:43

All right, we'll pause again. There's any other questions?

32:48

Andrea Yes, there's a question from Valerie Meza, what if you'd have to haulers in a city or a county area? How do you report that?

Yeah, so let me so the way you report on that. It's kind of how I showed you.

33:05

So you have your list here.

33:07

I mean, well, for this example that you're asking me about, let's say the county, right? So Sonoma, Unincorporated County Region Region, here.

33:16

did I just break it, I think I just broken here. We go, sorry.

33:20

Forgetting my own steps to activate the page with that it Edit the county.

33:28

Oops, sorry.

33:30

Not doing that the right way.

33:32 Click Additional Haulers.

33:35

Pics and Oman Incorporated can identify it however you like.

33:42

Specify the system for that color.

33:46

Enter the number of generators that have that collection service.

33:52

Scroll down. Grab that grid scroll bar.

33:55 Save the hauler.

33:59 And you'll see it now has two lines.

34:03

So you can use this first line for all or one, second one for hollered, to penny and add another one additional dollar.

34:11 Go back down to sonoma Unincorporated color too.

34:17 Say I have a two.

34:22 Enter this information here.

34:25 Grab that scroll bar of the grid. 34:28 Save hauler.

34:33

Now you have the three entries that answer your question.

34:40

It looks like it did. Perfect. Any other questions?

34:45

Not at this time.

34:46

All right, yeah, OK, so I'll move on to commercial programs will click on this one, didn't prompt me that I didn't say I'm information. I'll click Cancel.

34:58

Save that, to add, updated those records, so if you click OK, it's gonna wipe out anything you previously input at, I think that becomes more important. When there's a ...

35:08

programs, and you're modifying those program details, You wanna make sure to hit Save Your Page, before moving over to the Program Details Pages, Commercial Programs.

35:19

This is where we start blending things together. So you'll see kind of our note up here.

35:25

Regardless of the container, and this is really just to capture whatever collection container system you may have, whether it be 3 plus 3, 2, or one. But the focus and material types collected here are those that are diverted, not the ones that are disposed.

35:41

We put them in sub categories just to break it up. So there wasn't a giant list of things here. Entries are not required in each of these sections.

35:52

But you just check all the materials that are being diverted from disposal as they apply for all jurisdictions within the regional agency and these in these checkbox sections.

36:01

So this is, instead of having to enter it for each jurisdiction, all of them combined with care.

36:09

Remember this Describe, Material box?

36:11

Kinda for examples such as this?

36:14

Or if there's anything else you'd like to tell us. That it's being diverted. You can type that in this box here and it's not a required field. It's just there for convenience.

Then in this shree Program section, I went through and checked all the boxes, but you will be required to check all these boxes to ensure that those program details are current.

36:38

So you can click on the hyperlink. I'm not going to here since I already showed you that.

36:42

If you need to update anything but again, those diversion tons are already pre populated with zeros so you won't actually need to go in there and click anything.

36:51

I will show you, I guess the other way here, on the notes box.

37:01

Just to show you that if all you wanted to do is enter that note, You do not have to amps.

37:05

Let me save that so it actually goes there.

37:12

And we're not going to do large venues, so that's why I was getting that Error messages section isn't complete, but if I go here, you'll see that note I entered is showing up in that notes box. So if all you want to do is type something, you can do that all within the air, and you don't need to go to this Program Details page.

37:29

All right, we'll go back.

37:34

OK, So, again, just have to check these boxes to verify the program. Details are still current for all the commercial programs.

37:46

There's two pieces of information available on the screen, as far as venue and event information, and what should be reported, and what constitutes a large event, and down here, at the bottom, I said, come back down, Do you have a couple of options? one, you can say you had no reportable events operate this year.

For ease of access. For ease of getting through this, I am going to do that and show you the specific fields that need to be completed when you tap into that.

Zoom in a little bit, says incomplete, because even when you copy over the previous year's info, there are still a few fields that need to be updated.

On the basic info tab, you can update, if there's any changes on the, on the mailing, a physical address. And on the practices tab. And this is the thing that catches everyone every year.

There's couple items that need to be updated on this, the implementation level, of the venue and event, and I hope after this, many years of this being requirement, they are somewhere in the 76% range, if not higher, As well as dispose tons and diversion tons.

And you can put whatever tons in here you want. If you don't have any, you can just put zeros in press save.

And then this was, those were the three things you need to update when you copy over and event.

You'll also have the ability to, that is the material types, either what is generated or what is diverted as well as associate to any other local programs that jurisdiction may have.

So now that this one is updated, you'll see down here at the bottom of the screen that there is no more incomplete at the bottom, and that the section itself is now green and checked off.

When you come in, you will see a set of disposal numbers from our RDS system.

And this is a snapshot, as of the, right now, it's a snapshot as of a few days ago. This is not the final disposal data you're seeing on the screen, nor is it the final population, or employment information a little bit lower.

It will be the final disposal data will be based on a snapshot of close of business.

Monday, June 13th, so any changes in the earth's system prior to that will be reflected in the calculator when this year opens on June 15th.

And there are some links to different pieces of information as far as the DRS reports and the user guide and disposal modification for, and down here in the calculator, you can press edit.

And when you're filling this out, if you have no changes, all you do is have to press Save that will mark. The section is complete. If there is an issue with your disposal, well, well, you don't edit the individual.

Medical waste is a very specific type of medical waste from a regional diversion facility. Regional diversion facility has a very specific definition of items that go to a diversion facility, a source separated materials.

C and D waste is specific to construction demolition waste that falls outside of the jurisdiction's purview such as a Caltrans project or some type of Federal construction project and out of State export.

56:32

If it was noted as disposal, they went out of state.

56:35

But you can prove it was actually diverted and other disposal amounts which generally applies to things like grape stakes and or quarantines. Green waste if you had to be disposed because it can go to a composting facility out of the county or something.

56:54

All the descriptions of each of those types of waste are included in the disposal. Modification, for I'll let this load it.

57:03

Does take a minute two items on here that are still noted, but no longer can be edited, or for disaster waste, and for Class two waste. Because, after the transition to the ... Reporting system, those two types of disposal should not be tracked as from the jurisdiction of origin and would not be reported in ... with a jurisdiction of origin.

So, those two types would no longer need to be modified out of a report.

57:34

They should be fixed in our DRS, if they were included with the overall, in the Stubby total.

OK, form opened up here, so, on the disposal modification for this, too, was updated last year, and it was one little adjustment made this year.

At the beginning, sort of, know who you are, what you do, and what you're looking to get changed.

Then, on this page, we have some, Excuse me, we have some information about the system and how you make file an online complaint, if you're having issues with RDS facilities, and getting data corrected or adjusted in that system.

Then as you go to the next page, here, are those descriptive, specific descriptions for each of the types of disposal reduction credits that can be claimed.

If you meet the correct criteria, then each type will know which specific piece can highlight that, which specific section of the, the form needs to be filled out as you continue through it.

the areas of concern and conditional approvals. This is related back to the original set of planning documents that were approved by the California Great Waste Management Board, sometime in the late eighties, early nineties, in some cases, the early two thousands. And if there was any specific item noted, that was an area of concern.
