Our regulations will allow entities other alternatives for capturing origins, such as host-assigning tons to the jurisdiction in which the facility resides.

Since these materials are already being reported as solid waste, this should not require any change in reporting in RDRS.

SB 343 is focused on products and packaging that display a chasing arrows symbol and ensuring products are labeled appropriately. If biosolids are labeled with the chasing arrows symbol, then they must comply with SB 343's recyclability requirements.

Meza	VALERIE	10:30:24 AM PDT	So will the hauler need to separate out the plastic residual waste and report that as part of the transfer waste??	Haulers are not required to sort their materials for the purposes of reporting. Current regulations require that materials mixed with solid waste are reported as solid waste. So, if a hauler gives a T/P a mixture of solid waste and plastics (e.g., residential mixed waste), then the hauler should report that entire outflow as solid waste (meaning, give origins for all the material to the T/P). This will not change in the regulatory updates. However, in our proposed regulatory updates, if a hauler handles mixtures of plastics and other recyclables, which do not contain solid waste, then the hauler will need to treat that mixture as "mixed plastic waste." In the regulatory updates, a hauler will have to give origins for mixed plastic waste materials to the destination T/P.

Thanks	Yes, we are going to adjust existing RDRS regulations somewhat. We currently plan to cover these changes at the second workshop.

The material characterization study data will be available 1 Jan 2024. The RDRS data comprise two components: 1) outflows of recyclable materials, and 2) collection method for inflows of recyclables. RDRS already collects the former dataset and we anticipate publishing a public report with non-confidential data regarding recyclables around January 2023. For collection method, however, we anticipate that RDRS data will not start gathering those data until 2024 Q4, but that date could change during the rulemaking.
