10:11:22:Presenter: Summer to early fall this year, site assessments are ongoing and structural debris removal effectively. This past weekend, Calrecycle met the contracting requirements of this year's Mission task request.

10:11:37:Presenter: Using the master services agreement for field assessment and monitoring, consultants and accepted Tetra Tech response plan to support environmental and documentation services needed for this operation, Anvil Builders was awarded the debris and Hazard.

- 10:11:51:Presenter: Tree removal contract through the use of the departments pre qualified bidders list. Today we have 161 parcels enrolled into the state managed program, one of the neighborhoods impacted by the mill fire.
- 10:12:04:Presenter: Was Lincoln Heights in the town of Weed? We spoke to wildfire survivors Denise and Chester Hopkins who lost their home this year and have signed up for the states managed and funded debris removal program.
- 10:12:26:Presenter: My wife's mom lost her house back during bows fire, so we knew exactly what was going on from the bowls fire and stuff like that, and it was a good thing to get to debris removal, so we didn't have no way.
- 10:12:38:Presenter: Because the time because we know that was gonna be one of the things that we gotta have done and you know and that's and we had talked to our insurers and our insurance. So this money is just located just for the.

10:47:27:Presenter: Money, because I was chair of the Commission and I think we did do a lot of good work and I know you called in a couple times, so thank you so much for caring.

10:47:42:Presenter: So I did want to say on this, on this carpet item on America recycles day, America is not recycling enough carpet. There's about 4% of the waste stream. It's all fossil fuel based. Most of it now is plastic.

10:47:55:Presenter: And there's a lot more that could be done in California, really, led by passing the first carpet stewardship bill in the world. And it was an experiment.

There was a lot of fighting going on when we first the bill was sponsored by the author. 10:48:09:Presenter: And didn't get everything we wanted and it's got a visible fee. And I always said that we should never be giving public money to private sector groups to run the program. If they want the right to run the program, they should have use their own money and that also gives them the internalized.

10:48:22:Presenter: Us to drive design change and I think today with the letter that and the plan that they have, it's further exemplification of why I feel so strongly about that this program is not working as planned.

10:48:35:Presenter: In the SB54 discussions and negotiations, I repeatedly brought up how many times care has failed to hit. The goals have been fined. It's like kick the ball, drag care, kick the ball drag care. And this is not working for a public program.

10:48:49:Presenter: The public is not getting what they wanted, and we aren't getting what we intended in the bill, so they're for all the reasons we had laid out in our letter.

10:49:52:Presenter: Good morning. I'm Bob peoples. I'm the executive director of care and I will agree director. It's nice to be back together in person.

10:50:01:Presenter: I wanna say that care is proud of the program that we've accomplished and achieved working with the recycling community here in California. 10:50:05:Presenter: And we're going to continue to build on that success.

10:50:19:Presenter: This plan that you had before you was a very talented, capable and dedicated group of people, professional people. It was not drafted by me or the carpet industry. The effort was led by Cascadia.

10:50:34:Presenter: Insulting gigantic idea studios aprio accounting firm Abby Bean as an independent consultant, all recognized as experts by Cal Recycle. These people are all highly regarded professionals who understand.

10:50:37:Presenter: The California Statutory and regulatory requirements.

10:50:42:Presenter: What seems to be clear is that Cal.

10:50:59:Presenter: What seems to be clear to Cal Recycle was not clear to this team and points to the complexity in some of the cases and the inconsistency of the demands being placed on care at this time. A case in point.

10:51:11:Presenter: To not understand why the absolute pounds of recycled output would drop signifies a lack of integrating key parameters on the part of the agency.

I know because I have the data. I plotted it. I shared that with you today. 10:51:52:Presenter: My email if you measure care on the same criteria as other

programs, the 2022 recycling rate will actually come in at close to 80%.

10:51:55:Presenter: Let me restate that.

10:52:09:Presenter: If we applied the same recycling rate calculation as used by the mattress program, we would be at close to 80% today when I shared the difference in these calculation rates with.

10:52:25:Presenter: I recently spoke with they admitted they were unaware that we're different calculations used to calculate the recycling rate, and agreed that there needs to be a common rate between them so you could compare programs.
