Andrew Parrish (CalRecycle): meaning garbage, sledges and other discarded solid materials resulting from residential activities and industrial and commercial operations.

Andrew Parrish (CalRecycle): means, solid waste, containing material originated from living organisms

Andrew Parrish (CalRecycle): and their metabolic waste products, including they're not limited to food, green material, landscape and pruning waste organic textiles and carpets.

Andrew Parrish (CalRecycle): is a dumpster that's approximately 4 feet by 4 feet by 6 feet.
