SUBJECT: Statewide Average Monthly Scrap Value Notice for January 2023

California Code of Regulations (CCR), Title 14, Section 2985 (b), requires the Department of Resources Recycling and Recovery to provide written notification of the monthly statewide weighted average scrap values for beverage container material types reported to the department by participating certified processors.
