Re: CalRecycle's Completeness Determination of MED-Project's 2022 Annual Report and 2024 Annual Program Budget for Home-Generated Sharps Waste

Dear Dr. Travis:

The Department of Resources Recycling and Recovery (CalRecycle) received MED-Project's 2022 annual report and 2024 annual program budget for home-generated sharps waste on March 31, 2023, titled, *MED-Project 2022 Annual Report; State of California, Sharps and MED-Project 2024 Annual Program Budget; State of California, Home-Generated Sharps Waste*, respectively, the latter of which included an independent financial audit of MED-Project's stewardship programs titled, *MED-Project CA, LLC; Financial Statements for the Year Ended December 31, 2022*. Public Resources Code (PRC) section 42033.2(d)(1) and Title 14 of the California Code of Regulations (14 CCR), section 18973.1(b) require CalRecycle to determine if the annual report and annual program budget are complete and notify MED-Project of its determinations within 30 days of receipt (i.e., by May 1, 2023).

Staff reviewed MED-Project's 2022 annual report and 2024 annual program budget for home-generated sharps waste for completeness pursuant to the requirements in PRC sections 42033.2(a) through (c) and 14 CCR sections 18973, 18973.1(b), 18973.5, and 18973.6 and found the annual report and annual program budget complete. These completeness determinations are separate from the compliance determinations that CalRecycle will now conduct pursuant to 14 CCR sections 18973.1(d) through (f). CalRecycle has 90 days from the date of receipt of the 2022 annual report and 2024 annual program budget for home-generated sharps waste to review for compliance with all statutory and regulatory requirements and approve, conditionally approve, or disapprove the annual report and annual program budget (i.e., by June 29, 2023).
