NOTICE

To: All Interested Parties

Subject: 4th Quarter 2023 Processing Payment Adjustments

Section 14575 of the Public Resources Code requires the Department of Resources Recycling and Recovery (CalRecycle) to establish a processing payment for any beverage container type that has a scrap value less than the cost of recycling. The calculation of the processing payments is based on the difference between the scrap values offered to recyclers and the sum of the actual costs of recycling for certified recycling centers, excluding centers receiving handling fees, plus a reasonable financial return. CalRecycle makes processing payments to processors. Processors pay recyclers the entire processing payment.

CalRecycle has discretion to adjust processing payments not more than every three months if the department:

- Determines the statewide scrap value paid for a specific beverage container
 material type for the most recent available twelve-month period directly
 preceding the quarter the processing payment is calculated is five percent more
 or less than the scrap value used as the basis for the processing payment
 currently in effect.
- Funds are available in the processing fee account for the material type.
- Adjusting the processing payment is necessary to further the objectives of the beverage container recycling program.

PROCESSING PAYMENT ADJUSTMENTS:

Effective October 1, 2023, CalRecycle will adjust the processing payment for glass and #1 PET as noted in Table 1. The change in scrap value for glass and #1 PET, for the 12-month period of July 2022 through June 2023, is greater than five percent.

The processing payment for #2 HDPE, bimetal, and plastics #3 - #7 are not being adjusted.
