

Beverages subject to California Refund Value (CRV)

Beverage Container Recycling and Litter Reduction Act: PRC Section 14504

The following products packaged in aluminum, glass, plastic or bimetal beverage containers:

- **Beer and Malt beverages...** for example: Budweiser, Coors, Corona, Heineken, Smirnoff Ice, Mike's Hard Lemonade, White Claw, Truly
- **Carbonated Water, including soda and carbonated mineral water...** for example: Pellegrino Sparkling Natural Mineral Water, Crystal Geyser Sparkling Mineral Water, Perrier Sparkling Natural Mineral Water
- **Noncarbonated Water, including noncarbonated mineral water...** for example: Evian Natural Spring Water, Dasani Purified Water, Fiji Natural Artesian Water
- **Carbonated Soft Drinks...** for example: 7Up, Coca-Cola, Mountain Dew, Pepsi, Sprite
- **Noncarbonated Soft Drinks...** for example: SoBe Lifewater, Country Time Lemonade, Vitaminwater, Visvita Aloe Vera Drink, Don Jose Horchata, Califa Almond Milk
- **"Sport" Drinks...** for example: Powerade, Gatorade, Pedialyte Sport
- **Carbonated Fruit Drinks (All Sizes 1/1/2024)...** for example: Martinelli's Sparkling Cider, Izzy Sparkling Juice, Welch's Sparkling Juice Cocktail
- **Noncarbonated Fruit Drinks that contain any percentage of fruit juice (All Sizes 1/1/2024)...** for example: Snapple Juice Drink, Hawaiian Punch Fruit Juicy Red, Minute Maid 100% Orange Juice
- **Coffee and Tea beverages...** for example: Starbucks Frappuccino Coffee Drink, Lipton Iced Tea, Arizona Green Tea, Kombucha
- **Vegetable Juice (All Sizes 1/1/2024)...** for example: V8 Vegetable Juice, Odwalla Carrot Juice, Campbell's Tomato Juice



Effective 1/1/2024: The following products packaged in box, bladder, pouch, aluminum, glass, plastic, or bimetal beverage containers:

- **Distilled Spirits...** for example: Tito's Vodka, Mailbu Rum, Tanqueray Gin, Don Julio Tequila, Jim Beam Whiskey
- **Wine, including sparkling & alcohol removed ...** for example: Beringer White Zinfandel, Mumm Sparkling Wine, Woodbridge Cabernet Sauvignon, Sutter Home Fre, Dom Perigon Champagne, Barefoot Chardonnay
- **Wine Coolers and Distilled Spirit Coolers (All % ABV 1/1/2024)...** for example: Jack Daniels Can Cocktails High Noon Vodka & Soda, Woodchuck Hard Cider, Arbor Mist Strawberry Moscato
