We continue to coordinate with the LEA and the community to look for solutions. We understand the significance of this issue

and just really appreciate the callers for calling in and bringing this to our attention. So more to come in the coming months.

So on today's agenda, we'll have updates on our Packaging EPR law. We'll talk about some of our beverage

container grants and new grants and deadlines for those grants. We'll have an update on our tribal work.

Let's see what else debris and many other things. So we'll get to that in just a few minutes.

But first, I wanted to take this moment to introduce our new deputy director for legislative and external affairs.

She went out into the into the world for a little bit and did some work with the private sector and we're super excited to invite her back to CalRecycle.

So I'm sure you'll be hearing from her in coming months as we have exciting legislative updates. Welcome, Allegra.

So now, CalRecycle, Deputy Director over disaster debris Recovery operations.

5:21

Jen Hogan has some updates for us. Good morning, Jen. Good morning. Thanks, Zoe. 5:28

So CalRecycle's incident management teams and contractors are currently deployed for structural debris and hazard tree removal on the park.

5:34

Thompson and Burrell Fire burn scars. We've also been mission tasked by CalOES to conduct the cleanup

5:39

for the Boyles Fire in the city of Clearlake. I just wanted to take a moment to recognize the impact

5:46

on California citizens. Our sympathies go out to all those whose lives have been impacted

5:51

by the wildfires this season, particularly those who have lost their homes. It's not lost on us

that these events changed the lives of impacted Californians forever. And we are proud to be a part of the state's multi-agency

6:02

recovery team helping Survivors move forward. CalRecycle is committed to our mission to expedite debris recovery so that homeowners can begin to rebuild.

6:10

And we are honored to serve California in this space.

6:26

Okay, I forgot about the second slide. Someday I'll get my stuff to.

6:33

Today, we received enrollment forms for 45% of the properties destroyed in those four fires.

6:39

Our assessment and monitoring teams have done site reviews for 94% of those properties, which is an essential step before crews mobilize to a site.

6:47

Asbestos abatement is underway as well as biological and cultural reviews on each property.

6:53

Both debris removal crews deployed on November 12th and will be working for the next few months to safely remove toxic ash and debris and ensure

7:00

that the property and the soil are clean and safe for rebuilding.

7:06

And for that, sorry, let me start over. Written comment period for the proposed revisions to the Plastic Pollution

Prevention and Packaging Producer Responsibility Act draft regulations

9:41

that ended on November four. Thanks to everyone who sent comments and staff are reviewing

9:46

written feedback and considering changes to the draft regulations. We're currently in the 45 day public comment period

9:53

for the draft program Environmental Impact Report. Just a reminder, there'll be a public hearing today here in this room

10:00

at the CalEPA headquarters building at 1 p.m.. Staff will present information on the report and accept in-person

10:08

and Zoom comments. If you'd like to submit written comment, you have until 5 p.m. on December 19th to do so.

CalRecycle preferred method to submit comments is through the online portal. For more information on how to submit comments,

please visit CalReycle's SB 54 webpage. The SB 54 Advisory Board held two meetings this month on the first and the 15th.

The next meeting is planned for December 13th and check out CalRecycles events calendar for more information.

Moving on to Dealer Cooperative program updates, CalRecycle is advancing reforms to give Californians more options to cash in their beverage container deposit.

10:48

Here's a quick video reminder of what dealer cooperatives are all about.

10:54

Check it out. In 2025, the law changes for California grocery stores and beverage retailers

11:01

with new rules for redeeming beverage containers and new opportunities to bring in more customers, receive payments from the state,

11:07

and join the movement to California's circular use Waste free future. If you sell CRV beverages but don't have a recycling center nearby, listen.

11:16

Starting January 1st, 2025 stores under 5000 square feet or less than \$1.5 million in annual sales are exempt from redemption requirements.

11:26

After you register with CalRecycle, remaining stores in areas not served by recycling centers have two choices.

11:32

One set up a system to redeem beverage container deposits in-store or to create or join a nonprofit dealer cooperative to redeem beverage containers.

11:42

The new dealer co-op option comes with state funding support for each container redeemed and flexibility

11:47

to use new redemption methods like automated reverse vending machines, where consumers can feed in their beverage containers for payment, mobile

11:55

recycling operations that can move around to serve different neighborhoods on different days or bag drop redemption sites

12:01

where consumers can drop off bags of material for later payment. Go to CalRecycle.ca.gov to learn more about

12:07

dealer co-ops.

CalRecycle held a workshop last week to provide an overview of the dealer cooperative requirements.

The department also released a draft of its model Dealer Co-op Stewardship Plan. It breaks down the elements

redemption methods, consumer convenience standards, and more. We're welcoming feedback on the draft model plan through December 2nd.

Thank you. You know, I can't see any of you

that my glasses. I just have a couple quick updates

13:37

about documents that the department has received and is currently reviewing. The first is Carpet America Recovery efforts Differential Assessments,

13:46

Plan Amendment, and we're currently asking for feedback. You can, through November 22nd, send those comments

13:55

to Carpet@calrecycle.ca.gov. And the director is going to be approving 14:01

11.01

conditionally approving or disapproving that document by January 7th.

14.06

And a decision is going to be announced at an upcoming meeting. The next one is the Drug Takeback Solutions Foundation.

14:14

They submitted revised 2023 and reports for cover drugs and their home

generated store or home generated Sharps waste stewardship programs in response to CalRecycle's disapproval of those items earlier this summer.

14:29

Those documents, again, are under review, and the director has until December 26 to determine if they're compliant.

14:37

You can find more information on CARE's differential assessment plan amendment or the foundation's revised annual reports linked in today's agenda.

Good morning, Carol. Good morning, everybody. Good to see you all. And for those of you who are online, thank you for being here.

California has covered electronic Waste Management program, is housed in the Materials Management and Local assistance division.

15:19

And as you may all know, we have been in process of implementing 15:24

new legislation, SB 1215, which adds embedded battery products to the program.

15:30

So I'm super excited about the expansion of the program with these many new products. And also it presents an opportunity for modernizing 15:38

the e-waste program that's been in place for many, many years now. So at this time, I'd like to introduce Martine Boswell.

15:44

She is our manager over the e-waste program. Martine?

15.52

15:58

Thank you, Kara. Recent legislation SB 1215 added battery

and better products to the covered electronic waste recycling program. CalRecycle held emergency rulemaking workshops in person

16:06

on August 19th and virtually on September 18th. Emergency regulations will be submitted

16:13

to the Office of Administrative Law at the end of this year. These proposed regulations are intended to meet and.

Fulfill the most urgent statutory. Mandate, which requires CalRecycle to adopt regulations to establish.

16:28

A process for recyclers to submit payment. Claims for battery embedded products.

16:33

CalRecycle will develop more regulations in 2025 to carry out and clarify the law.

16:41

Sign up for Electronic waste Recycling Program Updates on CalRecycle's Gov Delivery System.

16:47

Back to you, Maria. Thanks, Martine. Now to public comments.

16:52

Do we have any public comments in the room right now on the plastic pollution prevention Law and Dealer Cooperative implementation updates the Extended 17:02

Producer Responsibility Program updates or the East Bay E-waste Program Expansion?

17:08

Any comments in the room today? It looks like there are none. And are there any online? Yes.

17:17

We currently have two calls on the line. Let's first go to 7412.

17:23

You're up first, Please state your name and affiliation.

17:36

Hello, this is this is Susan Collins from the Container Recycling Institute

17:41

and I appreciate the update on the dealer cooperatives. I wanted to ask a few follow up questions.

17:48

I'll I'll actually go through all of them. I have like four or five questions, but they're all related to each other.

17:54

And it all has to do with when exactly are dealers or retailers

18.02

expected to comply with the new program, as you described it, either

18:08

take back in store or join a dealer cooperative. And I always say that I'm uncertain about this because of

18:16

the other implementing pieces of the regulation.

18:22

So so the statute says that the retailers have to comply January 1st of 2025.

But I'm wondering, is that really the date that they have to comply or do they have more time because of the approval date

18:36

of the model stewardship plan and the dealer co-op regs? So my my questions are several.

18:44

First is when do the dealers have to comply? The second is, are the dealer co-op regulations

18:52

fully approved or is the approval process not yet, through all of its stages? And when when would the dealer co-op regs be fully, fully approved?

19:02

And same with the model stewardship plan. It's out for comment right now. When will the comment period be finished

19:11

and that be amended and then fully, fully approved? Thank you very much,

19:17

Susan. Thank you for for your questions and for, you know, highlighting some of these these issues.

19:23

We're understanding that we're we have many concurrent regulatory processes going on

19:30

with many new requirements for different participants in the program.

19:35

So appreciate your ask for clarification because these are important questions. For your first question, when do dealers need to comply?

19:43

You're right. As far as the statutory language, there is that requirement that by Jan one dealers are either

19:50

redeeming in store or that they've joined a dealer cooperative. But we're understanding that, you know, we're still going through the process

19:56

of dealer registration and that this is a significant change to the program.

20:02

So with any of our programs as we're realizing these significant changes, our interest is to, of course, provide that compliance assistance

20:12

to bring those entities into compliance as quickly as we can. But also

20:17

just to be transparent from the enforcement side of the House, utilize our enforcement discretion appropriately.

20:23

So our hope is, is that in the very, very near future, the new ecosystem for beverage container redemption will be more clear.

But we understand that there's a number of things that have to happen to get us to that point from first off, getting the dealers registered,

20:39

all the dealers finalizing the regulations, receiving the dealer cooperative plans,

20:45

providing that assistance to dealers through that process, and ensuring that we have the information

20:53

to best explain or to best represent, rather, what decision the dealers within California have made.

21:01

So I'll stop there, but I'll check in with Amy or Michelle to see if they had any anything they wanted to add to that.

21:12

Thank you. Thank you. And we are working on dealer registration

21:20

and they will need to begin redeeming and store on January

21:25

1st, 2025, unless, of course, they meet the requirements for the exemption

21:32

and then as dealer co-ops get finalized, that's when they will have the opportunity to switch over, if that's what they choose.

21:40

Thank you. Thank you, Amy. And then the approval process for the dealer cooperative regulations, I can say that

21:50

they have not been approved yet, but they are. We are working through our process. And as soon as we have an update on timing, we can provide that to you.

21:59

I don't have that now, but our hope is that we can move this regulation package relatively quickly so that

22:05

the dealer cooperatives have the certainty that they need to be able to to move forward. And then the stewardship plans.

22:13

Michelle, do you know the specifics there for the comment period? Yes. So the model plans will be final when when the regs for final.

22:23

Thank you. Thank you for your question, Susan.

22:30

Now, moving on to the second color. 1109 Please unmute and go ahead with your comment.

22:46

1109 Can you hear us?

This is Heidi Sanborn with the National Stewardship Action Council. Thank you for taking my comments

22:59

for regarding item number one on SB 54. I know the law because we were there 23:07

when it was written as the expanded polystyrene data

23:12

be delivered to recycle by January 1st of next year, it's not that far away.

23:19

Six weeks on whether they had the 25% recycling rate and then also basically on the same date, which is probably not a great idea

23:28

in the bill, is the date when it would be banned if they didn't hit that recycling rate. So I guess my question is, I'm hearing

23:35

from a lot of people who are out doing organic site visits of restaurants, that the restaurants have absolutely no idea that the EPA food work

23:44

could be banned early next year and they're just proceeding to buy it. Should local governments be educating the restaurants about that

23:53

to the or the haulers? Is that the pros responsibility, etc.? I guess that's a question. 23:59

And then I have others. Heidi, thanks for your question. And, you know, this is one of the first compliance deadlines in Senate Bill 54.

24:08

So we understand the significance of it. And I have received a lot of questions about this lately. So I'm just going to you clarified, but I'm also going to clarify

24:16

that requirement in statute, which is that producers of extended polystyrene packaging 24:24

and food service wear need to demonstrate to the department by Jan 125 that they've achieved a 25% recycling rate.

24:31

And if they're unable to do that or they do not demonstrate that, then they are no longer able to offer

24:38

for sale, distribution or import into the state of California EPS food serviceware so the requirement is a demonstration

24:46

for all EPS packaging and food serviceware and then the

24:53

the compliance piece after that is specific to EPS food serviceware so it's a little bit nuanced.

24:59

And I hear you on the both things happen at the same date. So that's just not feasible.

So I think we had an analysis at a public meeting several months back that our team had sent out notifications to the

25:14

the producers that we could find that we know are producing extended polystyrene to notify them of this requirement and to ask them to please

25:21

provide us with that data. We anticipate will receive that data or receive something by Jan one

25:27

that the department can take a look at, make a determination, and then figure out what the next steps are, the path forward from that point.

25:35

So more to come after the first of the year when we know more. You had asked the question about of food service

25:42

establishments and the importance of them understanding these requirements under the law and what may happen past Jan one.

25:52

And, you know, our goal is to make sure that with Senate Bill 54, that 25:58

all those that will be implemented are affected. Best understand the law. So we can take a look at what we have in our website and and make sure it's

26:07

abundantly clear what this requirement is specific to extended polystyrene.

26:12

But as as we've discussed it, it wouldn't be appropriate for the department to go out now and

26:20

make any determinations or provide outreach to those jurisdictions specific to what may happen after Jan one.

26:28

But what we can do is make sure that everyone's aware of what those requirements are in the law to answer all all the parts of your question, I feel like I missed something. 26:37

No, you did. I think that was great. I guess my my advice to local governments then, is to just as you're out

26:43

talking to the restaurants anyway regarding organics or some other reason, please let them know that this could be coming

26:48

so that they're at least starting to prepare and think about it. And I have comments on other agenda items too, if that's okay.

26:56

Agenda Item four on Carpet. Of course, we support increase of the assessment 27:01

for making sure that program is fully funded and has an adequate reserve, but we continue to be disappointed that the eco modulated fee

27:10

is not a minimum 10% on the carpet tile especially, which is 6.22%.

27:17

And we know that that does not drive green design. It has to be at least 10% or higher. All the studies show that

27:23

and I wish that was being addressed, but I know they're working on a study. But there we know enough and there's enough studies already done to know what to do. 27:31

So I wish that was being addressed in this proposal. So I just want to make that comment and will be submitting a letter on Friday,

27:40

a joint comment letter actually. And then on item number five on Sharps, I want to let you know that we are hearing

27:46

from multiple jurisdictions from San Benito to Rancho Cucamonga

27:52

to Sonoma, that the Med project had apparently sent out a letter a week 27.58

before they stopped reimbursing for Sharps. They gave almost no notice to the local governments.

28:05

And when you know, I worked very hard on that bill, the whole plan was that they get reimbursed, worth

28:11

the costs, get covered, they're allowed to switch how they do it, whether they're reimbursing or they're going to pick up the needles.

28:18

But giving them a week's notice is not okay. They don't have time to review the contracts or do anything.

28:25

And then they were also feels like blackmail. Honestly, to say Med project is telling them 28:30

we are not going to pay them for what they already did until they signed a new contract that we're okay to come pick up the needles.

28:37

And that does not feel right to me at all. So we're advising local governments to go bring this

28:42

to their legal teams and possibly the D.A. But that feels very, very wrong.

28:49

And they should just pay these local governments. But I guess I'm wondering, what is CalRecycle doing?

Are you fully aware of that situation? What can we do to inform you more if you're not aware of it?

29:02

How do you thank you for your comments on the carpet issue? And then I appreciate your observations and sharing the observations

29:10

and what you've been hearing from local jurisdictions. On the project issue that you mentioned.

29:16

We will discuss internally and provide follow up if appropriate, but I appreciate you flagging.

29:23

Thank you. And we've already emailed Victoria and that project and I've not heard back, so it's been almost a week.

29:29

So we're trying to reach out to them and find out what's happening, but wanted to report that it was brought up at the House of Hazardous Waste Information Exchange.

29:35

And then last question, I guess it would be on the directors report. We haven't seen the 343 data released, the formal publishing of the preliminary

I guess the published updated preliminary findings report. Is that coming? 29:50

Yes. I can't give you a date, but we're working internally on it right now.

Good morning, Katrina. Thank you, Maria. My office works closely with tribal nations and as well as working

31:33

with historically underserved communities to strengthen partnerships, improve access to resources, increase protections

31:42

and lessen environmental burdens through meaningful engagement. CalRecycle has been actively engaging with tribes this year to help inform

31:50

and advance California's historic circular economy reforms. Let's take a look at this short video overview.

31:59

Together with tribal nations, California is building a waste free future with less trash and climate pollution and more repair, reuse and repurposing.

32:08

Mother Earth has just given over the years and given it's time to start giving back. California honors Native American tribes rich history and thoughtful stewardship

of our planet's resources. The value system was within the land, and it's not, you know, item or thing.

32:24

You take care of it. You don't. Polluted. California Values Tribal Perspectives to help shape new ways to take on trash

32:31

and climate pollution, like cutting single use plastic and packaging waste. We're using natural fiber to replace

32:38

replaced plastics single use packaging. Expanding edible food recovery, and community composting for food sovereignty.

32:46

Tribal communities have a natural food system that's 20,000

32:52

years old that sustained us for that long, and it didn't have any plastics at all.

32:59

In connecting tribal businesses with state support to keep materials in use. We brought in \$700,000 worth of CRV

to our community so that it doesn't go into landfills. Tribal nations are key partners in California's move from a disposable

33:13

throwaway system to a circular reuse economy. Tribes are using their natural stewardship

33:21

on their traditional knowledge to create economies. Not only helps our community, but helps our earth.

33:28

That's what we're here to do.

33:35

Great. Thank you for that video. Within that video, you saw a bit of CalRecycle work to meaningfully engage with tribal nations this past year.

33:44

Some of those clips were directly from an engagement that was co-hosted by the Native American Fiber Program and Big Valley Band

33:51

of Pomo Indians up in Clearlake area. And it was a really great event.

33:57

So appreciate them for supporting us. We've also engaged with tribes through California's Zero Waste Plan, hosting a tribal listening session.

34:05

We also attended and presented at the 2024 Tribal EPA and U.S.

34:10
