TO ALL OPERATORS/OWNERS OF SOLID WASTE LANDFILLS

Title 27, California Code of Regulations (27 CCR), Division 2, Subdivision 1, Chapter 6, Subchapter 3, Article 1, section 22236, requires you to submit a report annually to the California Department of Resources Recycling and Recovery (CalRecycle). The report calculates the inflationary increase in the closure, postclosure maintenance, and/or corrective action cost estimates for the previous calendar year.

Based on information obtained from the U.S. Department of Commerce, Bureau of Economic Analysis, Table 4, dated March 27, 2025, the inflation factor for **2024** is **1.024 (2.4%)**. Please complete the **2024 Annual Inflation Factor Report** for each landfill you own and/or operate, and send it to the **Financial Assurances Unit** at the following email address by **June 1, 2025**:

For example, if the cost estimates were prepared in 1989, apply the 1989 inflation factor to your 1989 initial certified total closure and postclosure maintenance cost estimates and so forth, until the current inflation factor is applied.

Do not disregard this notice. If you recently revised your estimates due to changes in your closure, postclosure maintenance and/or corrective action plans, and the revised estimates reflect 2025 dollars, please report your updated 2025 cost estimates.

Information regarding the total and remaining permitted capacity at your landfill(s) should be submitted under a separate mailing.

For public operators utilizing a Pledge of Revenue Agreement, the operator is required by 27 CCR section 22233(b)(4)(B) to submit the <u>CalRecycle 114</u> form to demonstrate the pledged revenue continues to be available when needed and will cover the postclosure maintenance and/or corrective action cost estimate(s) identified in the updated 2024 Annual Inflation Factor Report required by 27 CCR section 22236. The operator is required to submit annual certifications of the <u>CalRecycle 114</u> form with the 2024 Annual Inflation Factor Report (copies of the resolution and agreement are not required annually, unless amended).

2.) Multiply each cost estimate by the inflation factor to determine the new adjusted cost estimates as illustrated below:

The ABC Landfill's cost estimate for CLOSURE in 2024 was \$2,000,000. Using the 2024 inflation factor of 1.024, they recalculated their ADJUSTED CLOSURE COST for 2025 to \$2,048,000. Their POSTCLOSURE MAINTENANCE (PCM) COST with a Multiplier of 30 in 2024 was \$1,500,000. Using the 2024 inflation factor of 1.024, their ADJUSTED PCM COST for 2025 is \$1,536,000. Their cost estimate for CORRECTIVE ACTION in 2024 was \$1,000,000. Using the 2024 inflation factor of 1.024, they recalculated their ADJUSTED CORRECTIVE ACTION COST for 2025 to \$1,024,000.

NOTE: If the cost estimates identified above were prepared in 2025 dollars, do not inflate below.
