**Notice of Extension of Written Comment Period**

The written comment period is extended and will now end on **September 9, 2025**. This is an extension of seven days from the original written comment period as published on July 18, 2025.

The hearing will still be held on September 2, 2025, as described in the Notice Of Proposed Action published on July 18, 2025.

**WRITTEN COMMENT PERIOD**

The written comment period permits any interested person, or their authorized representative, to submit written comments addressing the proposed amendments to CalRecycle. Written comments, which offer a recommendation and/or objection, or

support the proposed amendments, should indicate the amended section to which the comment or comments are directed. CalRecycle will only consider written comments sent to CalRecycle and received during the written comment period, which begins on July 18, 2025, and ends on **September 9, 2025**. Written comments received by CalRecycle after the close of the public comment period are considered untimely. CalRecycle may, but is not required to, respond to untimely comments, including those raising significant environmental issues. ## ERRATA

### Errata to Regulation Text Published on July 18, 2025

It has been brought to CalRecycle's attention that the originally published proposed regulation text contained errors that are not reflective of the changes CalRecycle seeks to make for this rulemaking. Omitted language is language that was not intended to be noticed to the public because there are no effective regulatory changes offered by the omitted language. There are two types of omitted language that were included. The specific sections affected are listed below. The corrected regulation text accompanies this Addendum and is also published on CalRecycle's website at <https://calrecycle.ca.gov/laws/rulemaking/permanentid/>.

#### *Inclusion of Omitted Language*

The proposed regulation text included language in strikeout after three asterisks (e.g. \*\*\*). This gave rise to confusion as to whether CalRecycle was making any changes to this language. This error affected the following sections and the provisions that should be omitted as not being changed or amended by the proposed regulations are as follow:

- **17402(a)**- specifically subsections (a)(8) through (a)(33)
- **17414**- specifically subsections (a) through (h)
- **17414.2**- specifically subsections (a) through (a)(10) and (c) through (f)

- **17852-** specifically subsections (a)(1) through (a)(14), (a)(15)(C) through (a)(24), and (a)(25) through (43)
- **17868.1-** specifically subsections (a)(1) through (a)(2)(A) and (b) through (c).
- **17869-** specifically subsections Preamble, (a) through (d), and (f) through (k)
- **17896.45-** specifically subsections (a)(1) through (a)(6) and (b) through (l)
- **17896.58-** specifically subsections (a) and (c) through (d)
- **18304-** specifically subsections (b)(1) through (b)(4), (b)(6) through (e), and Supplement.

### *Inclusion of Omitted Language*

The proposed regulation text included strikeouts of additional language. Typographically, this language was represented as both underline and strikeout. To prevent any confusion regarding the actual text that is either being deleted or added, CalRecycle has made technical corrections to the following sections:

**17410.5-** specifically subsection (a)(2) language that is both in underline and in strikeout has been corrected and the section now accurately reflects the changes CalRecycle is seeking in the proposed rulemaking.

**17852-** specifically subsection (a)(24.5) language throughout this subsection that is both in underline and in strikeout has been corrected and the section now accurately reflects the changes CalRecycle is seeking in the proposed rulemaking.

**17868.6-** specifically subsection (a)(2) language that is both in underline and in strikeout has been corrected and the section now accurately reflects the changes CalRecycle is seeking in the proposed rulemaking.

**17869-** specifically subsection (e)(5) language that is both in underline and in strikeout has been corrected and the section now accurately reflects the changes CalRecycle is seeking in the proposed rulemaking.

**17896.62-** specifically subsection (a)(2) language that is both in underline and in strikeout has been corrected and the section now accurately reflects the changes CalRecycle is seeking in the proposed rulemaking.

### **Errata to Initial Statement of Reasons made available on July 18, 2025**

The purpose and necessity of the proposed regulation text for Section 17896.45 titles the discussion as Subsection (a)(5). This is erroneous and it should be titled (a)(7). This error will be documented in the Final Statement of Reasons at the end of the rulemaking.
