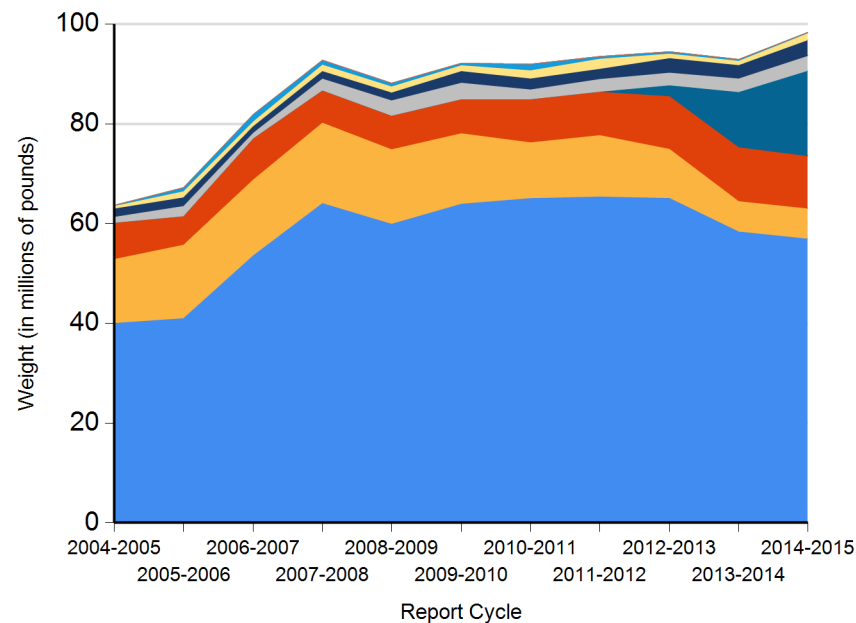


HHW Disposition By Disposition Method (City of Folsom
