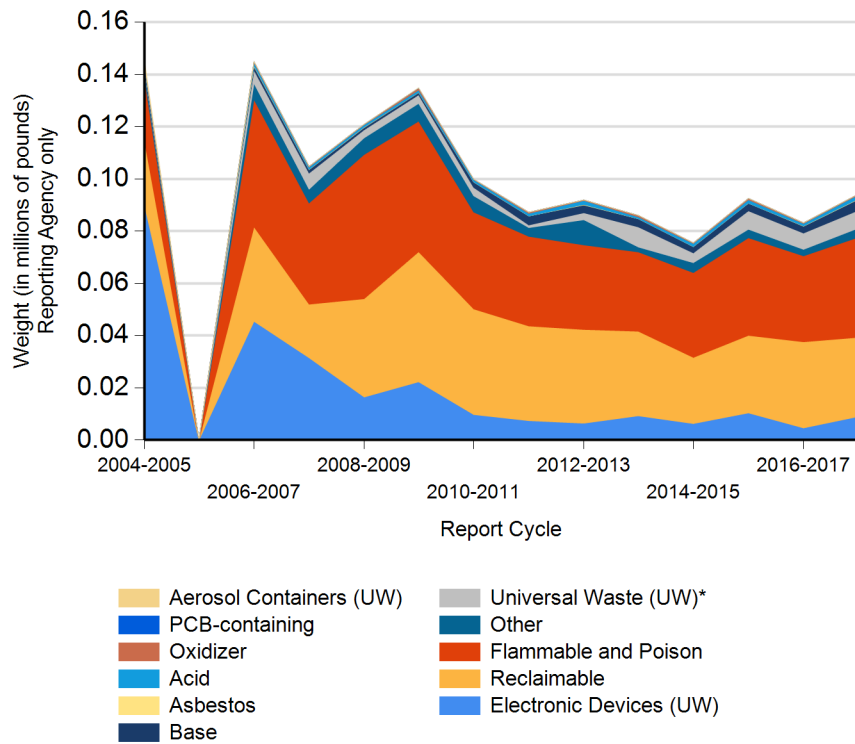


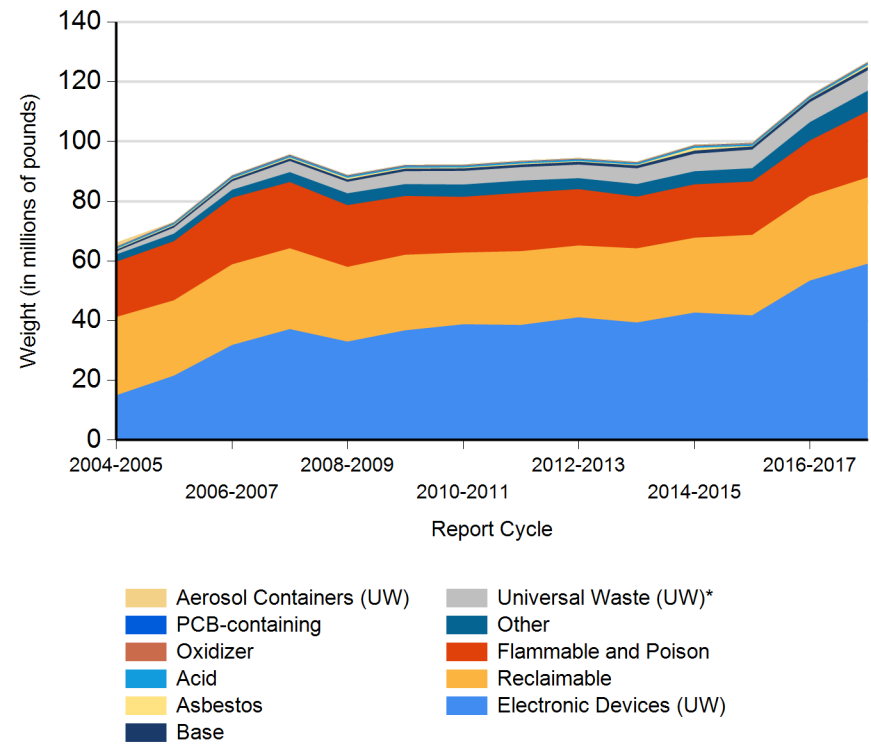

HHW Collection By Material Categories (City of La Mesa)

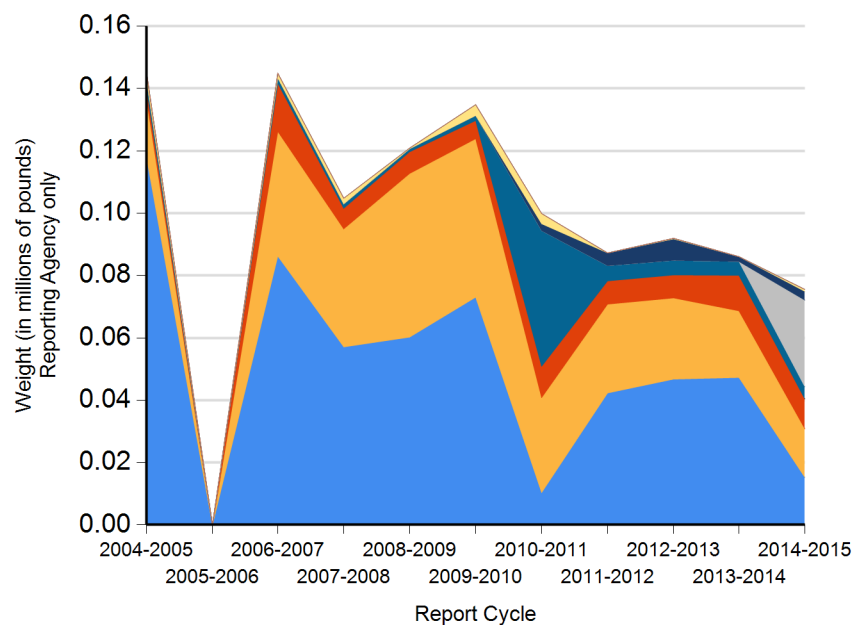


HHW Collection By Material Categories (Statewide)



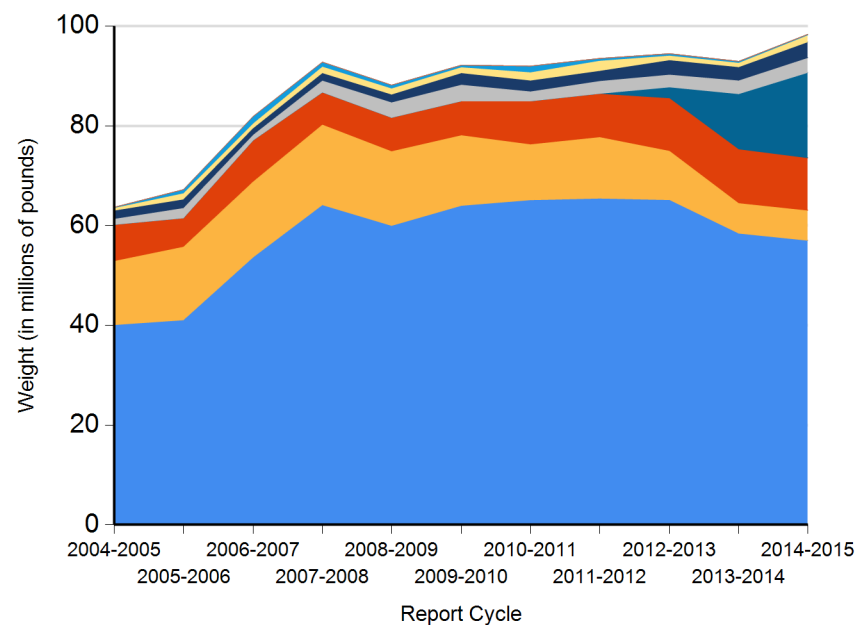


HHW Disposition By Disposition Method (City of La Mesa)
