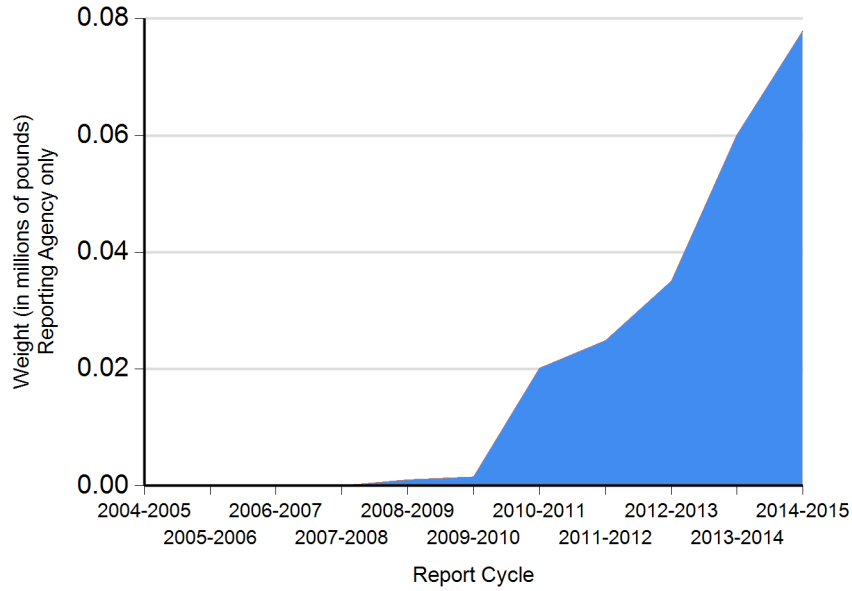

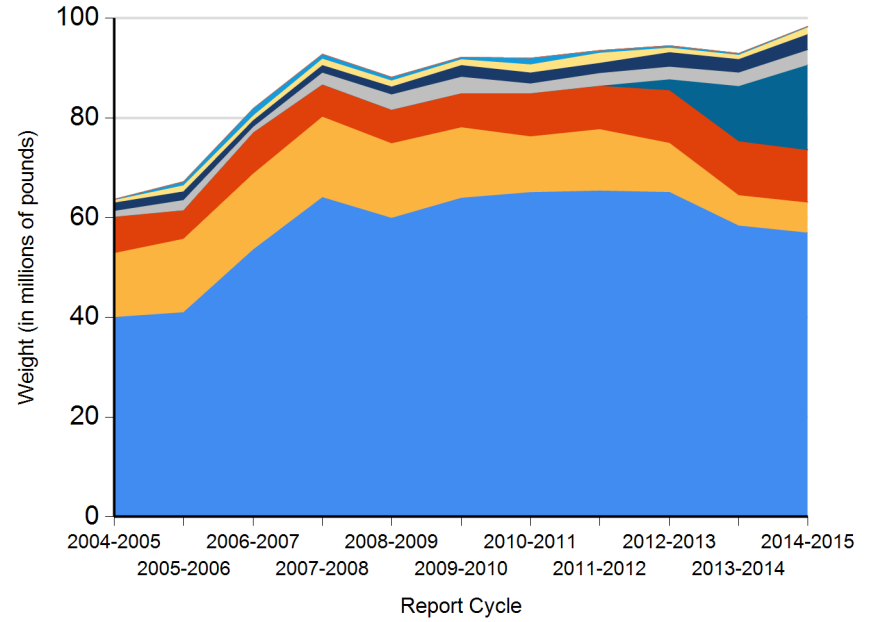


HHW Disposition By Disposition Method (City of Rancho Palos Verdes)
