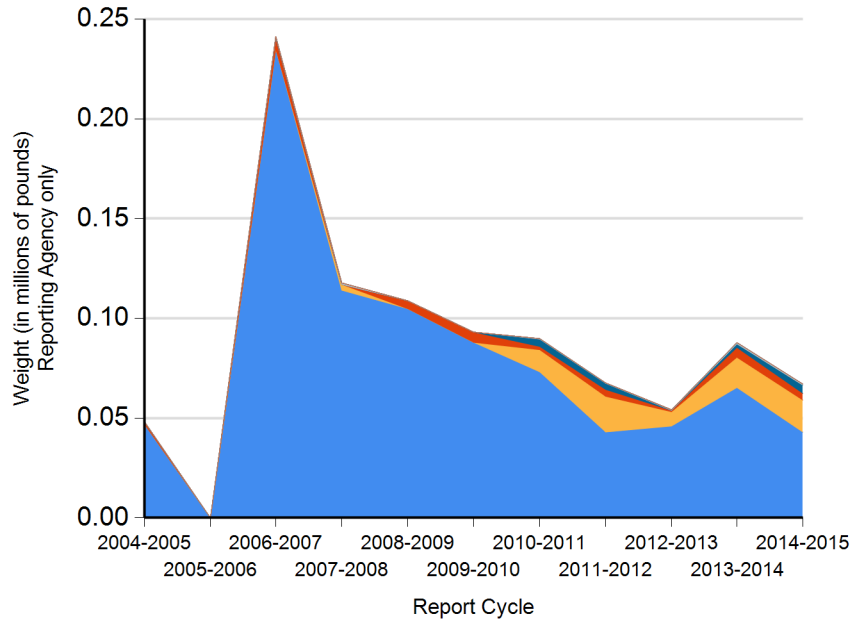

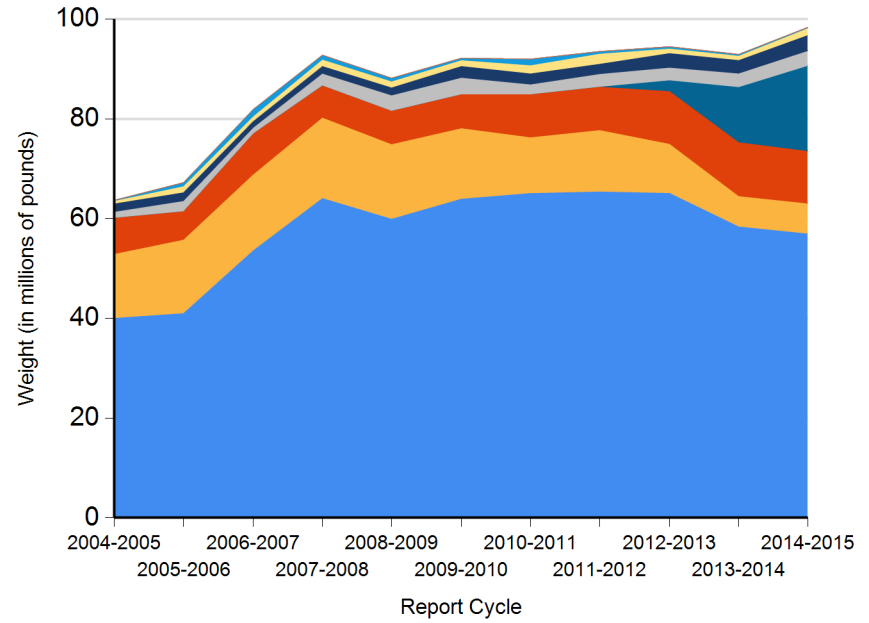


HHW Disposition By Disposition Method (City of La Habra)
