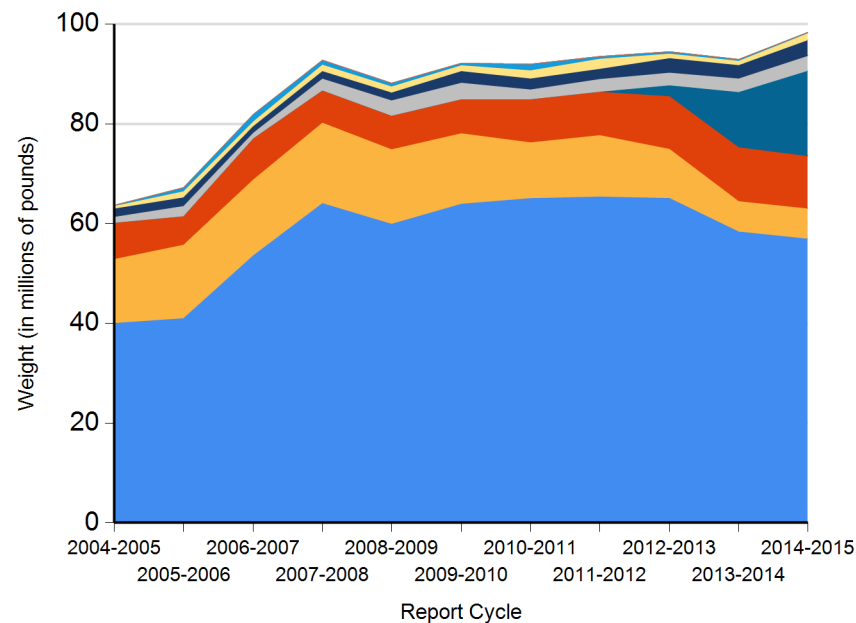


HHW Disposition By Disposition Method (City of Benicia)
