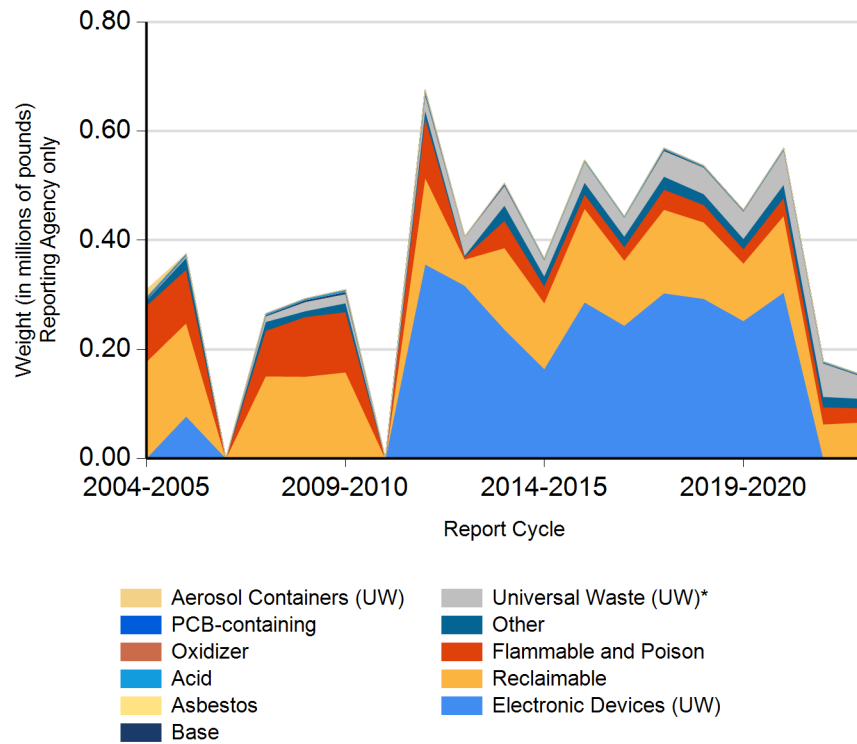


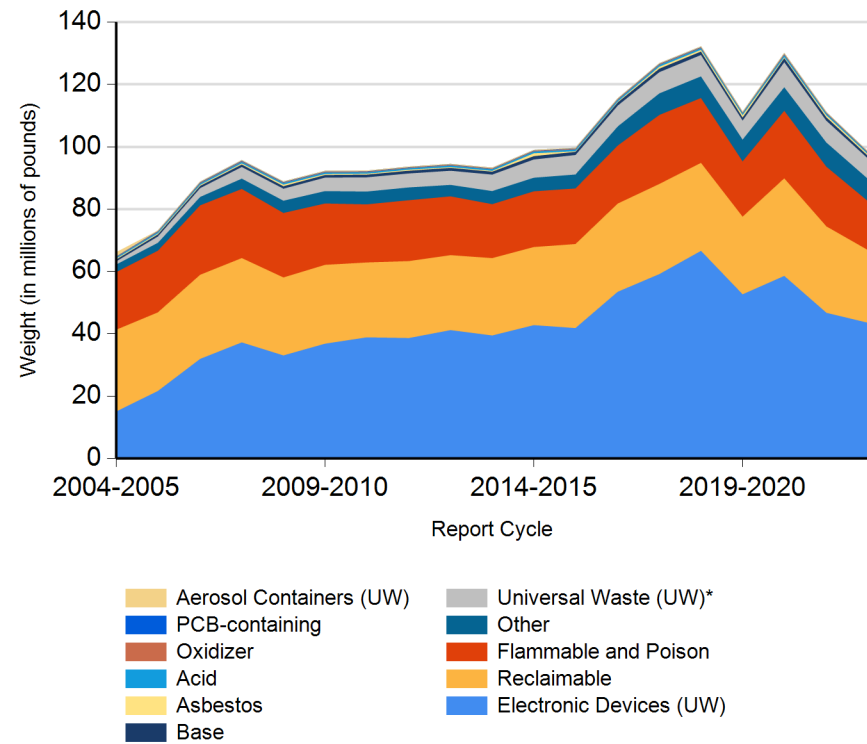

HHW Collection By Material Categories (City of Oceanside)

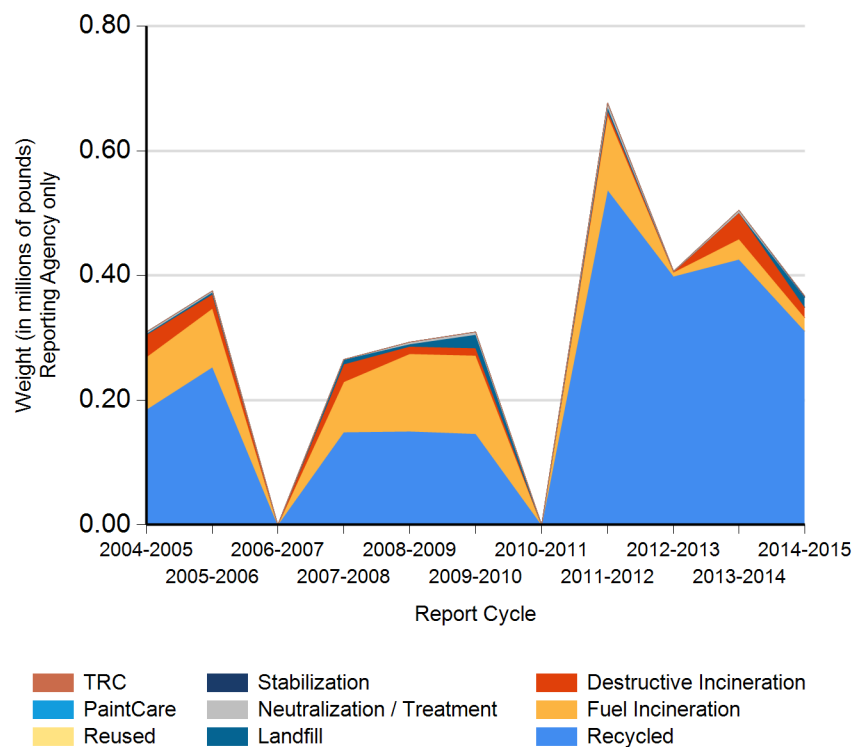


HHW Collection By Material Categories (Statewide)

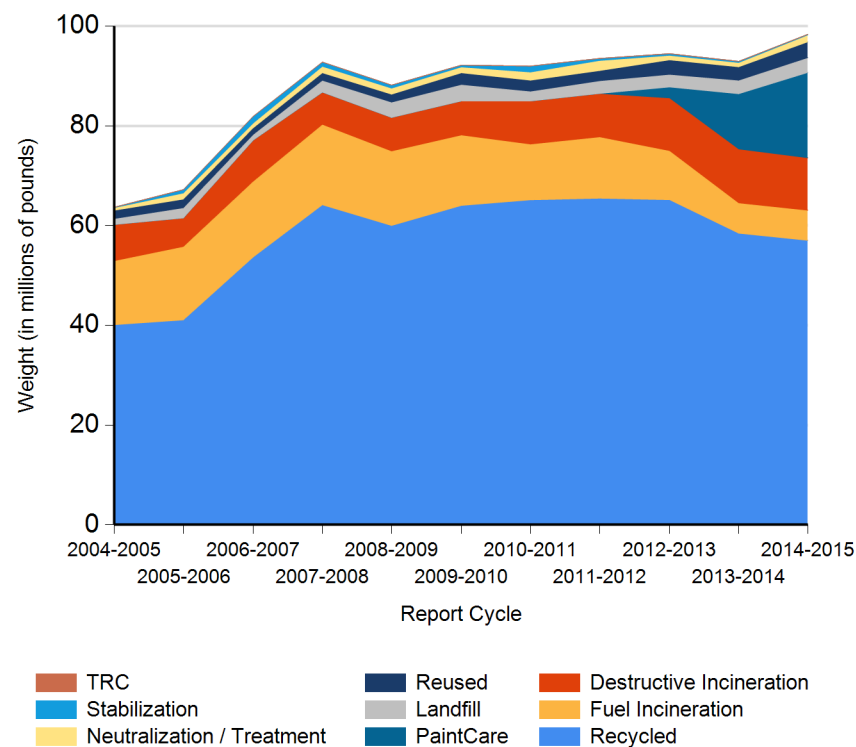




HHW Disposition By Disposition Method (City of Oceanside)
