## TITLE 14

Extension of 45-day Comment Period and Rescheduled Public Hearing Proposed Regulations - Sustainable Packaging for the State of California Act of 2018 (SB 1335)

Office of Administrative Law Notice Reference Number: Z-2020-0303-05

**NOTICE WAS GIVEN** on March 13, 2020, that the Department of Resources Recycling and Recovery (CalRecycle) proposes to add to the California Code of Regulations, Title 14, Division 7, Chapter 4, Article 8 commencing with Section 17989 and initiated a 45-day comment period. The proposed regulation is intended to clarify processes and develop criteria to determine the types of food service packaging that are reusable, recyclable, or compostable as required by the Sustainable Packaging for the State of California Act [Chapter 610, Statutes of 2018 (Allen, Senate Bill 1335)].

## **PUBLIC HEARING**

On March 4, 2020, Governor Newsom proclaimed a State of Emergency in California, as a result of the threat of COVID-19. On March 20, 2020, Governor Newsom issued a "shelter-at-home" order to preserve public health and safety. In light of these conditions, CalRecycle has determined that **the public hearing originally scheduled for April 28, 2020, shall be postponed until May 21, 2020.** The public hearing time and location are as follows:
