Commissioner Ward presented a policy proposal on carbon farming. Commissioner Ward and Commissioner Lapis will revise the draft recommendation to include the Healthy Soils Initiative before moving the proposal to the full Commission for review.

Commissioner Ward also proposed adding information on existing programs related to food waste and community composting to the resources section of the report.

Commissioners voted unanimously to include these resources in the report.
