

#### **AB 179** (Ting, Chapter 249, Statutes of 2022)

- Budget appropriation to provide funding to increase Consumer Access through additional redemption opportunities and invest
  in recycling infrastructure to produce Cleaner Material Streams.
  - \$73M Funding for Recycling Centers, RVM, Mobile, and Bag Drop Recycling
  - \$50M for quality incentive payment program
  - \$40M for thermoform material
  - \$30M for start up loans for processors and recyclers
  - \$5M for workforce development
  - \$10M for plastic market development payments
  - \$25M for reusable containers

#### AB 793 (Ting, Chapter XXX, Statutes of 2021)

- Regulation language has been submitted to OAL and is available for comment now through March 21, 2023

#### SB 1013 (Atkins, Chapter 610, Statutes of 2022)

- Expands convenience zones from  $\frac{1}{2}$  to one-mile
- Adds wine and distilled spirits January 1, 2024
- Requires wine and distilled spirits be labeled July 1, 2025
- Exempts "small" dealers starting January 1, 2025
- Authorizes dealer cooperatives January 1, 2025

#### **DEALER COOPERATIVES**

Dealer cooperatives are 501(c)(3) nonprofit stewardship organizations that dealers may join in lieu of redeeming in store when in an unserved and unexempt convenience zone. The Dealer cooperative will operate according to a department approved plan to redeem used beverage containers from consumers in convenience zones that are unserved by a recycling center and are not otherwise exempt.

#### Timeline:

- March/April- Workshops on Dealer Registration and Dealer Cooperatives
- June/July- Submission to OAL with 45-day comment period
- January 1, 2024 through July 1, 2024- Regulations take effect on Dealer Registration and Dealer Cooperatives
- January 1, 2025- Dealers in unserved unexempt convenience zones can either redeem in-store or join a dealer cooperative

# CALIFORNIA'S BEVERAGE CONTAINER RECYCLING PROGRAM

**OVERVIEW** 

AB 2020 (Margolin, Chapter 1290, Statutes of 1986) enacted the California Beverage Container Recycling and Litter Reduction Act (Act) also known as the "Bottle Bill".

Established the California Refund Value (CRV) deposit on beverage containers and an 80% recycling goal.

**CRV** is 5¢ for bottles and cans less than 24 ounces, and 10¢ for larger ones.

#### **DEALERS**

"Dealer" means a retail establishment which offers the sale of beverages in beverage containers to consumers.

- No limit in number of beverages sold
- No limit on what type or focus of retail sales
- Tasting rooms and consumers are not considered dealers for on-site consumption

#### DEALER RESPONSIBILITIES

Ensure CRV beverages are labeled with a CRV message.

The CRV portion is subject to sales tax if the sale of the beverage is subject to sales tax.

Dealers with a location greater than 4,000 sq ft (sales and storage combined) must display CRV separately from the sales price on all advertising and shelf labels.

Post required signage regarding the nearest redemption opportunities.

Provide redemption in-store **or** pay \$100 per day to CalRecycle if the dealer is located in an unserved convenience zone.

#### WHAT IS A CONVENIENCE ZONE?

- A convenience zone (CZ or "zone") is the area within 1-mile (previously  $\frac{1}{2}$  mile) of a supermarket.
  - Rural may be up to 5 miles of a supermarket
- All CZs must have a recycling center operating within each zone unless certain conditions exist that allow for granting an exemption for the entire zone.
  - CZs with a recycling center are "Served"
  - CZs without a recycling center are either "Unserved" or "Exempt"

## CZ STATUSES IMPACT DEALERS

- Dealers in "served" or "exempt" zones are not required to redeem instore or pay \$100 per day.
- Dealers in "unserved convenience zones" are required to either redeem empty CRV containers in-store **or** pay \$100 per day to CalRecycle to avoid having to redeem in-store.
  - If you are in an unserved zone, you may choose to host a recycling center at your location to serve the zone; please contact us for more information
  - You may apply for a convenience zone exemption

Dealers in unserved CZs are subject to the Notice Series based on PRC 14571.7. These notices will be mailed to your store.

**First Notice** 

Second Notice (Will be sent approx. 30 days after the first notice)

Final Notice (Will be sent approx. 30 days after the second notice)

In the notice process, you will be informed of the date that your affidavit choosing Option A (redeem in-store) or Option B (pay \$100 per day) is due.

Option B dealers will receive courtesy invoices for the \$100 per day. It is vital that dealers verify the address on the notices received is correct as that will be the same address where the invoices are sent. It is the dealer's responsibility to pay the \$100 per day, even if the invoice is not received.

Served	1,827	47.4%
Exempt	486	12.6%
Unserved	1,463	38.0%
Hold	78	2.0%
Total	3,854*	100.0%

# THE CZ SB 1013 LANDSCAPE

Provides the status (served, unserved, etc) of convenience zones organized by county or city.

# CONVENIENCE ZONE STATUS REPORT



Only supermarkets are listed; not every dealer in the zone.

# **CONVENIENCE ZONE EXEMPTIONS**

SB 1013 limits the number of CZ exemptions to a maximum of 15%.

#### Interested parties may apply for a CZ Exemption:

- Submit application for convenience zone exemption (CZ remains unserved during the exemption review)
- CalRecycle solicits public comment
- CalRecycle notifies affected party of exemption decision
  - Statutory timeline CalRecycle has to process exemption applications is 6 months

# SPECIAL NOTE FOR SB 155 DEALERS

Dealers that were notified during the exempt period that they are in an unserved convenience zone, but were exempt as a small business under SB 155 – your affidavits are due.

 If you haven't submitted your affidavit due to your cycle starting during the exemption period, your affidavit must be returned by February 15<sup>th</sup> or you will be defaulted into Option B (paying \$100 per day)
