Please be advised that the Department of Resources Recycling and Recovery (CalRecycle), serving as Enforcement Agency (EA) for Stanislaus County, is providing this public notice as part of the process in considering a modified Solid Waste Facility Permit (SWFP) for Turlock Transfer. This public notice was prepared pursuant to Title 27, California Code of Regulations, Section 21660.3.

Project Description

Turlock Transfer is an existing transfer/processing facility operating under a Full SWFP issued on February 8, 1999. The application package to modify the SWFP requests the following: Addition of organics processing activities, construction of a new transfer/processing building, and updates to the documents that describe and/or restrict the operation of the facility and the EA conditions of the SWFP, and updates the Transfer Processing Report (TPR). There will be no change in the current permitted area, hours of operation, or maximum tonnage.

EA's Determination

On March 24, 2023, the EA accepted the application for a modified SWFP submitted by Turlock Transfer, Inc. The EA's preliminary determination is that the proposed changes qualify for a modified SWFP since the changes are such that the SWFP does not need to include further restrictions, prohibitions, mitigations, terms, conditions or other measures to adequately protect public health, public safety, ensure compliance with state minimum standards or to protect the environment, pursuant to Title 27, California Code of Regulations, Section 21665.
