Please be advised that the Department of Resources Recycling and Recovery (CalRecycle), serving as Enforcement Agency (EA) for Santa Cruz County, regulates Buena Vista Transfer Operation, Facility No. 44-AA-0016, located at 1231 Buena Vista Drive, in Watsonville, CA. This public notice was prepared pursuant to Title 27, California Code of Regulations (CCR), Section 21660.3.

Project Description

Buena Vista Transfer Operation is a new facility that will be regulated as a Medium Volume Transfer/Processing Facility under a Registration Permit pursuant to Title 14 CCR, Section 17403.6. The facility is located at the Buena Vista Drive Sanitary Landfill which is zoned for the type of operation as described below. The Registration Permit will allow for the following:

- Operation of a Medium Volume Transfer/Processing facility on 3 acres at the Buena Vista Drive Sanitary Landfill;
- Receive up to 99.9 tons per day of municipal solid waste;

- Operate Monday through Saturday, 7:30 a.m. to 3:30 p.m. (closed at 2:30 p.m. on Wednesdays); and
- Have 17 incoming vehicles per day and 10 outgoing vehicles per day.

The registration permit will be issued within five (5) days from finding the application complete and correct and accepted for filing.
