Background and Analysis

Statutory Authority

Public Resources Code Section 42889 authorizes CalRecycle to conduct studies and research directed at promoting and developing alternatives to the landfill disposal of waste tires and the development of new markets and technologies for both used and waste tires.

Program Background

CalRecycle’s Waste Tire Management Program strives to drive the state to a circular economy through activities that increase the recycling rate of waste tires by issuing grants, providing education and technical assistance, and conducting research to develop new and enhance existing markets for waste tires.

Summary of Work

This contract will assist and support CalRecycle’s efforts to increase the use of rubberized

asphalt concrete (RAC) in California. The Contractor shall provide RAC technology transfer, construction inspection oversight, and general technical support to grantees within CalRecycle's Rubberized Pavement Grant Program. The Contractor may be directed to conduct research on issues related to the use of RAC and may provide other technical assistance regarding RAC. This contract will provide education and technical assistance to public and private entities interested in RAC use.
