Project Summary: Public Services Department has been working collaboratively with Lake County Waste Solutions and South Lake Refuse and Recycling (the two local County franchise haulers) to enhance the existing program of the collection and disposal of HHW by providing a temporary but consistent location for materials to be dropped off. The events would occur periodically 6 times annually with the option of splitting events to create 12 - ½ day events in order to meet the State guidelines for a temporary facility. The County of Lake would like to alleviate the need for the mobile unit from Mendocino County – (HazMobile) and for convenience and habit create consistent drop off sites that would cover a variety of needs and would encourage individuals to recycle, properly dispose of HHW, and this would potentially prevent some of the illegal dumping that occurs in the County. The County of Lake is currently working collaboratively with both haulers to advertise and support Paint Care and Sharps disposal sites at both ends of the Lake. This only makes sense to also support the facilities in becoming somewhat of a one-stop shop for residents to drop off all their HHW. This funding would be used to do minor improvements to the existing facilities by helping to provide signs and appropriate bins as needed for the collection events. Public Services would assist in the advertising by providing educational outreach and marketing for the community. The facility would be operated by two HAZWOPPER trained staff at all times and appropriate equipment and gear would be utilized at every event in each location. County of Lake Public Services, Southlake Refuse, and Lake County Waste Solutions are working collaboratively on marketing and advertising to capture a large portion of the population by looking at new avenues for reaching specific target audiences. The purchase of promotional items for safely disposing HHW materials will be provided by the Public Services Department while funding and supplies last to promote, encourage, and support the community in their efforts to work toward the statewide goal of recycling more.

Project Summary: This individual grant application proposes to expand the promotion and collection of Battery Recycling programs in Costa Mesa schools, promote the public outreach for the Door-to-Door HHW program for seniors and disabled residents, and to promote and set-up a one-day Household Hazardous Waste (HHW) collection event. The Costa Mesa Sanitary District (CMSD) has funded and implemented an 8-month Battery Recycling pilot program that includes five schools as participants. CMSD desires to increase the number of schools involved in the project and to use grant funds to promote the program for the following year. CMSD proposes to increase the promotion of public outreach for our Door-to-Door HHW collection program for seniors and disabled residents. This program assists residents who do not have the ability to recycle or dispose of their hazardous materials at permanent HHW facilities, by offering a free curbside pick-up. CMSD has worked with the OC Waste and Recycling and Orange Coast College to coordinate the community's first HHW collection event in 2012. The event successfully diverted 36,000 pounds of HHW away from the landfills. If awarded, CMSD will use the grant funds for the following programs: • Battery recycling program (multi-day collection event for schools) in the amount of \$20,000 • Public Education for the Door-to-Door HHW Program for Seniors and disabled residents in the amount of \$5,000; and • HHW Collection Event (\$25,000) As required by CalRecycle, and to be consistent with CalRecycle's core values, the CMSD has adopted and implemented an Environmentally Preferable Purchasing and Practices Policy since 2008. Ordinance No.66 stated that the CMSD adopted a preference and exception for environmentally friendly products in purchasing and has since been added to the Operation Code Section 4.05.035 on April 21, 2008.

Going forward the refillable cylinders will be filled at various filling locations within the City who agree to participate in the program for a fee. The program will use the Got Ants! program developed in conjunction with the California Department of Pesticide Regulation and the San Francisco Estuary Partnership. The program, along with public outreach at local events, will seek to educate home owners about the potential for IPM in their home and motivate them to encourage hired landscape and pest management professionals to do the same. Research has shown that many homeowners are unaware of what chemicals are used by hired professionals. Research has also shown that targeting hired landscape and pest management professionals directly is challenging due to informal license arrangements and are less motivated by environmentalism. Targeting homeowners creates an economic incentive for hired professionals to consider IPM practices.
