Project Summary: The Town of Paradise (Paradise) proposes the expansion of our Permanent Household Hazardous Waste Collection Facility (PPHHWCF) to expand storage capacity for collected materials. This grant will expand Paradise's current HHW program by: 1) Expanding the facilities storage capacity by installing a 57' x 30' x 16' Pre-Engineered Building and associate concrete infrastructure; 2) Purchasing additional shelving and signage. Shelves will be built to store reusable material, as well as, material waiting to be shipped out for disposal (i.e. 55 gallon drums of HHW, thermostats, Gaylord's with paint destined for Paint Care etc.) Signage will display the proper HHW placards and associated HHW regulated information for employee and public safety. Paradise believes that expanding the PHHWF is an effective method for making sure our facility is equipped with enough storage capacity to handle the increase of material received as the popularity of the facility continues to grow as a direct result of previous expansion efforts

Project Summary: The City of Lancaster is proposing the expansion of its current Household Hazardous Waste (HHW) Facility. In effort to reduce the demand for HHW disposal, the City of Lancaster wishes to add a cardboard compactor/baler, a propane canister depressurizer, an aerosol can depressurizer, and a re-use structure for residents to "shop" from. Adding a re-use component to its current repertoire of services and enabling more products to be converted to recyclable materials, will reduce and offset HHW disposal while also diverting more material from the waste stream. Additionally, the City proposes to incorporate a couple safety and efficiency features for its collection workers. The installation of a storage container for onsite keeping PPE, first-aid supplies, tools, and equipment will reduce potential spill response time and improve overall functionality of the collection process. Also, a centralized eyewash/deluge station to offer immediate decontamination, and a shade awning to provide workers relief from the extreme summer heat, is proposed for safer and efficient HHW collection.
