**Project Summary:** Property owner purchased the property (the 20.1 acres of forestland) in September, 2011. The parcel is privately owned. In February, 2015, owner was excavating a portion of the property for an outbuilding. Owner discovered tires and metal solid waste at the site. Owner contacted Placer County Environmental Health to notify the department of what he found. Noting that the property was zoned as Farm, and being told that the property owner had no knowledge of the waste being on the property, the Environmental Health department suggested that the site may be a candidate for the CalRecycle Farm and Ranch Grant. Owner, knowing that there was no guarantee of funding per the grant, has started voluntary cleanup of the site. Site cleanup and re-grading should exceed grant total maximum. Approximately 5000+ tires (85 tons) have been recovered by the contractor of the property owner. Most have already been picked up by Tri-C, a registered waste tire hauler. Some wood and metal wastes have been found at the site as well. These are being transported to the Kiefer Landfill. The site excavation and disposal costs should exceed the \$50,000 grant maximum. On top of this, a separate contractor will be hired to restore the drainage at the site and grade the pad for the outbuilding. This would cost approximately \$16,000 more. The property owner understands that the grant maximum is \$50,000 per individual site and anything above this amount is his responsibility. Future dumping will be impeded due to placement of the proposed outbuilding.
