Collection at multiple locations will lower transportation costs and so lower total costs for all participating jurisdictions. Data will be gathered during the project toward an understanding of the scope of need for this service in the region and communities that most need the service.

Project Summary: Grant to be used as a component of a multi-faceted approach promoting sustainability to the County and its 15 jurisdictions through continued EXPANSION of the program to cost-effectively promote/facilitate a significant increase in the amount of HHW managed within the HHW Collection System which is made up of a Permanent HHW Facility and approximately 300 Network Host Sites (Network Sites) throughout the County's ~6,000 sq. miles, serving a population of about 1 million. The grant funds will be directly used for the HHW disposal cost portion of setting-up and operating various separate temporary/mobile collection programs servicing at a minimum 100 participants each, in the remote areas of the County (includes about 45% of the population or roughly 450,000 residents) which through surveys were found not to regularly use the Permanent Facility. The County and its jurisdictions are in full support of this project and thus the remaining mobile collection tasks such as advertising, registration, permitting, planning, set-up, and operations will be self-funded.

This is in addition to our mobile collections. Construction of our new facility in 2012 (with CalRecycle support) created a debt burden which also impacts our budget. We also are seeking to increase safe public disposal of medications, sharps and general HHW. Our program started operations in 1996 and important equipment needs replacement. Our grant request would cover essential equipment replacement, new safety equipment, and targeted public education through print media and Facebook.

Project Summary: The City of Lincoln does not collect household hazardous waste (HHW) material. Products such as paints, cleaners, oils, and pesticides need to be taken directly to the Western Placer Waste Management Authority (WPWMA) HHW Facility for disposal. This is a free service to all residents provided by the County. The City receives many calls throughout the year from residents inquiring about HHW items and their proper disposal. The City wants to bring greater awareness to all residents regarding the collection of HHW at the local WPWMA facility. In an effort to increase public awareness about HHW, the city plans to use an existing event to promote the proper disposal of HHW. Each year the city hosts an annual spring cleanup event on the weekend that garnishes old household items that would normally be taken to the landfill. Many residents attend this event because they can dispose of unwanted items like old mattresses and furniture they no longer need. At this event, the city plans to distribute a HHW flyer to each resident educating them on the identification of HHW items and their proper disposal. The City will also increase awareness about the local HHW program through other means of communications.

Project Summary: The City of Riverside Public Works Department- Solid Waste Division is responsible for solid waste collection and coordinating clean up events held in the City. The City of Riverside has approximately 316,000 residents. To ensure a clean environment the City developed a comprehensive collection event program, Clean-Up Riverside's Environment (C.U.R.E.), to address issues ranging from bulky item disposal to the proper disposal of specific household hazardous waste materials. The City hosts two events for residents to properly dispose of their expired batteries and compact fluorescent tubes (CFLs) at the Public Works Corporation yard. These collection events are coupled with e-waste collection, document destruction, and bulky item collection and were designed to glean hazardous materials from the waste stream. Events occur in February and October. Items accepted at the collection events include fluorescent tubes, compact fluorescent lights and household batteries. In 2015, the C.U.R.E events collected over 5000 lbs. of batteries and lamps. Other hazardous waste programs for City residents include the permanent Agua Mansa HHW Collection facility located in Riverside and operated by the County of Riverside. Additional HHW programs also include sharps collection at three City fire stations in addition to the Agua Mansa HHW Collection Facility. The C.U.R.E program and other HHW collection components are fully funded by the City of Riverside. The City is applying for the Household Hazardous Waste Grant Program 27th Cycle (HD 27) in order to further develop HHW public education, promotion, and outreach and utilize funding for the proper disposal of battery and CFLs collected at our C.U.R.E events. Public education/promotion and outreach would include electronic and printed utility bill inserts, signage for residential trucks promoting collection events, signage at C.U.R.E events, street banners promoting the C.U.R.E events and proper HHW disposal educational materials provided to residents at City sponsored events. The funding will also be utilized for a Hazwoper re-certification training for three existing employees that work the C.U.R.E events collecting HHW from the public.
